Topic or Issue	St. Cyril school has been identified by the TCDSB as a non-qualifying school for school bus transportation, given its current status as a single stream French Immersion school. As such, no longer is any student at our school now eligible for school bus transportation. The distance guidelines applicable to all other schools in the Board are not being applied equitably.
Details	<p>All students at St. Cyril currently receiving school bus services have been notified that their bus routes / stops have been cancelled as of September, 2016. We are requesting that services be reinstated in an equitable fashion, using the same TCDSB distance requirements and a similarly defined geographical catchment area as any other school in the Board.</p> <p>School bus services are vital for this local school community, to ensure the safety of all students travelling in an area of significant development, and dangerously high traffic. The local infrastructure of roads, sidewalks parking lots and crossing guard resources are significantly lacking and insufficient to support additional vehicular traffic near the school or ensure safe pedestrian access for our students.</p>
Action Requested	Reinstate school bus services for St. Cyril students based on a defined geographical catchment area, regardless of language of instruction.



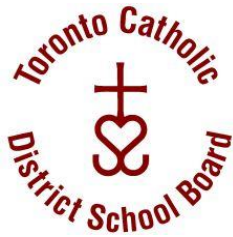

Details	<p>I am a current member of the CSPC of St Norbert's school, and my family is one that is also affected by this budget cut.</p> <p>I along with the St Norbert's community am extremely disappointed and concerned about the welfare of our children come September 2016. Both my husband and I work full time. As St. Norbert's school does not have a "before and after care program" we had to find a caregiver to watch our children before and after school. Our caregiver does not drive, but does have a bus stop right in front of her home. This was a perfect situation for my family as there was a bus to safely get my children to and from school along with someone to watch them for an hour before and after.</p> <p>Your decision has created a huge problem for us. My caregiver is elderly and unable to walk all 3 kids to and from school. Furthermore, I can't have my 6 yr old son walk across a busy street like Wilson Avenue without adult supervision.</p> <p>This is a safety concern for young children potentially travelling alone to and from school.</p> <p>There is also a concern of increased traffic congestion around the school which will again pose further risks to those children that are walking.</p>

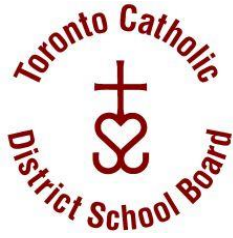

I would also add that on the Ministry of transportation website, McCowan and Kingston road is ranked as the <b>THIRD</b> most dangerous intersection in Toronto! Also, if you have been watching the news lately you will have seen that our neighbourhood has had 4 luring incidents in the past months. These near abductions are frightening and dangerous. Having more very young children on the roads increases the chance for these predators to lure them in successfully. Further, the traffic issues both in the St. Agatha parking lot and on the roads in front of and near the school have been chaos for years, they have been the place of arguments, fights, police involvement, warnings, etc. We must not make matters worse by removing these bus stops and therefore increasing the car congestion before and after school. We have also been asking around and have found that there are other schools within the TCDSB and the TDSB where children, even up to grades 6 and 8 are being bussed from distances less than 1km. So this makes us wonder why this discriminating decision was made for us and not some others. The elimination of these bus stops for our young and vulnerable children would be detrimental for our whole community in the many ways that I have outlined. Let's keep these stops and prevent a tragedy...</p>

For working parents, alternative arrangements will take more time to find other's to assist in the drop and pick-up process.</p>

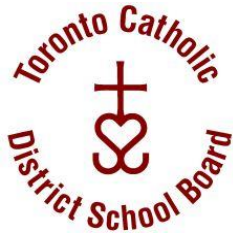

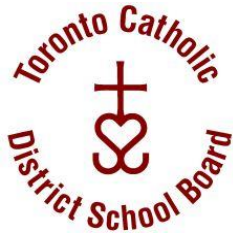

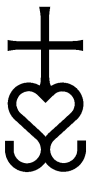

Dear Trustee,

We, the undersigned parents of children attending Immaculate Heart of Mary Catholic School at 101 Birchmount Road, Toronto, stand in protest to the Board's recent announcement that effective September 1, 2016, bus service will no longer be provided for students living closer than 1.5 km from the school.

Your administration is responsible for the budget problems currently faced by the Toronto Catholic District School Board and we working families should not be expected to sacrifice the bus transportation services that we rely on to get our children to and from school.

The question and answer information sheet provided with your letter dated June 13, 2016, notes that the average walk distance across the province is 1.6 km. We remind you that Toronto is a densely populated and thriving urban metropolis, which cannot be compared to other rural school districts in the province.

Families living in Toronto need the income of two working parents to be able to afford to live in this city. Cancelling bus service would significantly impact families, like ours, who cannot afford to take time off work to walk/drive our children to and from school.

Further complicating the situation is the lack of reliable public transit in our neighbourhood with wait times of up to 30 minutes for TTC buses in different directions to and from the school.

Therefore, we urge you to reconsider your position and make only reasonable changes to the services already provided. Otherwise, families like ours may be required to enroll in other public schools, further reducing funding for the Toronto Catholic District School Board.

Where school is an important part of their life, they feel abandoned especially in a catholic community where we are raised and taught to help and love one another.

Where they realize that others that live farther away have privileges that they do not. Feeling less special and unimportant.

Where they will be faced with emotional challenges to get to school where it once was considered as a normal part of going to school with a school bus, is no more.

To be overcome with stress while crossing the streets. Walking to school scared and distressed in hopes that they will arrive on time and safely and not get lost while using the TTC.

The horrible temperatures of the winter months where they will be forced to stay home because it's too cold to walk or they get sick and have to stay home resulting in missed classes and lack of learning.

The thoughts of a parent, that many have no choice because of the workplace, where they have to be at work and wonder if their child got to school okay. Horrible thoughts crossing their mind throughout the day and hopefully seeing their children when they get home from work at the end of the day.

I haven't slept since June 16th, filled with anxiety and stressing on how my children will get to and from school in the new school year. Rethinking over and over ways to change our schedule, or hire a transportation service, taxi or contemplating taking them to another school.

Why not reject these other children that live too far?

Why should they have special treatment and my children do not?

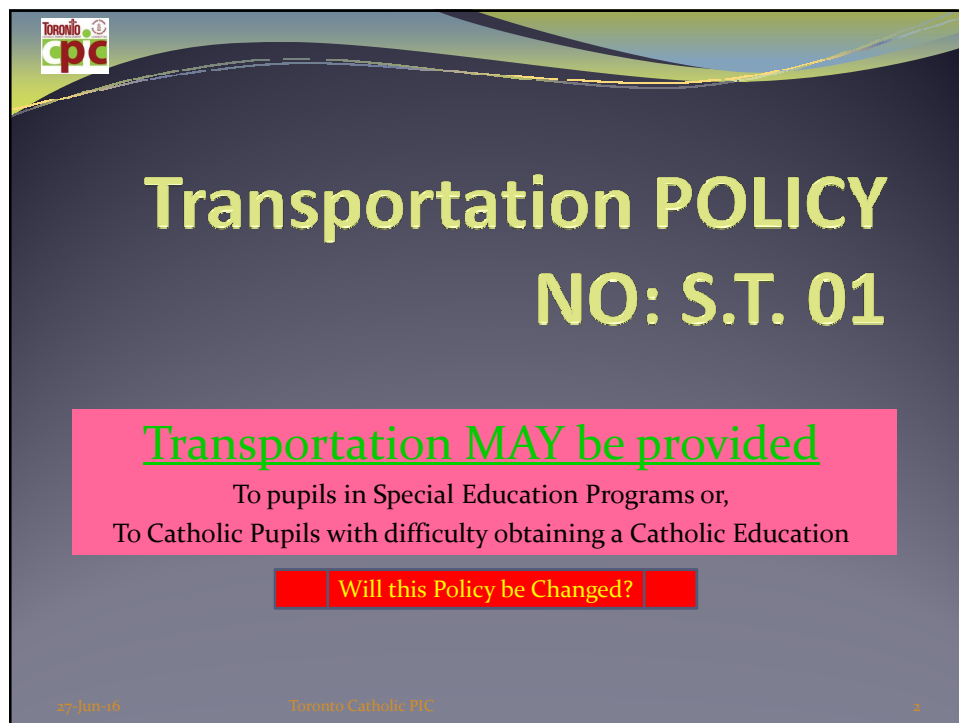
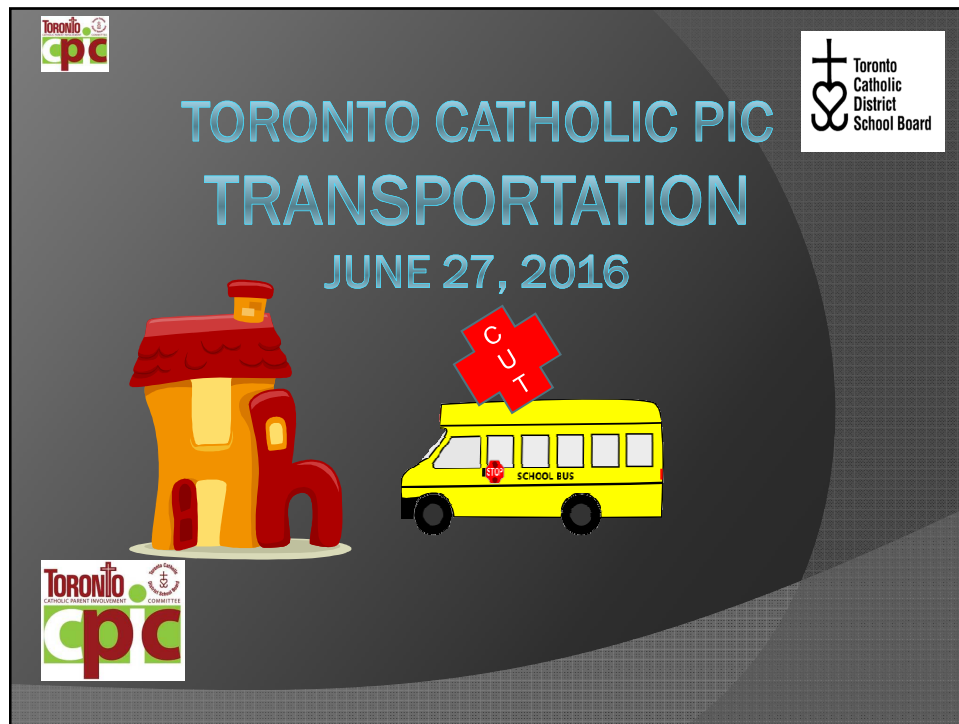
Why not have limitations on boundaries which are too far and drive the cost transportation up?

## TCDSB Transportation Policy Rules

A. Home to school transportation SHALL be provided to:


- 1) Exceptional elementary pupils with IPRC & requiring Specialized Programs out of home school;
- 2) Medical Practitioner Certified elementary pupils unable to walk temporarily or permanently;
- 3) Pupils where walking distance to the school is more than 1.5 km;
- 4) Pupils where **defined** safety hazards exist;
- 5) Principal determines Temporary Service needed for elementary student if hardship (as **defined** \*) exists;
- 6) Funded Gifted Student Programs who reside more than 1.5 km from school;
- 7) Funded French Immersion Students who reside more than 1.5 km from school;
- 8) Students whose Home School is over subscribed;

B. TTC Tickets (not highlighted)


C. Regular Kindergarten programs SHALL be provided with buses:


- 1) For pupils who reside more than 1.5 km from school; **or**,
- 2) If Principal determine (as **defined** \*) a need

\* no adequate parental supervision, personal hardship, family circumstances, or unusual hazard
