Good evening trustees, staff, and attendees. I am truly grateful to be able to express both my opinions and student voice tonight. Actions taken such as the LGBTQ+ advisory committee at the board level, the lgbtq+ student-led committee at CSLIT, and the resources found on the TCDSB website that are accessible to our student body. Trustees,

My child is 4 years old. She started JK this year. I'm sure you all remember JK as being a time when you sang songs, sat in a circle on a carpet on the floor, played games, water play, sand play and sharing -- all of this is GONE. We have taken it all from them.

There are now new rules such as:

- forward facing rules
- no talk rules
- inappropriate, fear inducing language from teachers about Covid
- fearmongering about children making family/grandma sick
- music classes with watching videos instead of using instruments like drums etc.
- excessive use of videos, TV to keep children quiet
- closing of school play structures
- no regular access to school gym/balls/equipment
- all extra curricular activities canceled, like basketball, chess clubs etc.
- excessive masking of children all ages. Including bus time up to 7 hours with no breaks

Since the last TCDSB meeting, The SickKids Hospital has updated their "Guidance for School Operation during the Pandemic" document. This document is the central pillar for the safe operation of schools in Ontario at this time. As I'm sure you are aware, The SickKids Hospital's Reopening Guidelines were the basis of the government's plans and policies since last summer. Please note that in this updated document, top doctors from Ontario's major healthcare centres explicitly state that they do not recommend kindergarten children be masked in schools.

Their guidance is now, "for elementary school students, there was a lack of consensus around a masking recommendation, but most agreed that in areas of moderate to high community transmission, NMMs should be recommended in this age group. There was agreement that masking should not be mandated in kindergarten." This recommendation be found in the section "Considerations for the Safe Continued Operation of Schools", subsection 5.

Please use this opportunity to update the TCDSB's initial masking mandate and remove the expectation for kindergarten students to wear masks in school. It should not be mandatory, but a choice. It is a liability for TCDSB to continue to have these measures in place.

The SickKids guidance document also states, "Children's and youth's social development hinges upon their interactions, facial expressions and body language. Though important for all age groups, this is particularly so for younger children."

The benefits of mask wearing do not outweigh the risks for children. Medical doctors and specialists have clearly outlined the deleterious consequences of long-term mask use by children, while the virus itself has shown near zero percent mortality rate in children. Forcing children to wear masks that are easily contaminated and misused is a blatant endangerment of their health. Education and psychology experts have raised valid concerns that the inability to see someone's face impedes confidence, social development, negatively impacts communication and hinders the ability to properly acquire language skills, particularly in young children

Other countries such as Austria, Netherlands, Norway, Sweden, Iceland and Switzerland all do not mandate mask wearing in schools.

Please consider the well-being of kindergarten children and the recommendations of Ontario's top doctors and remove the mask mandate for our youngest students. It is causing irreputable harm to these children.

Dear Trustees,

I would like to discuss the mandatory masking of school children particularly those at the kindergarten level AGAINST the advice of Canada's leading medical pediatric specialists.¹

TCDSB has always been seen as a leader in education, other school boards look up to TCDSB – why it's even in the motto; "Transforming the world through witness, faith, innovation and action".

Last August TCDSB made the decision to go above and beyond the call for the masking of children within the school environment. I appreciate that the board made the decision based on the limited information that was available to them at the time. However, I do have questions regarding that decision making process:

As educated professionals, I'm sure that you have reviewed and are able to provide an impact study of masking vs no masks on children prior to enforcing a mask mandate for school children as young as four years old?

As educated professionals I'm sure that you have completed and are able to provide a risk benefit analysis that has an accurate assessment of potential drawbacks of mandatory masks, including physical, psychological, developmental as well as defined outcome metrics / expectations (what you expected vs what actually happened)?

As educated professionals I'm sure that you are aware that informed consent is a necessary part of any medical intervention? And providing that information to parents is part of your duty as educators.

As educated professionals I'm sure that you are aware that if you don't have any of the above, then you could in fact be opening yourself up to negligence and liability through the medical experimentation of children?

It is now 6 months after the initial decision to mask children and we have a large volume of data when it comes to the impacts of this virus on children. If you do not have any of the points outlines above, now is the time to re-evaluate. There is an immense amount of data on the minimal impact mask mandates provide on transmission. There is also at hand information on the HARMS of masks particularly as it relates to children and especially young children such as those in Junior and Senior kindergarten.^{2,3,4} It is time to re-evaluate the decision to mandate masks for all children, particularly those at the kindergarten level.

We now know that the effects of masking children, far out weighs the benefit – this is no longer a debate. It is time for TCDSB to ask themselves if masking healthy kindergarten children is ethical and really how the school board would like to be remembered. It is time for TCDSB to be a leader and take action to remove the mandatory mask mandate for healthy children.

Hello TCDSB members, I am a concerned mother of two young children ages 3 and 7 that are being forced to wear masks for 6 and half hours a day, while trying to get a proper education in an emotionally healthy environment. We have finally reached a point now in the pandemic where we scientifical and factually know that, "young children don't get as sick from Covid 19 and don't pass it on as well as others". This is a direct quote from B.C's Provincial Health Officer Dr. Bonnie Henry. Data from around the world support her statement! Masks have not been studied for their safety in children and there is no data to support the masks in an educational environment are beneficial. There are however countless documented physical, mental and emotional harms associated with children wearing masks. You cannot claim to be concerned about health and safety of your students while failing to acknowledge that face masks are threatening to physical and social health and impede normal social interaction between student and peers / teachers. Is there any scientific data or proof that a face mask on my child all day will not in fact cause irreversible adverse side effects? Will children be more susceptible to the virus from touching their faces all day adjusting their masks? And should there be long term irreversible effects who will be made accountable?
