



WHEREAS: In 1992, the Government of Canada, designated October as Women's History Month marking the beginning of an annual month-long celebration of the outstanding achievements of women throughout Canada's History;

WHEREAS: On March 8, 2018, Trustee Rizzo put forward a motion for the Board to recognize International Women's Day and to create an award in honour Sr Evanne Hunter, IBVM. A Report was requested. The report was passed at the May 3, 2018 Student Achievement and Well-Being, Catholic Education and Human Resources Committee Meeting;

WHEREAS: Paolo De Buono delegated asking the Board to consider recognizing October as Women's History Month;

WHEREAS: Women's History Month includes International Day of the Girl on October 11 and Persons Day on October 18;

WHEREAS: International Day of the Girl is a United Nations observance day dedicated to girls' rights around the world;

WHEREAS: Persons Day marks a pivotal movement in Canadian History [1929] when the legal definition of "persons" was changed to include women; and

WHEREAS: Curriculum resources support each year's theme for Women's History Month and should be reflective of the diversity within the Toronto Catholic District School Board (TCDSB).

BE IT RESOLVED THAT: TCDSB hereby proclaim October as Women's History Month annually throughout the Board;

BE IT RESOLVED THAT: TCDSB hereby proclaim every October 11 as International Day of the Girl; and

BE IT RESOLVED THAT: TCDSB hereby proclaim every October 18 as Persons Day.

WHEREAS: St. Pius X Catholic School is holding a Christmas event on Saturday, December 4, 2021. The Catholic School Parent Council (CSPC) requests that the Board's liquor policy be waived for this event;

WHEREAS: Several parent volunteers are Smart Serve Certified, and they will be on hand to serve the attendees;

WHEREAS: The CSPC have sent letters of notification about the St. Pius Christmas Festival to the: Toronto Police, Fire Department, Toronto Public Health, and the City Clerk's office;

WHEREAS: This will be a time ticketed event and families will only be present for a 2-hour period; and

WHEREAS: All public health guidelines, at the time of the event, will be strictly adhered to.

Students of St. Vincent De Paul School (SVDP) who continue with their
Extended French Studies in High School, and to investigate if bus
transportation is possible for those students to attend the French
Extended Program at Michel Power/ St. Joseph High School that this
Item be considered at the December 9, 2021 Regular Board Meeting:

WHEREAS: Some Grade 8 students who have been taking Extended French for the last four years have been offered to pursue their studies at Michael Power/St. Joseph High School (MP/SJ);

WHEREAS: To attend Michael Power/St. Joseph High School, the students would need to travel over 34 km daily by TTC with multiple transfers to get to school on time:

WHEREAS: The traveling itself would create additional stress, anxiety and time constraints for students and consequently lead to lost of interest, in pursing Extended French studies on a secondary level;

WHEREAS: Studies on mental health show that the majority of youth reported worsening mental health during the COVID-19 pandemic;

WHEREAS: There is a serious shortage of French teachers across Ontario and the entire country, the TCDSB should nurture and encourage our existing students in French Programs to continue their studies and provide practical and realistic options for them; and

WHEREAS: Many of our graduates could become new French teachers in the future, the TCDSB needs to work efficiently to end the continuous interruption of French Programs due to the shortage of French teachers. BE IT RESOLVED THAT: The Staff investigate if a bus transportation can be provided for St. Vincent De Paul school Grade 8 students, who chose to attend Michael Power/St Joseph High School;

BE IT RESOLVED THAT: The TCDSB provide space to pursue Extended French Program at Marshal McLuhan, Notre Dame and St. Joseph College School for those students from St. Vincent De Paul who select to attend the above listed high schools, as of 2022-2023 school year and every year thereafter;

BE IT RESOLVED THAT: The entire SVDP school community is notified immediately about the options available to pursue Extended French Program through Marshall McLuhan, Notre Dame, St. Joseph College and Michael Power/St Joseph High schools, so that families can plan accordingly; and

BE IT RESOLVED THAT: The promotional materials for continuing studies in Extended French for St. Vincent De Paul students at Marshal McLuhan, Notre Dame, St. Joseph College and Michael Power/St. Joseph High schools are included in OPEN HOUSE Information Kit for 2023-2024 school year and every year thereafter.

**8d)** From Trustee Rizzo regarding TikTok and SnapChat Challenges that this Item be considered at the December 9, 2021 Regular Board Meeting:

WHEREAS: Some secondary students are issuing, participating and executing TikTok and SnapChat challenges;

WHEREAS: Challenges include Slap the Teacher, fake sexual assault; vandalism of toilet stalls, late for class; prank calls; loitering, etc;

WHEREAS: TCDSB high schools have been dealing with these TikTok and SnapChat challenges all year;

WHEREAS: Almost every week TikTok allows posts of school challenges that in some cases has prompted kids to do and act inappropriately;

WHEREAS: TCDSB administrators frequently spend great amounts of time to address many inappropriate posts such as sexual orientation/racist/sexist actions and behaviours by students in high schools on TikTok and SnapChat platforms;

WHEREAS: This is a particularly concerning trend impacting TCDSB secondary schools, Staff and administration;

WHEREAS: Tic Tok is allowing these challenges to be posted;

WHEREAS: These challenges encourage and advance inappropriate behaviour by students;

WHEREAS: Intervention is required as these challenges will continue and may get worse if action is not taken now;

WHEREAS: Community guidelines of diversity, safety, and inclusion are not adhered to by TikTok and SnapChat as it relates to the challenges and posts; and

WHEREAS: TikTok and SnapChat will remove any content – including video, audio, livestream, images, comments, and text that violates Community Guidelines if reported.

THEREFORE BE IT RESOLVED THAT: TCDSB request TikTok and SnapChat to remove school student challenges;

#### **Elementary Affairs**

The Directors of Elementary Affairs Audri and Mara successfully hosted their third ECSLIT virtual general assembly. The theme for December was Generosity. Audri

and Mara were thrilled to invite the amazing guest speaker, Tanika Riley, to speak about this theme and relate it to faith in action. In addition —as per their pillar action plans — the directors ensured to incorporate one of the seven grandfather teachings, cultural superhero highlights, and mental health toolbox. As always, the directors are thankful for the continuous support from the board and for making themselves available for opening and closing remarks. Mara and Audri are continuing to plan for future ECSLIT meetings, and hope to be able to host them live at the CEC at some point in 2022. Audri and Mara are also excited to launch a Christmas-themed social media project on the ECSLIT Instagram account prior to Christmas to get the students excited about the Christmas season, as well as increase interaction between the two directors and the students between meetings.

#### Social Affairs

Director of Social Affairs, Serenity Bui, was excited to announce the upcoming Christmas Social entitled *The Social Before Christmas* which is happening on December 20th. Adekunbi also played a leadership role in the Equity Career Fair that took place on Wednesday, November 24th, alongside the directors of Charity and Social Justice; Julissa P., Nicole B., and Rushan J. Guidance teacher Gina Vincent raved about how well our CSLIT Executive did and their leadership. Adekunbi, two Catholic Student Leadership coop students, and our teacher moderator Michael Consul also presented the *Equity Champions* professional learning session on November 17. At this meeting, they shared all the equity-related initiatives CSLIT has planned throughout the school year which included our 5 Pillars of Focus, four of which directly tie in with equity.

#### Faith

The Director of Faith, Roy Bou Abboud, prepared and facilitated opening and closing prayers for our monthly CSLIT and ECSLIT online meetings. Roy will host the final Let's Talk Faith webinar of 2021 on Wednesday, December 15th, 2021 with the help of the Faith Subcommittee. The Faith Subcommittee has been meeting on a weekly basis, planning the upcoming Let's Talk Faith webinar. The December 15th meeting will focus on the advent season and the meaning of Christmas. The Faith Subcommittee will also be volunteering at the Parkdale Community Foodbank on December 4th, with the goal of putting their faith into action during the Christmas season.

#### **Charity**

The Charity Subcommittee led by Nicole and Julissa is excited about spreading the Christmas spirit through charitable works throughout December. The new Charity subcommittee Instagram account is growing which is an amazing sign that students want to get involved in supporting great charities like the Angel Foundation, Sharelife, Development and Peace, and Meagan's Hug. **WHEREAS:** Some Grade 8 students who have been taking Extended French for the last four years have been offered to pursue their studies at Michael Power/St. Joseph High School (MP/SJ);

**WHEREAS:** Studies on mental health show that the majority of youth reported worsening mental health during the COVID-19 pandemic;

WHEREAS: There is a serious shortage of French teachers across Ontario and the entire country, the TCDSB should nurture and encourage our existing students in French Programs to continue their studies and provide practical and realistic options for them; and

**WHEREAS:** Many of our graduates could become new French teachers in the future, the TCDSB needs to work efficiently to end the continuous interruption of French Programs due to the shortage of French teachers.

**Subject: Consideration of Motion** - TikTok and SnapChat Challenges

**WHEREAS:** Some secondary students are issuing, participating and executing TikTok and SnapChat challenges;

**WHEREAS:** Challenges include Slap the Teacher, fake sexual assault; vandalism of toilet stalls, late for class; prank calls; loitering, etc;

**WHEREAS:** TCDSB high schools have been dealing with these TikTok and SnapChat challenges all year;

**WHEREAS:** Almost every week TikTok allows posts of school challenges that in some cases has prompted kids to do and act inappropriately;

**WHEREAS:** TCDSB administrators frequently spend great amounts of time to address many inappropriate posts such as sexual orientation/racist/sexist actions and behaviours by students in high schools on TikTok and SnapChat platforms;

**WHEREAS:** This is a particularly concerning trend impacting TCDSB secondary schools, staff and administration;

WHEREAS: Tic Tok is allowing these challenges to be posted;

**WHEREAS:** These challenges encourage and advance inappropriate behaviour by students;

**WHEREAS:** Intervention is required as these challenges will continue and may get worse if action is not taken now;

**WHEREAS:** Community guidelines of diversity, safety, and inclusion are not adhered to by TikTok and SnapChat as it relates to the challenges and posts; and

**WHEREAS:** TikTok and SnapChat will remove any content – including video, audio, livestream, images, comments, and text that violates Community Guidelines if reported.

**THEREFORE BE IT RESOLVED THAT:** TCDSB request TikTok and SnapChat to remove school student challenges;

**BE IT FURTHER RESOLVED THAT:** A report be prepared to investigate and address the actions that can be implemented to shut down these posts;

**BE IT FURTHER RESOLVED THAT:** Staff be requested to report on the ramifications of students participating inappropriately on social media posts; and

**BE IT FURTHER RESOLVED THAT:** Staff report on a plan that includes centrally monitoring these unfitting posts on TikTok and SnapChat.



#### A. EXECUTIVE SUMMARY

This report provides the Board of Trustees with a recommendation from the Special Education Advisory Committee.

#### **B.** PURPOSE

The purpose of this report is to provide the Board of Trustees with a recommendation from the Special Education Advisory Committee.

#### C. BACKGROUND

- 1. On November 17, 2021, the Special Education Advisory Committee met.
- 2. At that meeting, a recommendation to the Board of Trustees was proposed.

#### D. EVIDENCE

The Special Education Advisory Committee met on November 17, 2021 and a motion regarding Agenda Item 16a) Consideration of Motion from Melanie Battaglia, representative of Autism Ontario regarding Exclusion Tracking and Reporting was approved by a majority vote as per the Minutes of that meeting included under Communication on the Order Page.

#### E. STAFF RECOMMENDATION

The Special Education Advisory Committee recommend to the Board of Trustees that the following be approved:

**WHEREAS**: The mission of the Toronto Catholic District School Board (TCDSB) is to be an inclusive learning community uniting home, parish and school and rooted in the love of Christ;

WHEREAS: Autism Ontario, Association for Ontarians with Disabilities Act (AODA) association, Inclusion Action Ontario, Advocacy Resource Center

for the Handicapped (ARCH) disability Law and many other organizations and associations in Ontario supporting students with special education needs and/or disabilities ("special needs students") and their families have repeatedly raised concerns about the frequency of special needs students being excluded under section 265(1)(m) of the Education Act (a "formal exclusion") and/or what are frequently referred to as soft exclusions where student hours of attendance are restricted or are requested to stay home for a number of days at the Principal's request, including without limitation for off school premises field trips ("soft exclusions");

**WHEREAS**: The Ministry of Education's "Enrolment Register Instructions for Elementary and Secondary Schools" has since the 2018/19 school year required school Boards to maintain Exclusion records for "audit purposes" (pages 23 and 24), including the following information:

- Documentation that shows the reason for the exclusion;
- Documentation of successful notification of the exclusion and the response between the School Board and the pupil (if the pupil is an adult) or the pupil's parent or guardian;
- Documentation of the plan (signed by the principal) to re-integrate the pupil into the education system;
- Documentation of communication with other parties involved with reengaging the pupil (e.g. social agencies); and
- Data on the number of students who have been excluded during the school year (including the name of student, Ontario Education Number (OEN), length of exclusion, and reason for exclusion).

**WHEREAS**: SEAC recommended to the Board and the Board affirmed the request for a report that would include summary information of Exclusions on March 27, 2019 and to date no report has been presented to SEAC, over 2.5 years later ("reporting delay");

**WHEREAS**: The Ministry of Education has placed new limits on the suspension and expulsion of students in Grade 3 and below effective this

school year (2021/2022) and Exclusions may be used as a method to circumvent these Ministry limits on administrator authority; and

**WHEREAS**: It is clear from the extensive reporting delay that the TCDSB does not have the ability to systematically monitor Exclusions to ensure appropriate use, meet the Ministry's audit expectation as outlined in the "Enrolment Register Instructions for Elementary and Secondary Schools" document or collect data to compile any reliable reports surrounding the use of Exclusions for SEAC or the Board in a timely manner.

#### **BE IT RESOLVED THAT:**

- SEAC recommend to the Board that the attendance system be updated to track all Exclusions, including formal and soft exclusions;
- A formal exclusion is defined as under Section 265 (1) (m) of the Education Act.
- A Soft Exclusion is defined as a Principal's request to keep a child home for all or part of a day.
- SEAC further recommend to the Board that the Progressive Discipline Application be updated to keep records associated with both types of Exclusions as required for a Ministry audit and those records should also be kept in a Student's Ontario Student Record (OSR);
- SEAC further recommend to the Board that a Policy be created that will instruct staff on the appropriate use of Exclusions, record keeping and appeal provisions; and
- SEAC further recommend reporting of both types of Exclusions in the Annual Safe Schools report and it indicate the numbers of special needs students affected along with total students (Consideration of Motion from Melanie Battaglia, representative of Autism Ontario regarding Exclusion Tracking and Reporting).

**WHEREAS:** The mission of the Toronto Catholic District School board (TCDSB) is to be an Inclusive learning community uniting home, parish and school and rooted in the love of Christ;

WHEREAS: An "Inclusive" school board is one that focuses educating all students in regular classrooms and delivering necessary services and accommodations to special needs students in a regular classroom at their student's local school and in their local community. Those boards operate few or no special segregated classrooms (ISP classes);

**WHEREAS:** Pope Francis and Catholic Social Teachings strongly supports the establishment and operations of Catholic Schools following the "Inclusive" model:

- 'An inclusive education finds a place for all and does not select in an elitist way the beneficiaries of its efforts." Pope Francis
- "An education in the fullness of humanity should be the defining feature of Catholic schools" Pope Francis
- "Putting the entire person at the centre of education" Pope Francis
- "Orienting educational work towards the margins, social margins and existential margins through service, encounter and welcome." Pope Francis
- "Education is an inclusive movement. An inclusion that goes towards all the excluded: those for poverty, for vulnerability due to wars, famines and natural disasters, for social selectivity, for family and existential difficulties," – Pope Francis
- Vatican City, Feb 20, 2020 / 10:08 am (CNA)- Pope Francis called for an
  educational revolution Thursday, telling the Congregation for Catholic
  Education that more effort needs to be made to accelerate the inclusiveness of
  education.
- FRATELLI TUTTI Encyclical Letter Pope Francis writes: <sup>[98]</sup>I would like to mention some of those "hidden exiles" who are treated as foreign bodies in society. Many persons with disabilities "feel that they exist without belonging and without participating". Much still prevents them from being fully enfranchised. Our concern should be not only to care for them but to ensure their "active participation in the civil and ecclesial community. That is a demanding and even tiring process, yet one that will gradually contribute to the formation of consciences capable of acknowledging each individual as a unique and unrepeatable person". I think, too, of "the elderly who, also due to their disability, are sometimes considered a burden". Yet each of them is able to offer "a unique contribution to the common good through their remarkable life stories". Let me repeat: we need to have "the courage to give a voice to those who are discriminated against due to their disability, because sadly, in some countries even today, people find it hard to acknowledge them as persons of equal dignity".
- "Defense of the right to life implies the defense of all other rights that enable the individual with the disability to achieve the fullest measure of personal development of which he or she is capable. These include the right to equal opportunity in education, in employment, in housing, and in health care, as

well as the right to free access to public accommodations, facilities, and services." US Catholic Bishops Statement on Disability (2016);

**WHEREAS:** 30 years of extensive research supporting accommodating special needs student within regular classrooms has shown, with an Inclusive approach:

- The special needs student does the same or better academically in an Inclusive classroom
- Academically all students do better in Inclusive classrooms.
- Teachers become more effective educators by broadening they teaching skills which benefit all students in Inclusive settings.
- Students learn to interact socially and accept those who are not like them, those who are different.
- Special needs students learn to interact with their peers in a typical accommodated, class setting and this eases the transition into adult life, making them more productive members of society. An artificial segregated setting can never achieve this and discourage accommodation in accordance with the Ontario Human Rights Code.
- Monies can be diverted from expensive segregated programs, bussing and underutilized assets to training staff, hiring frontline staff supporting students in regular classrooms and hiring support staff;

**WHEREAS:** 19 of the 60 English language school boards (32%) in Ontario promote the use Inclusive classrooms and operate no or only a few ISP classes for a limited number of Identifications;

**WHEREAS:** 12 of the 29 English Language Catholic School Boards (41%) in Ontario promote the Inclusive classroom and operate no or only a few ISP classes for a limited number of Identifications;

**WHEREAS:** New Brunswick, which has similar student enrollment levels as TCDSB, prohibits by law the segregation of any student due to a disability. New Brunswick has been a global leader in Inclusive education for 35 years;

**WHEREAS:** Most school boards that promote Inclusive classrooms achieve similar or superior results on standardized testing when compared to geographically overlapping boards that segregate special needs students, some by significant

amounts. Renfrew Catholic DSB EQAO scores are 19% higher than Renfrew DSB. Hamilton-Wentworth Catholic DSB EQAO scores are 16% higher than Hamilton-Wentworth DSB. Of note Hamilton-Wentworth Catholic DSB has been operating without ISP classes as we know them for over 50 years;

WHEREAS: There is a presumption by TCDSB staff at all levels that the current ineffective and expensive parallel model of special education is best suited for a special needs student. This presumption is made without benefit of reviewing research or having experience in Inclusive school boards. Parents and advocates who request an Inclusive placement for a student are dismissed without serious consideration of the request and they are often subject to significant pressure from staff to consent to a segregated placement recommendation;

**WHEREAS:** There are few if any accommodations provided to students in ISP classes that could not be provided in a regular class if staff were trained and supported to provide those accommodations; and

WHEREAS: Promoting Inclusive Education is consistent with our Catholic values, modern pedagogy research and practices, is consistent the Canadian Charter of Rights and Freedoms, The Ontario Human Rights Code, the laws and court rulings of Canada and Ontario. It is more cost effective than a segregated approach and helps all students reach their potential.

**THEREFORE BE IT RESOLVED:** That a senior Academic and Special Education staff (the Senior Team) look into how to promote Inclusive placements for special needs students that are currently or likely to be placed in Intensive Support Program (ISP) and bring back a report to Board and SEAC by January 2022 meetings; and

**BE IT RESOLVED:** That SEAC recommend to the Board of Trustees that the following be considered by the Senior Team for inclusion in the 2021-2024 Multi Year Strategic plan (MYSP):

• provide a modern definition of Inclusion in an education setting that will be posted prominently on the board's website, on related documents and shared with staff.

- Consult with experts in Inclusive Education, Inclusive school boards, SEAC, review research and review available plans for transitioning a board to an Inclusive model.
- Develop a general strategy for preparing staff, departments and the board to support a transition to an Inclusive model.
- Identify and prioritize policies and procedure documents than need to be updated to reflect a change to an Inclusive model of education, including the Special Education Plan.
- Identify groups of students and/or schools that will be transitioned to the Inclusive model each year, the staff groups that will educate and support them and the training they will need.

**WHEREAS:** Students who are Deaf or Hard of Hearing or lack communication ability will benefit and become more intently involved when being instructed etc. by Multiple Exceptionalities (ME) Staff who communicate through facial expressions and mouth movement; and

**WHEREAS:** TCDSB should accommodate all students by using all supports needed to communicate and instruct students.

THEREFORE BE IT RESOLVED: That SEAC recommend to the Board that the responsible staff member research the fully transparent, anti-fog masks available to help healthcare providers and essential workers to protect themselves, communicate better, and ease confusion manufactured by ClearMask and make them available to all school staff who wish to use this clear mask shield to fully communicate, instruct, etc. with students who rely upon the full facial expressions that includes lip movement to enable them to provide full and inclusive education.



# The Most Important Letter in SEAC is the "C"

- SEAC is a Committee structured to provide many perspectives
- ▶ It is composed of *subject experts* with the role of speaking for a community of interests (which don't always mean the same things to everyone)
- Can only act via decisions of the whole group
- ▶ Is strictly limited by statute to a single power...

## ...Recommendation

SEAC HAS NO OTHER POWER, AND NO OTHER PURPOSE

### It isn't a recommendation unless...

- ▶ It is a motion duly passed by SEAC at a meeting (and using the rules of the Committee).
- ▶ It falls within the mandate of SEAC
- It is appropriate to be considered by the Board of Trustees

# SEAC Recommends, Board Decides

- ▶ Board can refer a SEAC (or CPIC) recommendation to staff (for additional study or consultation) or can take up the recommendation.
- Board can receive a SEAC recommendation and take no further action. "Thanks for letting us know."
- ▶ Board may refer a question back to SEAC or to other bodies within the TCDSB.

### Important Considerations

- Members by themselves have no powers
- SEAC does not directly control anything; no staff, no parent councils, no policies, nothing; except your own deliberations
- You are representatives of organizations, not necessarily free agents
- The Act gives you access (to the Director of Education or his designate, to the Trustee members of SEAC, and to information from staff.
- You are influential because of your expertise, and your access

### The Problem with Subject Experts

- Not experts on everything
- ▶ Tend to follow their own passions
- ▶ Tend to prioritize time/effort around their own specialization
- May "talk past" other experts with different knowledge

### Good Advice

- Use formal rules to make decisions, not to distract from your role
- ► Look for shared issues where you can make recommendations which will serve many of the students under the Special Education umbrella
- Bring your expertise/do your homework
- Remember your mandate

### Special Education Superintendent Update October 2021

### **OCTOBER IS AUTISM AWARENESS MONTH**

In Canada, October is Autism Awareness Month. Autism Spectrum Disorder (ASD) is a neurodevelopmental disorder that includes impairments in language, communication skills, and social interactions combined with restricted and repetitive behaviours, interests, or activities.<sup>1</sup> Today prevalence rates of ASD in Canada are approximately 1 in 66.<sup>2</sup>

An increase in the number of students with Autism has been observed in the Toronto Catholic District School Board. Currently there are over 2,000 students with Autism in our schools.

The TCDSB offers a range of programs, services, and resources to support students, staff and families.

Autism Support Team: Multi-disciplinary staff on the Autism Team are available on a referral basis to help support schools and students in building capacity around best practices focusing on ABA strategies.

Connections For Students: Connections For Students is an Ontario government initiative, intended to facilitate the transition of children with Autism Spectrum Disorders from Autism Intervention Programs (AIPs) to school. This initiative partners school boards with AIP providers.

The Program to Assist Social Thinking (PAST): PAST is an elementary school program for students diagnosed with Autism level 1.

**Resources:** Information about resources available through the Autism Department and allied community organizations are available on our <u>Resources</u> page. Resources and materials for board staff can be accessed through the board's intranet <u>TCDSB Autism Services Team Site</u> (staff login required).




The Mental Health Team promoted mental health activities and resources throughout the system by:




### CELEBRATING CATHOLIC EDUCATION WEEK




### WALKING WITH CHRIST PASTORAL PLAN LAUNCH

I look forward to continuing on our journey together, providing the best outcomes for our students and realizing a fruitful and prosperous future for the Toronto Catholic District School Board.


## Maintaining Student Well-Being and Public Confidence

# NAVIGATING THE COVID-19 PANDEMIC

In a year unlike any other, TCDSB maintained a focus on the importance of the health and safety of everyone. Following the guidance of public health officials, we pivoted from inperson to remote learning and collaborated to create meaningful connections and learning in a virtual space.

The pandemic saw many of us spending more time indoors and less time with close friends and relatives. This new way of living was difficult for many and caused a focus on supporting student and staff mental health and well-being. Guided by our Mental Health and Social Work departments, we could share valuable health and wellness resources for students, staff and families throughout the year.

To support public health and government partners, we opened our doors and promoted our schools as COVID-19 Pop-up Vaccination Clinics for surrounding communities. Education and awareness around COVID-19 is ongoing, and we continue to work with our public health partners and the Ministry of Education to support the rollout of vaccinations.

#### PUBLIC ENGAGEMENT

Maintaining public accountability is extremely important. The pandemic meant we needed to pivot to find unique opportunities to engage the public like the launch of monthly Director Live Q & A sessions. Stakeholders were encouraged to ask questions about issues that matter to them, such as health and safety, school renewal, learning models, equity, etc.

Families were invited to participate in learning model surveys that better equipped us to identify and monitor disparities within our school system and provided insight into the student and parent/guardian experience of remote learning and in-person learning.

Despite the challenges brought on by the pandemic, I am pleased to share that we maintained our focus on capital priorities and continued to consult impacted school communities, i.e., Dante Alighieri Academy, Bishop Allen Academy, Loretto Abbey and Buttonwood.

With the culmination of our current Multi-Year Strategic Plan, we initiated the consultation and development process to inform our new plan. The consultation and development process will continue throughout 2021, and we look forward to involving key stakeholders in reviewing the data to inform our new plan.

#### FISCAL RESPONSIBILITY

The 2020 Budget Consultation was held virtually and input from all TCDSB stakeholders was provided. At the Special Board meeting held on July 23, 2020, the Board of Trustees approved a 2020-21 Operating Budget in compliance with the Education Act. Guided by the Board's Multi-Year Strategic Plan, the TCDSB budget continues our commitment to achieve effective, efficient and equitable programs and services while better meeting the needs of all students.

In light of the COVID-19 pandemic, we focused on the safety and well-being of our schools and communities, as well as system stability without compromising long-term financial sustainability. Investments were made in additional staffing, enhanced cleaning, mental health supports, remote learning, technology, facilities and transportation. The use of Board reserves supported the additional costs and absorbed the overall financial impact.

The TCDSB remains focused on student achievement and well-being, stewardship of resources and excellence in governance.

Board Expenditures exceed operating grants provided by the ministry and as a result TCDSB has a deficit of \$42M. This is mainly due to additional costs to maintain smaller class sizes due to COVID -19. This deficit will be funded by the Board's operating contingency reserve.

# Equitable and Diverse Learning and Working Environments

As the Director of Education, I recognize my role and leadership as being paramount to addressing systemic barriers, ensuring equity and leading from an anti-racist, anti-oppression perspective. This work begins with understanding who our students and staff are, and their lived experiences within our system - who we are serving effectively and who we are not.

This year we saw the launch of our Workforce and Grade 9 Student Census. These annual identity-based data collections will better equip us to identify and monitor disparities within our school system. The data will inform our decision-making, with the goal of influencing outcomes for students and staff and will help us better understand how our staff and students are represented and served by our Board.

We continue to learn from our community and advisory groups who influence our work, while also allowing us to connect with and better understand the needs of our students, families and staff. With their valuable insight, we continue to inform our strategies for addressing inequities and dismantling barriers in our system.

#### CULTURALLY RESPONSIVE AND RELEVANT PEDAGOGY


Through our continued work in realizing our Equity Action Plan, we renew our promise to ensure equity at all levels of our system as we strive to close the achievement gap, enhance students' physical, mental, and spiritual well-being, and ensure equity of opportunity and outcomes for all. In collaboration with the TCDSB African Canadian, Indigenous Education, Latin-Hispanic, Portuguese-Speaking, Spanish-Speaking, Filipino and Ukrainian Community Advisory Committees, and organizations like the Ripple Effect, we demonstrate our commitment to understanding how

our system perpetuates outcomes that disproportionally impact students, and how to disrupt in ways that change outcomes.

As part of our efforts towards removing barriers and achieving reconciliation, staff professional learning opportunities, data collection and incorporating culturally relevant and responsive texts and teachings enables us to address and dismantle barriers from our places of work and learning. The inaugural Connections and Conversations Series focused on themes that reflect the importance of equity and diversity in our local and global communities, and Remembrance Day through an Afrocentric Lens provided an opportunity to reflect on the contributions of Canadians whose sacrifices may have been overlooked. These opportunities allowed us to focus on ways in which we can better equip ourselves with the skills and knowledge to support students and peers from an anti-racist and anti-biased lens.

This year also saw the Ministry of Education move to destream math, and our Board of Trustees declared June as Pride Month, recognizing that change can happen as we continue to stand in solidarity with students, staff and allies.

# 16a) Consideration of Motion from Melanie Battaglia, representative of Autism Ontario regarding Exclusion Tracking and Reporting:

**WHEREAS**: The mission of the Toronto Catholic District School Board is to be an inclusive learning community uniting home, parish and school and rooted in the love of Christ;

WHEREAS: Autism Ontario, Association for Ontarians with Disabilities Act (AODA) association, Inclusion Action Ontario, Advocacy Resource Center for the Handicapped (ARCH) disability Law and many other organizations and associations in Ontario supporting students with special education needs and/or disabilities ("special needs students") and their families have repeatedly raised concerns about the frequency of special needs students being excluded under section 265(1)(m) of the Education Act (a "formal exclusion") and/or what are

frequently referred to as soft exclusions where student hours of attendance are restricted or are requested to stay home for a number of days at the Principal's request, including without limitation for off school premises field trips ("soft exclusions");

**WHEREAS**: The Ministry of Education's "Enrolment Register Instructions for Elementary and Secondary Schools" has since the 2018/19 school year required school boards to maintain Exclusion records for "audit purposes" (pages 23 and 24), including the following information:

- Documentation that shows the reason for the exclusion;
- Documentation of successful notification of the exclusion and the response between the School Board and the pupil (if the pupil is an adult) or the pupil's parent or guardian;
- Documentation of the plan (signed by the principal) to re-integrate the pupil into the Education system;
- Documentation of communication with other parties involved with reengaging the pupil (e.g. social agencies); and
- Data on the number of students who have been excluded during the school year (including the name of student, Ontario Education Number (OEN), length of exclusion, and reason for exclusion).

**WHEREAS**: SEAC recommended to the Board and the Board affirmed the request for a report that would include summary information of Exclusions on March 27, 2019 and to date no report has been presented to SEAC, over 2.5 years later ("reporting delay");

**WHEREAS**: The Ministry of Education has placed new limits on the suspension and expulsion of students in grade 3 and below effective this school year (2021/2022) and Exclusions may be used as a method to circumvent these Ministry limits on administrator authority; and

WHEREAS: It is clear from the extensive reporting delay that the TCDSB does not have the ability to systematically monitor Exclusions to ensure appropriate use, meet the Ministry's audit expectation as outlined in the "Enrolment Register Instructions for Elementary and Secondary Schools" document or collect data to compile any reliable reports surrounding the use of Exclusions for SEAC or the board in a timely manner.

#### **BE IT RESOLVED THAT:**

- SEAC recommend to the Board that the attendance system be updated to track all Exclusions, including formal and soft exclusions;
  - A formal exclusion is defined as under Section 265 (1)(m) of the Education Act.
  - A Soft exclusion is defined as a Principal's request to keep a child home for all or part of a day.
- SEAC further recommend to the Board that the Progressive Discipline Application be updated to keep records associated with both types of Exclusions as required for a Ministry audit and those records should also be kept in a Student's Ontario Student Record (OSR);
- SEAC further recommend to the Board that a Policy be created that will instruct staff on the appropriate use of Exclusions, record keeping and appeal provisions; and
- SEAC further recommend reporting of both types of Exclusions in the Annual Safe Schools report and it indicate the numbers of special needs students affected along with total students.






The Mental Health Team promoted mental health activities and resources throughout the system with the following activities:

- The Mental Health Professionals provided mental health resources to support the well-being of Newcomer students,
- Developed a presentation on Hope for Safe Schools Student Symposium. The presentation will be asynchronous for secondary students but deliveredsynchronously for elementary students.
- Distributed a message of Staff Well-Being with a focus on Self-Compassion for the month of November with mental health resources for both staff as well as classroom educators.
- Provided Staff Well-Being Professional Development for 70 Assessment and Programming Teachers as well as the Autism Staff members on Fostering our Own Resiliency During Uncertain Times.
- Provided Staff Well-Being Professional Development for 80 New Teachers.
- In collaboration with School Mental Health Ontario and York Region District School Board, we will present at the Annual Ontario Psychological Association Conference on **Supporting Student Mental Health in Schools During Uncertain Times.**

Psychology staff participated in the Dorothy Hill Symposium presented by the Ontario Psychological Association. This year's presentation was on *Social Justice and Anti-Oppressive Work in School Focused Psychological Services* by Dr. A. Jordan Wright from New York University. The presentation identified the



academic and social emotional impacts of inequities in education, and some initial steps needed to address these concerns within school psychology practice, and within school systems.

Psychology staff taking part in a Literacy Research Working Group resumed regular meetings this month. The goal of this working group is to review and summarize relevant research on the development of reading ability, and on reading assessment and intervention. The working group will be in-servicing psychology staff, and offering support for classroom literacy interventions this school year.

The Psychology Department continues to serve students, families and the school community. This includes in-person psychoeducational assessments, counselling and mental health supports, school team consultation, and psychology education for school staff and community.
