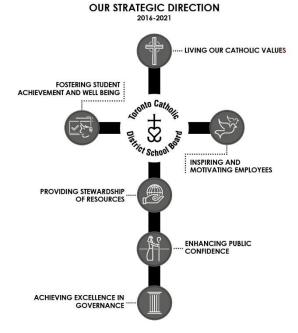

13c) From Trustee Rizzo regarding TikTok, SnapChat and other Online Challenge Trends:

WHEREAS: Some secondary students are issuing, participating and executing TikTok, SnapChat and other online challenges;

WHEREAS: Social media challenges encourage students to vandalize schools and participate in hoaxes is wreaking havoc at high schools across Canada and the US;

WHEREAS: Heightened attention to this trend has resulted in challenges spreading on social media;

WHEREAS: Challenges include Slap the Teacher, fake sexual assault; vandalism of toilet stalls, late for class; prank calls; loitering, etc;

WHEREAS: TCDSB high schools have been dealing with these TikTok, SnapChat and other online challenges periodically throughout the year;

WHEREAS: Almost every week online posts are allowed of school challenges that in some cases have prompted kids to do and act inappropriately;

WHEREAS: TCDSB administrators spend time to address many inappropriate sexual orientation/racist/sexist actions and behaviours by secondary students on TikTok, SnapChat and other online platforms;

WHEREAS: This is a particularly concerning and disturbing trend impacting TCDSB secondary schools, staff and administration and needs to be nipped in the bud;

WHEREAS: Tic Tok, SnapChat and other online platforms are allowing these challenges to be posted;

WHEREAS: These online challenges encourage and advance inappropriate behaviour by students and jeopardize the safety of students and staff;

WHEREAS: Intervention is required as these challenges continue and get worse if action is not taken now;

Director's Monthly Report

January 2022

Since the last board meeting, we have celebrated the birth of our Lord over the Christmas season, and spent time with family, albeit in reduced capacities congruent with our on-going public health realities. We are hopeful that despite the impositions on our regular gatherings over the holidays, that it provided the opportunity to be present with those closest to us, with an optimistic look toward the future.

The rapid rise in the Omicron variant resulted in yet another "pivot" into remote learning for staff and students. We recognize that information moved quickly and decisions around the extension of the Christmas break turned into extended remote learning at the beginning of the month. These realities challenged our resiliency and impacted our social, emotional, academic, and mental-health and wellness. We are tremendously grateful to all staff for their service, sacrifice, and support for students and families during this difficult time, and to our parents and community members for their support and partnership.

Looking forward to a return to in-person learning, we have been focused on continuing to create the safest spaces possible for our students and staff. We have made tremendous investments in ventilation upgrades since the summer and continue to ensure that staff and students have access to appropriate masks and access to rapid antigen tests. Our partnership with Public Health has resulted in hosting numerous vaccination clinics throughout our board to increase access and remove barriers for students, staff, and families. Though the provincial direction has moved from Public Health contact tracing and public reporting, the TCSDB has committed to providing parents information as it disclosed to them regarding COVID-19 in our schools, and we continue to post such information we receive publicly. Daily absences are being reported provincially and can be accessed daily in the spirit of transparency for our communities.

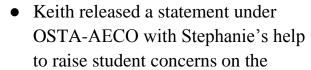
As we dig ourselves out from one of the largest snowfalls in recent memory which impacted all schools and communities, we remain optimistic about returning to pre-pandemic realities, recognizing the importance of being able to gather in communities of faith. We are grateful for the ways our parents and caregivers continue to support our shared commitments as we recognize the impact and importance of partnership on our schools and communities.

Highlights from January include:

• Celebrating Courage as the Virtue of the Month and recognizing important observances such as: Tamil Heritage Month, New Year's Day, Solemnity of Mary the Holy Mother, World Peace Day, Epiphany, Eastern Rite Christmas, Baptism of the Lord, Eastern Rite New Year, Dr. Martin Luther King Jr Day, International Day of Education, Bell Let's Talk Day, Family Literacy Day, and International Holocaust Remembrance Day. Kindergarten Registration also begins this month.

- Engaging with media on behalf of the TCSDB and education in Ontario on CBC Metro Morning, CBC Ontario Today, CTV, CP24, The Star, and the Globe and Mail. We continue to embrace opportunities to positively position TCSDB and the important work happening throughout the system
- Connecting with our TCDSB Community through our monthly "Lunch with the Director" series live streamed on Facebook and YouTube where we discussed questions focused on mental health, pandemic responses, and even the snow day from the TCDSB community on Friday, January 21st
- Contributing to on-going provincial conversations regarding **Streamlining the Board Improvement and Equity Plan (BIEP)** with the Ministry and a group of Director's from across Ontario. The BIEP sets out province-wide goals and performance indicators under four educational priority areas, 1) Achievement; 2) Human Rights and Equity; 3) Mental Health, Well-Being, and Engagement; and 4) Transitions and Pathways
- Along with Trustees, participating in the OCSTA 2022 Virtual Catholic Trustee Conference
- Delivering opening remarks at the **Pastoral Day of Care** along with Principals, Chaplains, and school TSU representatives with this year's focus on Technology Use and Mental Health
- Along with the Chair attending the **Annual Meeting of the Chairs and Directors of Education** of the Catholic School Boards within the **Archdiocese of Toronto with Cardinal Collins**
- Connecting with and encouraging leadership candidates who are discerning school leadership at the CPCO Principal's Qualification Program Part 2 session
- Participating in the upcoming virtual **CODE Annual Business Meeting** and keynote speakers between January 26 and January 28
- Participating in monthly **Ripple Effect Circle** Meetings Ripple Effect Circle an action-oriented alliance of individuals of influence across multiple sectors (private, public, non-profit) in Canada created to take action and work towards combatting systemic racism in Black communities
- On-going engagement with Toronto Public Health with vaccination and booster strategies in Toronto, and public health recommendations from TPH that impact and influence TCDSB staff and students
- Continuing important connections throughout the pandemic with the Deputy Minister of Education, Toronto Public Health, and the Ministry of Health in support of provincial and local initiatives to keep students, staff, and families safe and healthy during this current COVID-19 pandemic
- Participating on and contributing to provincial leadership conversations with Directors of
 Education and Health Officials from across the province in support of TCSDB staff, students,
 and families, and to influence public policy decisions in support of education and health care

January Student Trustee Board Report Update from the Student Trustees:





- Ministry's return to school plan. We emphasized the need for further student consultations, the continuation of reporting covid-cases, and providing adequate PPE for students.
- Keith and Stephanie were interviewed by CTV News, Toronto Star and CHCH News regarding the return to in-person learning and hear our honest opinions on it.
- Keith hosted the second meeting of the 2SLGBTQ+ Student Advisory Committee. At this meeting, we continued planning this year's initiatives and ideas.
- Keith and Stephanie met with CSLIT Moderator Mr. Consul, Superintendent Caccamo, Superintendent DiMarco and Superintendent Fernandes to discuss the idea of potentially cancelling exams. After some insightful discussion, we proposed that if a student's exam mark were to negatively affect their overall grade, it should not be counted due to the additional mental health stress during this time due to the pandemic and Omicron variant.
- Keith joined a panel session called "If I had 1.08 billion dollars", funded by Wilfred Laurier University and moderated by *People for Education*. He joined other leaders in education and Ontario educational stakeholders to discuss the challenges of learning recovery and solutions we can implement.
- Keith joined a panel session at the *Cannexus Conference*, Canada's largest conference focused on career and workforce employment. The session Keith joined focused on "A Future of Public Education Driven by Youth".
- Keith and Stephanie held individual meetings with secondary school student councils from across the board with the goal of discussing CSLIT initiatives, menstrual products in schools, the anonymous alerts app, and any concerns their student body had in regards to the return to in-person learning.
- Keith and Stephanie had a virtual OSTA-AECO executive meeting to discuss ongoing initiatives including the publication of a new document that

- builds a platform that ensures students' voice is heard in the upcoming provincial election and planning for the next OSTA-AECO conference.
- Stephanie was interviewed for a research and journalism podcast to discuss the positive impacts recognizing pride month had on students and school communities.

CSLIT Executive Council

Elementary Affairs

For the month of December, the Directors of Elementary Affairs hosted their Christmas-themed General Assembly where the topic of generosity was discussed. During this meeting, Audri and Mara encouraged the elementary leaders to send in any socks, gloves, and winter hats to the CEC to donate to the homeless. The response was awesome and the items will be donated to the Good Shepherd Refuge in January. Mara and Audri also hosted their January General Assembly where their guest speaker, Juan Bendana focused on the Indigenous Grandfather teaching of "Truth." Audri and Mara are continuing to prepare for the upcoming iLITE conference scheduled on January 27th. As always, the directors thank Mr. Caccamo and the board for their continuous support in ECSLIT events.

Social Affairs

After a well-deserved break, the Social Affairs subcommittee is ready to get back into action. For the month of January, the subcommittee got together and split into different groups in order to discuss specific events planned for 2022. The next event will be themed around Valentine's Day. One initiative is creating *letters of love* to be sent out to hospital patients. Students will be able to purchase and personalize these anonymous Valentine's cards. The Social Affairs subcommittee wants to remind students about balance and how taking breaks and having fun leads to better mental health.

Social Justice

The Social Justice Subcommittee is in the final planning phases of their recycling for social justice initative. This idea involves collecting batteries and scrap metal from schools and students in a safe and logistically convenient way to raise money for community causes. More details to come about this unique initiative. In addition, the Social Justice subcommittee wants to host different events in 2022 including something on February 20 which is the World Day of Social Justice. In addition, the committee is brainstorming ideas related to learning and celebrating Indigenous culture and language (which is part of our Indigenous education pillar of focus). Details about these events will be released when finalized and reviewed by staff.

Equity

The Director of Equity, Adekunbi Luwaji is working alongside her subcommittee to commence the integration of CVMA—Catholic Visible Minority Alliance. This student group amalgamates last year's *Catholic Youth Black Alliance* and *Asian Core Team*. This group is brainstorming some Black History Month initiatives for February.

<u>Faith</u>

The Director of Faith, Roy Bou Abboud, prepared opening and closing prayers for our monthly CSLIT and ECSLIT online meetings. Roy will host the first Let's Talk Faith webinar of the year on Wednesday, February 16th, 2022 with the help of the Faith Subcommittee. The Faith Subcommittee has been meeting on a weekly basis, planning the upcoming Let's Talk Faith webinar as well as premliminary planning for our annual Faith Camp. Roy also attended the monthly 2SLGBTQ+ Student Advisory Committee meeting on Friday, January 14th, 2022. Roy is one of the leads on our 2SLGBTQ+ Inclusion and Acceptance pillar of focus.

Charity

To raise engagement on our social media, our Directors of Charity Julisa and Nicole, have been posting Advent reflections every Sunday. Advent posts were created for every week of December with various prompts connected to our faith. Before the break, we also had the amazing opportunity to fundraise for the charity Meagan's Hug which supports kids with brain cancer. Through the selling of gingerbread houses, our charity subcommittee was able to raise close to \$800. Julisa and Nicole are also part of our Equity Pillar and have been working closely with our Director of Equity, Adekunbi planning events for Black History Month.

Public Relations

The month of December and the weeks leading up to the return from the Holiday has been busy for the Public Relations Team. With the guidance from Student Trustees, and Mr. Consul, The Public Relations Team has worked hard to put out the most up-to-date posts and constantly update students on developments regarding school. Furthermore, with the final stretch of the semester looming, The Public Relations Team has increased attention towards swiftly responding to students who reach out to CSLIT via Instagram. On a good note, CSLIT's social media presence has been growing at a rate higher than previous months, with a net increase of 400 followers. With this new audience, we expect an uptick in participation in CSLIT and Catholic Student Leadership events.

In the month of January, Junette Tindan has been working alongside the student trustees and the executive directors in support of the future plans for the school year. Junette has been working on plans within the Indigenous Education pillar as well as helping organize iLITE happening on Jan. 27th. 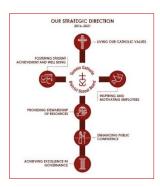

WHEREAS: The mission of the Toronto Catholic District School Board is to be an inclusive learning community uniting home, parish and school and rooted in the love of Christ;

WHEREAS: Autism Ontario, Association for Ontarians with Disabilities Act (AODA) association, Inclusion Action Ontario, Advocacy Resource Center for the Handicapped (ARCH) disability Law and many other organizations and associations in Ontario supporting students with special education needs and/or disabilities ("special needs students") and their families have repeatedly raised concerns about the frequency of special needs students being excluded under section 265(1)(m) of the Education Act (a "formal exclusion") and/or what are

frequently referred to as soft exclusions where student hours of attendance are restricted or are requested to stay home for a number of days at the Principal's request, including without limitation for off school premises field trips ("soft exclusions");

WHEREAS: The Ministry of Education's "Enrolment Register Instructions for Elementary and Secondary Schools" has since the 2018/19 school year required school boards to maintain Exclusion records for "audit purposes" (pages 23 and 24), including the following information:

- Documentation that shows the reason for the exclusion;
- Documentation of successful notification of the exclusion and the response between the School Board and the pupil (if the pupil is an adult) or the pupil's parent or guardian;
- Documentation of the plan (signed by the principal) to re-integrate the pupil into the Education system;
- Documentation of communication with other parties involved with reengaging the pupil (e.g. social agencies); and
- Data on the number of students who have been excluded during the school year (including the name of student, Ontario Education Number (OEN), length of exclusion, and reason for exclusion).

WHEREAS: SEAC recommended to the Board and the Board affirmed the request for a report that would include summary information of Exclusions on March 27, 2019 and to date no report has been presented to SEAC, over 2.5 years later ("reporting delay");

WHEREAS: The Ministry of Education has placed new limits on the suspension and expulsion of students in grade 3 and below effective this school year (2021/2022) and Exclusions may be used as a method to circumvent these Ministry limits on administrator authority; and

WHEREAS: It is clear from the extensive reporting delay that the TCDSB does not have the ability to systematically monitor Exclusions to ensure appropriate use, meet the Ministry's audit expectation as outlined in the "Enrolment Register Instructions for Elementary and Secondary Schools" document or collect data to compile any reliable reports surrounding the use of Exclusions for SEAC or the board in a timely manner.

BE IT RESOLVED THAT:

- SEAC recommend to the Board that the attendance system be updated to track all Exclusions, including formal and soft exclusions;
 - A formal exclusion is defined as under Section 265 (1)(m) of the Education Act.
 - A Soft exclusion is defined as a Principal's request to keep a child home for all or part of a day.
- SEAC further recommend to the Board that the Progressive Discipline Application be updated to keep records associated with both types of Exclusions as required for a Ministry audit and those records should also be kept in a Student's Ontario Student Record (OSR);
- SEAC further recommend to the Board that a Policy be created that will instruct staff on the appropriate use of Exclusions, record keeping and appeal provisions; and
- SEAC further recommend reporting of both types of Exclusions in the Annual Safe Schools report and it indicate the numbers of special needs students affected along with total students.

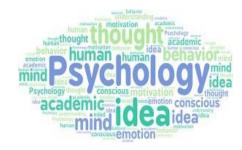




The Mental Health Team promoted mental health activities and resources throughout the system with the following activities:

- The Mental Health Professionals provided mental health resources to support the well-being of Newcomer students,
- Developed a presentation on Hope for Safe Schools Student Symposium. The presentation will be asynchronous for secondary students but deliveredsynchronously for elementary students.
- Distributed a message of Staff Well-Being with a focus on Self-Compassion for the month of November with mental health resources for both staff as well as classroom educators.
- Provided Staff Well-Being Professional Development for 70 Assessment and Programming Teachers as well as the Autism Staff members on Fostering our Own Resiliency During Uncertain Times.
- Provided Staff Well-Being Professional Development for 80 New Teachers.
- In collaboration with School Mental Health Ontario and York Region District School Board, we will present at the Annual Ontario Psychological Association Conference on **Supporting Student Mental Health in Schools During Uncertain Times.**

Psychology staff participated in the Dorothy Hill Symposium presented by the Ontario Psychological Association. This year's presentation was on *Social Justice and Anti-Oppressive Work in School Focused Psychological Services* by Dr. A. Jordan Wright from New York University. The presentation identified the



academic and social emotional impacts of inequities in education, and some initial steps needed to address these concerns within school psychology practice, and within school systems.

Psychology staff taking part in a Literacy Research Working Group resumed regular meetings this month. The goal of this working group is to review and summarize relevant research on the development of reading ability, and on reading assessment and intervention. The working group will be in-servicing psychology staff, and offering support for classroom literacy interventions this school year.

The Psychology Department continues to serve students, families and the school community. This includes in-person psychoeducational assessments, counselling and mental health supports, school team consultation, and psychology education for school staff and community.

A. EXECUTIVE SUMMARY

This report recommends updating the current Access Control Policy B.B.05 in order align with current practice and policies.

The cumulative staff time required to prepare this report was 8 hours.

B. PURPOSE

1. This recommended report is on the Order Paper for Governance & Policy Committee as it recommends a Policy revision.

C. BACKGROUND

- 1. The Policy on Policy was first approved in October 1988 and has not been amended since.
- 2. The Environmental Support Services Department maintains and administers the access controls processes and procedures for key and card access to all schools and facilities of the TCDSB
- 3. Changes to this policy reflect current practice and alignment with related policies:
 - **B.B.01** Facilities Management Policy
 - B.B.06 Employee Photo Identification (ID) Cards
 - S.S.04 Access to Students in Schools
 - Education Act, Section 53
- 4. Environmental Services is working to standardize and bring awareness to key and access card protocols for all locations.
- 5. Environmental Support Services provides keys and access cards to authorized staff.
- 6. Most recently, the Renewal Department has been installing a new card access systems with photo identification at school locations.

- 7. TCDSB photo ID cards will eventually be combined with access control cards to serve the dual risk mitigation purpose of photo identification and controlled access to various parts of a facility.
- 8. Several Regulations were removed from the Policy as they were more instructional in nature.
- 9. The Environmental Services Department is working to align and enact the policy with current procedures and proposed initiatives.
- 10. This policy was brought to the Governance and Policy Committee on January 11, 2022.

D. EVIDENCE/RESEARCH/ANALYSIS

1. This policy has been amended in consultation with staff from the Facilities and Communications Departments, Field Superintendents and Legal Services.

E. METRICS & ACCOUNTABILITY

- 1. Recommendations in this report will be monitored by Policy Development staff.
- 2. Costs associated with providing keys, access cards and installation of locks, and access cards readers will be monitored by Environmental Support Services Department.

Purpose:

The Toronto Catholic District School Board is committed to ensuring a safe environment for students, staff and occupants of all buildings. The Access Policy is intended to manage access to all properties owned or operated by Toronto Catholic District School Board, through the issuance, distribution and accountability of grand master and master keys, as well as building access cards.

Scope and Responsibility:

This policy extends to all schools and buildings of the TCDSB and all stakeholders that access them. The Superintendent of Facilities Environmental Support Services is responsible for implementation of this policy. The School Principal shall have the responsibility of administering and maintaining this policy within the school at the local level.

Policy:

Toronto Catholic District School Board (TCDSB) shall manage and control the issuance, distribution and accountability of keys and access cards to staff employed at one or more facilities owned or operated by TCDSB, as well as tenants and leaseholders in TCDSB facilities. All existing and future access points shall conform to this standard.

Regulations:

1. All grand master and master keys, as well as access cards that are issued to authorized employees must be signed for by the employee receiving the key and witnessed by an authorized senior staff person or authorized alternate / delegate.

- 2. Standardization of access card information has been developed in consultation with Safe Schools, Facilities Services, and Health & Safety. All cards are designed to have name and photo image of the person to whom the card is being issued. There will be some instances where a photo is not applicable. (See Procedures)
- 3. Access level **for access cards is** determined by the employee's job classification within the organization. This information is provided by the Human Resources Department to the Superintendent of Facilities **Environmental Support Services** or designate.
- 4. Written authorization from the Human Resources department to the Superintendent of Facilities Environmental Support Services or designate, is required for issuance of an access card to the Catholic Education Centre building and the parking structure.

5. Upon change of employment status or a change of position, with the Board, which would no longer require the employee to be an authorized key holder, employees shall relinquish said keys and card access to their immediate Supervisor or identified alternate approved senior staff person before any final or further payment to the employee is processed. The key and/or access card release form will be completed and returned to the Human Resources department. At a school location, the key and/or access card will be returned to the school Principal or Designate. At an Administrative Site, i.e. the Catholic Education Centre, the key or access card will be returned to the departmental Supervisor. (See Procedures)

- 6. Upon termination of an employee, the key(s) and access card shall be collected immediately from the terminated staff person or persons by the senior management staff person in attendance at the termination meeting. (See Procedures)
- 7. Secondary schools shall have a key distribution framework that will allow academic and support staff to have access to all classrooms utilized by their respective department(s) as well as identified common use spaces. (See Procedures)
- 8. Elementary schools shall have a key distribution framework that will allow academic and support staff to have access to individual classrooms (pass key) utilized by themselves as well as identified common use spaces. (See Procedures)

9. Tenants and/or Licensees operating in a TCDSB school, will be provided with a security access card at their sole cost which will be administered by the respective School Principal. Tenants and/or Licensees are required to pay a fee for each card to a maximum of two cards. There is an additional fee for replacement access cards. The operational hours on these access cards is Monday to Friday from 8am to 6pm, or as appropriate. (See Procedures)

** Exemption: the Board's Security contractor will be provided with the Board's Grand Master Keys to patrol and enter all school Board sites.

- 10. Employees must report lost or stolen cards to their Supervisor within six to twelve hours. The employee's Supervisor will report this information to the Superintendent of Facilities or Designate in writing immediately via email. (See Procedures)
- 11.Access cards that are damaged, obsolete or un-necessary cards must be returned to the Superintendent of Facilities Environmental Services or Designate by the school Principal or Designate. (See Procedures)
- 12.All employees of the Board must read the policy before the access card is issued and sign for receipt of both. All employees are expected to comply with this policy and its regulations
- 13.All non-union new hires will sign an Offer of Employment letter that identifies responsibilities of the employee with regards to Board property, including and not limited to, the Employee Security Access Card and Keys.
- 14. The Board requires all employees to treat their security access card and keys with the same respect as all other Board property issued.

15.Employees are prohibited from unauthorized possession or duplication of keys as well as disabling or re-programming of access cards. Employees are not permitted to circumvent locks, modify lock cylinders, tamper with door locks or latches to bypass security systems in place at TCDSB facilities.

16. These keys and access cards remain the property of the Board and shall not be duplicated or shared with others.

17. All new construction and retrofit projects shall conform to this standard.

Evaluation and Metrics:

- 1. **Environmental Support** Facilities Services will monitor the distribution and tracking of keys/access cards, in coordination with school administrator or designate.
- 2. Once a year the site administrator or designate shall validate the key holder list and access card listing, and provide this information to the Superintendent of Facilities Environmental Support Services or Designate.
- 3. Human Resources will communicate staff changes to the Superintendent of Facilities or Designate to ensure keys and access cards are assigned in accordance with the Policy at the Catholic Education Centre. (See Procedures)
