

Chair's Monthly Report

February and March 2023



A. EXECUTIVE SUMMARY

This report outlines proposed amendments to *Policy A.18 – Development Proposals, Amendments of Official Plans and Bylaws.* The purpose of these amendments is to improve the flow of development information throughout the organization.

The cumulative staff time required to prepare this report was 15 hours.

B. PURPOSE

This Recommendation Report is on the Order Paper of the Governance and Policy Committee as it recommends policy amendments.

C. BACKGROUND

- Policy A.18 Development Proposals, Amendments of Official Plans and Bylaws was first approved in February 1980, with amendments in January 1987 and January 2018. The policy addresses the Board's response to development proposals and amendments to the Official Plan and bylaws.
- 2. The TCDSB is a commenting agency for all development plans and proposals within the City of Toronto. Staff are circulated on development applications and collect data to supplement the Board's annual enrolment projections process.
- 3. Staff respond to all requests for comment to protect Board interests by identifying concerns and asserting positions. This can include requesting to be involved in construction management when a proposal poses direct site impacts to a Board property, as well as the installation of on-site accommodation signage to inform potential residents of local school enrolment capacity.
- 4. In the City of Toronto, development projects are often circulated on multiple occasions before reaching a final iteration. Staff also track and provide comments on proposal resubmissions as they progress through the development approvals process. This allows staff to address any ongoing concerns the Board may have with a specific development proposal.
- 5. Recommendations in this report were reviewed at the March 7, 2023 meeting of the Governance and Policy Committee.

D. EVIDENCE/RESEARCH/ANALYSIS

- 1. The proposed amendments to *Policy A.18 Development Proposals, Amendments of Official Plans and Bylaws* are intended to improve the flow of information between staff, Trustees, and school leaders.
- 2. Enhancing the flow of information will allow staff, Trustees, and school leaders to collaboratively assist with general advocacy and identifying issues which may impact schools and students at the local level.
- 3. Staff will inform Trustees, Area Superintendents and Principals when development proposals which are anticipated to significantly impact local enrolment are received and/or when a proposal poses immediate impacts to Board property/operations.

E. METRICS AND ACCOUNTABILITY

1. Statistics garnered from the development pipeline are used to inform TCDSB's annual enrolment projections. These statistics will be published on an annual basis within the annual enrolment projections report.

F. GOVERNANCE AND POLICY COMMITTEE RECOMMENDATION

The Governance and Policy Committee recommends that *Development Proposals, Amendments of Official Plans and Bylaws Policy (A.18)* provided in Appendix 'A' be approved.

The Toronto Catholic District School Board will formally assess and respond to all requests for comment related to a development proposals, official plan amendments to an official plan or a and proposed City of Toronto bylaw changes.

Regulations:

- 1. The Trustees, Area Superintendents and Principals will be notified of Toronto Catholic District School board ("the Board") will formally respond to all development proposals, official plan amendments and zoning by-law changes when received if the TCDSB anticipates a significant impact to student enrolment and/or the proximity of construction might have immediate impacts to a school site or daily school operations (eg. Construction traffic, shadows, noise and vibration and/or crane swing). that adversely affect the Board. The Board may be adversely affected because of insufficient space to accommodate students as a result of the development proposal, official plan amendment or zoning by-law change.
- 2. School community engagement will occur when need is identified by any of the parties listed above. The proposals, official plan amendments, zoning by-law changes and their impacts will be presented to the Board of Trustees on an annual basis.

Evaluation and Metrics:

Data collected by tracking development proposals, official plan amendments and/or zoning bylaw changes is integral to the accuracy of annual enrolment projections and will inform and be included in the reporting on the enrolment projection process. The

effectiveness of the policy will be determined by measuring the following:

The Director of Education will report responses referred to in Regulation 1 annually to the Board of Trustees for information.

A. EXECUTIVE SUMMARY

This report recommends rescindment of *Policy S.T.04 TTC Identification Cards*, as the policy no longer reflects the practices of the Toronto Transit Commission (TTC).

The cumulative staff time required to prepare this report was 3 hours.

B. PURPOSE

This Recommendation Report is on the Order Paper of the Governance and Policy Committee as it recommends policy rescindment.

C. BACKGROUND

- 1. Policy S.T.04 TTC Identification Cards was first approved in August 1977, and last amended in December 1987.
- 2. The policy was related to the provision of TTC Student Identification cards, which was a photo identification used along with fare payment when accessing transit services.
- 3. This policy no longer reflects current practices by The Toronto Transit Commission (TTC) or TCDSB.
- 4. Recommendations in this report were reviewed at the March 7, 2023 meeting of the Governance and Policy Committee.

D. EVIDENCE/RESEARCH/ANALYSIS

- 1. Beginning in March 2015, children age 12 and under are able to access the TTC at no cost.
- 2. The TTC has discontinued the practice of photo Student Identification *Cards.* Previously, TTC would arrange visits to TCDSB schools to photograph students for the purposes of these cards.
- 3. The TTC now provides the TCDSB with Child Proof of Age cards that are distributed to schools students that are 12 and under. These cards are generic, and do not include a picture. The cards assist in situations where the age of the student is in question and lets TTC drivers and fare collectors verify that the student is eligible to ride for free.

- 4. Secondary School students are required to carry the school issued photo identification as proof of age when travelling on the TTC.
- 5. *In summary, this policy is no longer required and should be rescinded and removed from the policy register.*

E. METRICS AND ACCOUNTABILITY

- 1. TCDSB will continue to align with the procedures of the TTC regarding the provision of student transportation.
- 2. The policy will be removed from the TCDSB policy register.

F. GOVERNANCE AND POLICY COMMITTEE RECOMMENDATION

The Governance and Policy Committee recommends that *Policy - S.T.04 TTC Identification Cards* be rescinded and removed from the Policy register.



A. EXECUTIVE SUMMARY

This report recommends this rescindment of the Subsidies for Individual Courses Policy HM 20.

The cumulative staff time required to prepare this report was 2 hours

B. PURPOSE

This Report is on the Order Paper of the Governance and Policy Committee pursuant to the policy review schedule.

C. BACKGROUND

- 1. Following the rescindment of Board policy HM 02 (Non-Union Employee Handbook), administration has maintained a handbook which includes the terms and conditions of employment for non-union administration and management employees. While the current handbook does not include any reference to individual course subsidies that may be available to non-union employees, they could be added if policy HM 20 was rescinded.
- 2. The Non-Union Employee Handbook is a live document that is accessible to non-unionized employees for information purposes through the Board's staff intranet. It is updated by Human Resources on a regular basis as necessary due to legislative requirements such as provincial amendments to the *Employment Standards Act* or due to operational reasons including the clarification of on call and call out provisions.
- 3. Recommendations in this report were reviewed at the March 7, 2023 meeting of the Governance and Policy Committee.

D. METRICS AND ACCOUNTABILITY

The Director of Education through the Executive Superintendent of Human Resources, Leadership & Equity will monitor the terms and conditions of employment for non-union employees and assess any revisions that may be necessary.

E. GOVERNANCE AND POLICY COMMITTEE RECOMMENDATION

The Governance and Policy Committee recommends that the Subsidies for Individual Courses Policy HM 20, attached as **Appendix A**, be rescinded.



TCDSB Policy Register Subsidy Of Individual Courses H.M.20

Policy

1. The Toronto Catholic District School Board shall pay the fee for courses completed by employees when such courses are taken at the request of the Board or the Director of Education.

2. Where the employees initiate requests for payment of courses, the Board shall pay the cost of prior approved courses, provided that such employees are not covered in a related or similar provision in a current collective agreement, and subject to the following regulations:

Regulations (For Policy Statement #2):

1. An applicant shall have a minimum of five (5) years experience with the Board

2. Applications shall be submitted in writing not later than June 30 to the Superintendent of Program Services.

3. Selections shall be made by a committee comprised of equal numbers of employees and the Board's administrative officials but not more than three of each.

4. Courses approved must be relevant to the job description for the employee's position and potentially result in increased skills or improvement in job performance.

5. The committee shall make recommendations to the Director of Education taking into consideration the high quality of service and the relative lengths of service of the applicants.

6. The total annual cost of courses for which the Board shall provide reimbursement shall not exceed the equivalent of twenty-five (25) university courses.



A. EXECUTIVE SUMMARY

This report recommends this rescindment of the Eastern Rite Employee's Holy Days Policy HM 01 and its replacement with a new policy, Religious Observance Days.

The cumulative staff time required to prepare this report was 5 hours.

B. PURPOSE

This Report is on the Order Paper of the Governance and Policy Committee pursuant to the policy review schedule.

C. BACKGROUND

- 1. Since 1970, the TCDSB has recognized the religious diversity of its employees with the provision of two paid days for religious observance of two holy days for employees who are members of the Eastern Rite Orthodox Church in place of Good Friday and Christmas Day. These two days are recognized province wide as public holidays for all employees regardless of religious denomination. (*Employment Standards Act, 2000*)
- 2. As the composition of the Board's non-academic workforce has changed over time to reflect the diversity of the City of Toronto, the TCDSB employs some employees that are not Catholic nor are they members of the Eastern Rite denomination of Catholicism. These employees may celebrate other Holy Days depending on their religion.
- 3. Employees of different faiths have referenced the Eastern Rite Employee's Holy Day policy when requesting up to two paid days for religious observance of their holy days. While their supervisors have granted the time, the process to be followed is unclear and not necessarily consistent since the employees making the request are not members of the Eastern Rite denomination.
- 4. The rescindment of the existing policy, which is applicable to members of only one denomination, and replacement with the new draft policy, "religious observance days" will provide clarity to all TCDSB employees of different faiths, including supervisors who are responsible for complying

with the Ontario Human Rights Code in the day-to-day management of nonacademic employees.

5. Recommendations in this report were reviewed at the March 7, 2023 meeting of the Governance and Policy Committee.

D. METRICS AND ACCOUNTABILITY

The Director of Education through the Executive Superintendent of Human Resources, Leadership & Equity will implement the new Religious Observance Days policy.

E. GOVERNANCE AND POLICY COMMITTEE RECOMMENDATION

The Governance and Policy Committee recommends that the Eastern Rite Employee's Holy Days Policy HM 01, attached as **Appendix A**, be rescinded, and replaced by the new policy, Religious Observance Days, attached as **Appendix B**.





Policy:

Under the *Employment Standards Act, 2000*, Good Friday and Christmas Day are public holidays for all employees, regardless of the religious denomination to which they belong.

The TCDSB employs some employees that are not Catholic and celebrate other, non-Catholic Holy Days. Therefore, such employees may request up to two (2) paid days off work over the course of a school year for religious observance on the Holy Days of the religious denomination to which they belong ("Religious Observance Day"), when said Holy Days fall on school or workdays, e.g., Christmas and Good Friday (Eastern Rite).

For clarity, employees will not be granted a Religious Observance Day where a Holy Day falls on a weekend.



Regulation:

1. Requests for Religious Observance Days shall be made to an employee's supervisor who may approve the request.

A. EXECUTIVE SUMMARY

This report recommends that TCDSB Student Trustee Policy, T.02., be amended to remove the requirement that student trustees be Roman Catholic.

The cumulative staff time required to prepare this report was 2 hours.

B. PURPOSE

1. The recommended amendment would bring Policy T.02 in compliance with the *Education Act* and the *Charter of Rights and Freedoms*, following the recent decision of the Ontario Divisional Court in *Kandaharian* v. York Catholic District School Board.

C. BACKGROUND

- 1. On October 6, 2022, the Superior Court of Justice (Divisional Court) released its decision and reasons in *Kandaharian v YCDSB*.
- 2. *Kandaharian* was a legal challenge initiated by a student of the YCDSB. The student, Daria Kandaharian, challenged the validity of a YCDSB Policy that required that student trustees be Roman Catholic.
- 3. The Divisional Court struck down the policy requirement that student trustees be Roman Catholic.

D. EVIDENCE/RESEARCH/ANALYSIS

The Court's Decision

- 1. In Kandaharian, the Divisional Court found that the YCDSB had no legal authority under the *Education Act* and Ont. Regulation 7/07 to impose a religiousbased qualification for student trustee. As such, the policy requirement was outside the jurisdiction of the YCDSB and could not stand.
- 2. The YCDSB relied on its special status and powers under s. 93(1) of the *Constitution Act*, 1867. The Court found that s. 93(1) provides constitutional protection to Roman Catholic separate schools in Ontario to the extent of the rights they had at the time of Confederation. The Court found that this protection did not extend to the student trustee position. The position was created

by the Legislature in 1997 and so was not a right or privilege held by the YCDSB at Confederation.


- 3. In the absence of protection provided by s. 93 (1), the Court held that the YCDSB policy was not immune from a challenge that it discriminated based on religion, contrary to s. 15 (1) of the *Charter of Rights and Freedoms*. Section 15 (1) of the *Charter* provides every person with the right to equal treatment without discrimination based various enumerated grounds, including religion.
- 4. The Court found that the requirement that student trustees be Roman Catholic breached s. 15 (1) of the *Charter* and that this infringement was not a reasonable limit on the right to be equal treatment without discrimination. As such, the policy requirement that student trustees be Roman Catholic was unconstitutional.
- 5. The Court struck the policy requirement as being outside of the Board's jurisdiction and contrary to the Charter of Rights and Freedoms..

TCDSB Policy T.02

- 6. TCDSB Policy T.02 requires that candidates for student trustee must be Roman Catholic (see regulation 10(i) of Policy T.02).
- 7. The Court held that such a requirement is outside of a school board's jurisdiction and unconstitutional because it is an unjustified infringement of s. 15(1) of the *Charter of Rights and Freedoms*.
- 8. To bring T.02 in compliance with the *Education Act* and the *Charter of Rights and Freedoms*, the requirement that student trustees be Roman Catholic should be removed from Policy T.02.
- 9. Recommendations in this report were reviewed at the March 7, 2023 meeting of the Governance and Policy Committee.

E. GOVERNANCE AND POLICY COMMITTEE RECOMMENDATION

- 1. The Governance and Policy Committee recommends that Student Trustee Policy, T.02, be amended by striking out the words "Roman Catholic" from Regulation 10(i), as in Appendix A to this report.
- 2. The Governance and Policy Committee further recommends that an information session be provided to our Education Partners Catholic Parent Involvement Committee (CPIC) and Ontario Association of Parents in Catholic Education (OAPCE) to explain the legal basis for the policy change.


Appendix A - Rights and Responsibilities of a Student Trustee Appendix B – Process for Election of the Student Trustee

Purpose:

This Policy provides for the direct representation of the interests of students on the Board in accordance with the provisions of the Education Act, Ontario Regulation 07/07 and any guidelines issued by the Minister of Education under paragraph 3.5 of subsection 8(1) of the Education Act.

Scope and Responsibility:

The policy applies to the election of two Student Trustees and their terms of reference, as well as rules of engagement while participating at Board and



Committee meetings. The Director of Education, with the assistance of the Superintendent of Education for Curriculum and Accountability, is responsible for this policy.



Regulations:


- 1. The Toronto Catholic District School Board shall establish two Student Trustee positions to represent the interests of all students. Student Trustees must be enrolled in the senior division of the Board.
- 2. The Student Trustees may participate in TCDSB Board and Committee meetings, both in public and private session. A Student Trustee is not entitled to be present at a meeting that is closed to the public if the subject matter under consideration involves the disclosure of intimate, personal or financial information in respect of a member of the board or committee, an employee of the board or a pupil or his/her parent or guardian. Student Trustees are not considered elected members of the Board and are therefore not entitled to exercise a binding vote, not eligible to move or second motions but are entitled to suggest a motion and are entitled to require that a vote be recorded and have their vote recorded.
- 3. The student trustees will serve two successive one-year terms beginning on August 1 of the year in which he or she is elected and end on July 31 of the following year of election, following a transition period from May until July 31, in the first year of election.
- 4. Only one trustee will be elected each year. Each student trustee will be elected in April of their second year of secondary school, thus commencing their two year term to begin August 1.
- 5. The student trustee elected may not be from the same secondary school as the incumbent student trustee.
- 6. The Student Trustees will serve as the Co-Chairs of the Catholic Student Leadership Impact Team (CSLIT). The CSLIT will hold at least one meeting per month during the school year.

- 7. A student trustee must resign from their position if they are absent from three (3) consecutive regular meetings of the board without being authorized by a resolution of the board. Authorizations by resolution must be provided to student trustees in the same manner as they are to board members and must be recorded in the meeting minutes. Student trustees are considered present at a meeting in which they participate through teleconferencing, videoconferencing or other electronic means.
- 8. Where a vacancy occurs with one Student Trustee, the second Student Trustee will continue with his/her duties and the Director of Administrative Affairs of CSLIT shall fulfill the duties of a Student Trustee for the balance of the Student Trustee's term or until such time as a by-election is held and a new Student Trustee is elected.
- 9. Each secondary school will be entitled to put forward one candidate for election to one of the positions of Student Trustee in any given year.
- 10.Each candidate for the position of Student Trustee shall meet the following qualification criteria:
 - be a Roman Catholic student enrolled at a Toronto Catholic District School Board secondary school, and during his or her term of office must be a full-time student or is an exceptional pupil in a special education program for whom the board has reduced the length of the instructional program on each school day under subsection 3(3) of Regulation 298 of the Revised Regulations of Ontario, 1990 (Operation of Schools—General) made under the Act, so long as the pupil would be a full-time pupil if the program had not been reduced;
 - (ii) be elected by the local student body;



- (iii) receive the written approval of his/her parent(s)/guardian(s), unless 18 years of age, to stand for election and also present a letter of reference from a teacher, guidance counsellor or Principal; and
- (iv) maintain a grade average that will contribute to his/her successful graduation at the time of becoming a candidate for the position.
- 11. The Superintendent of Education, Curriculum and Accountability Department or designate, shall establish procedures and include suitable orientation to assist the Student Trustees in fulfilling their roles and responsibilities.
- 12. The Student Trustees will provide a verbal report and/or written report at each regular Board meeting.
- 13. A Student Trustee may be disqualified from holding office for one or more of the following reasons:
 - (i) serious violation of the TCDSB Trustees' Code of Conduct;
 - (ii) disclosure of intimate, personal or financial information in respect of a Trustee or committee, an employee of the TCDSB or a student or his/her parent or guardian;
 - (iii) commission of a serious breach of his/her school's code of conduct;
 - (iv) demonstrated behaviour that is deemed to be incompatible with the role and responsibilities of the Student Trustee.
- 14. Student Trustees shall be entitled to reimbursement of out-of-pocket expenses as if they were members of the Board.



- 15. Student Trustees shall be paid an honorarium of \$2,500 for a complete term of office, consistent with the provisions of the Education Act, which shall be prorated if the Student Trustee holds office for less than a full term.
- 16. Student Trustees have the same status as a Board member with respect to access to Board resources and opportunities for training.
- 17. The successful candidates elected/appointed to the position of Student Trustee will have prescribed rights and responsibilities. (<u>Appendix A: Rights</u> <u>and Responsibilities of the Student Trustee</u>)
- 18. The procedure for election of Student Trustees is determined by the Board. (Appendix B: Election of the Student Trustee)
- 19. Student Trustees shall be required to wear their school uniform or business attire when attending Board or Committee meetings, representing the Board at either internal or external board-related business meetings, or when meeting with other students in the Board in the capacity of student trustee.
- 20. The opportunity to earn a secondary school credit towards the Ontario Secondary School Diploma in the area of Co-operative Education, consistent with Ministry of Education policies and procedures, will be offered to the Student Trustees.
- 21. The board shall provide the Ministry with the names of the student trustees elected, not later than 30 days after the date of the election or by-election.

Evaluation and Metrics:

The "Ratification of Student Trustee Nominees" report will be brought to the Student Achievement Committee in May of each year.

Dear Members of the Board of Trustees,

Re: Closed meeting complaint

My Office received a complaint regarding a closed meeting held by the Board of Trustees (the "Board") for the Toronto Catholic District School Board on October 27, 2022. The complaint alleged that the Board's closed meeting agenda was not made public and that the open meeting agenda did not list the items that were discussed in closed session. The complaint also alleged that the Board did not provide sufficient information about the subject matter of its October 27, 2022 closed session discussions when it reported back in open session.

I am writing to share the outcome of my review of this complaint. For the reasons set out below, my Office has determined that the Board's October 27, 2022 meeting agendas met the requirements set out in the *Education Act*¹. In addition, my review has determined that the Board complied with the Toronto Catholic District School Board's Operating By-Law Number 175 (the "Operating By-Law") and my Office's best practices when it reported back to the public following its closed session discussions on October 27, 2022.

Ombudsman's role and authority

The Ombudsman is an independent and impartial Officer of the Ontario Legislature. Since September 1, 2015, the Ontario Ombudsman has the authority to carry out impartial and independent reviews and investigations of complaints concerning the administrative conduct of school boards. In addition, my Office is the closed meeting investigator for more than half of Ontario's 444 municipalities. As the province's default closed meeting investigator, my Office is responsible for determining whether a municipality has complied with the open meeting requirements outlined in the *Municipal Act, 2001*.

My Office has investigated hundreds of closed meetings since 2008. To assist municipal councils, staff, and the public, we have developed an online digest of closed meeting cases. This searchable repository was created to provide easy access to the Ombudsman's decisions on, and interpretations of, the open meeting rules. While the open meeting requirements in the *Municipal Act* differ from those in the *Education Act*, school boards can consult the digest to inform their discussions and decisions on whether certain matters can or should be discussed in closed session, as well as issues related to open meeting procedures. Review

My Office reviewed the open and closed meeting materials, including the meeting minutes, agendas, and reports, and watched relevant portions of the video recording of the open meeting. We also reviewed relevant sections of the Toronto Catholic District School Board's Operating By-Law and spoke with the Toronto Catholic District School Board's Recording Secretary and the Executive General Counsel/Head of Legal Services.

October 27, 2022 meeting

The Board of Trustees held a meeting on October 27, 2022. Consistent with its typical practice, the Board first met in closed session at 6:00 p.m. At 7:00 p.m., the Board resolved to move into open session and began its public meeting as scheduled. After discussing various matters, the Board subsequently returned to closed session, and then returned to open session.

My review found that during the first closed session, the Board reviewed a report pertaining to a property matter. My review indicates that during the second closed session, the Board considered a report pertaining to a labour relations matter, received a personnel update from the Director of Education, and discussed inquiries and other issues.

Following the closed sessions, the Board provided the following public reports regarding its closed session discussions:

Reports from Private Session

MOVED by Trustee Li Preti, seconded by Trustee de Domenico, that the following report from Trustee Tanuan, be received.

In PRIVATE Session – dealt with a property matter and passed a motion to resolve back after PUBLIC Session.

Reports from Private Session

MOVED by Trustee Crawford, seconded by Trustee Martino, that the following report from Trustee Tanuan be received.

In PRIVATE Session – discussed labour matters, received a personnel update from the Director and discussed Inquiries.

The Board then considered various other matters in open session and adjourned the meeting.

Analysis

Under the *Education Act*, all meetings of a board of trustees must be open to the public, subject to prescribed exceptions.² Subsection 207(2) of the Act allows for meetings of a committee of a board, including a committee of the whole board, to be closed under certain exceptions.

Article 4.16 of the the Toronto Catholic District School Board's Operating By-Law similarly states that meetings of the Board of Trustees and committees of the Board of Trustees may be closed to the public when the subject matter under consideration involves any of the exceptions outlined at subsection 207(2) of the *Education Act*. Article 1.2 of the Operating By-Law also states that "[f]or the purposes of this By-Law references in the Act to a committee of the whole board shall be deemed to be references to the Board of Trustees."

Agenda

The complaint alleged that the Board's closed meeting agenda was not made public and that the open meeting agenda did not list the items that were discussed in closed session. However, the *Education Act* does not require that boards publicize their closed meeting agendas, nor does it require that boards list the topics of discussion for closed sessions in their open meeting agendas.

Under subsections 218.4(c) and (d) of the *Education Act*, the Chair of the Board of Trustees is

responsible for establishing agendas for board meetings in consultation with the Director of Education, and is to ensure that trustees have the information needed for informed discussion of agenda items. The *Education Act* does not otherwise prescribe minimum requirements for meeting agendas. My Office's review indicates that the Board did prepare open and closed meeting agendas with attachments the October 27, 2022 meeting.

Report back

The complaint alleged that the Board did not provide sufficient information about the subject matter of its October 27, 2022 closed session discussions when it reported back in open session.

Although there is no requirement under the *Education Act* for boards of trustees to report back in public after the conclusion of a closed meeting, my Office has recommended this practice in the municipal context to increase transparency of the municipal closed meeting process.³ A report back may consist of a general discussion in open session of subjects considered in closed session, together with information about any decisions, resolutions, and directions given to staff.⁴ In other cases, the nature of the discussion might allow for considerable information about the closed session to be provided publicly.⁵ Reporting back after each closed session provides meaningful information to the public about the issues discussed *in camera* and inspires confidence that the meeting has been properly closed.⁶

The Operating By-Law does not prescribe a minimum level of detail to be included in a report back in open session about closed session discussions.

In this case, my review indicates that the Board reported back in the public session that it discussed a property matter in the first closed session. Following the second closed session, the Board reported back publicly that it discussed labour matters, received a personnel update from the Director, and discussed inquiries *in camera*. These subsequent reports provided the public with information about the nature of the Board's discussions in the two closed sessions. I commend the Board for adopting this best practice and encourage it to continue providing, as appropriate, information to the public about the outcome of its closed session discussions.

Conclusion

My review has determined that the Board of Trustees for the Toronto Catholic District School

Board met the meeting agenda requirements outlined at subsections 218.4(c) and (d) of the *Education Act* at its October 27, 2022 meeting. In addition, my review has determined that the Board complied with the Toronto Catholic District School Board's Operating By-law and my Office's best practices for reporting back when it provided the public with information about the subject matter of its closed session discussions on October 27, 2022.

I would like to thank the Board for its co-operation during my review. The Toronto Catholic District School Board's Executive General Counsel/Head of Legal Services has confirmed that this letter will be included as correspondence at an upcoming board meeting.
