Good evening and thank you for the opportunity to speak to Mr. Del Grande's motion regarding flying the pro life flag and Pro life educational opportunities on May 9th 2024 for our students.

I am a retired Catholic teacher beginning my career in 1989 and have retired as of June 2023. I attended Catholic school my whole life beginning in 1966. Quite frankly, I was insulted to hear about the ongoing attacks on Mr. Del Grande in the Toronto Star. These attacks are unacceptable.

Maybe if Jesus had just towed the line and listened to the Pharisees ...all challenges novel ideas would cease to exist. We need strong advocates of the faith to witness to the truth and Mr. Del Grande does that with determination and courage.

When I attended the M.S.S.B. the teachings of the church were clearly taught to us in Religion classes both at the elementary and secondary level by priests, nuns and teachers.

When I returned to teach for the T.C.D.S.B. I noticed some changes in the school system since my time. Sadly, over the years I witnessed our system become increasingly secular. Ultimately the continuation of Catholic education relies on all employees, parents, students, administration and trustees to continue to be witnesses of the faith . Mr. Del Grande's motion is one opportunity to do so.

Let me provide an example from my experience. When I was teaching civics the Principal of the School mentioned that the MP would like to visit my class. I agreed. She presented herself as a Catholic role model. She proceeded to talk about the Canadian political process which was informative for the students. When it came time for questions I asked her "was she pro life." She answered" the Prime Minister is pro choice and so am I" I pointed out the fact that belief is not found in church teaching .I wanted to witness to pro life in front of my students . I am firmly anti abortion and believe unborn children are people with

As Christians we have an obligation to witness those teaching and Mr. Del Grandes' motion is a much needed opportunity to be a beacon of catholic teachings and a light in the world. The teachings around pro life are not open for debate and I am dumbfounded why some Catholic trustees do not support this motion. More religious instruction is needed in this turbulent world to ensure our students make good choices and build their lives on a solid foundation. I conducted a poll with my students in civics class after the visit with the MP and I was very surprised to discover 99% of the students in my class were pro choice. I thought to myself how did this situation arise? This happened because they were not being taught the right values. This is a cause worth pursuing. Please stop wasting time opposing pro life flag flying and curriculum initiatives proposed for May 9th.

My name is Joe Di Fonzo.

I am a retired teacher from the TCDSB. I taught for 32 years (7 in elementary and 25 at the secondary level and most of those years teaching Religion and Physical Education). Looking back, I feel very fortunate to have spent those years bringing my students to a fuller understanding and love of the faith we all share and in helping them understand and appreciate the miracle of human life and its fragility.

This was fully supported by the school board in various ways:

- ...by promoting this week throughout the entire board to all schools
- ...by helping with the printing of material resources which included daily prayers and teaching resources to be used in the classroom.
- ...by helping finance the cost of guest speakers in schools
- ...and by helping finance buses, transporting students to the annual March for Life in Ottawa

These endeavors were well received and very effective in helping students understand, respect and value all human life, born and preborn, disabled and able, the young and elderly and those in their last days of life.

What came of these efforts? The school board administration thought it best to have this teacher-led initiative passed over to their administration. This made sense as it

was indeed a board wide initiative and several of the teachers organizing it, like myself, were soon to be retiring.

I am not certain what has come of this special week. Perhaps it may be the case that with so many other board initiatives to organize and administer, this issue and this special week has been lost. If that is the case, it is a great shame that this has happened. (But, I am open to being corrected on this.)

However, the proposed motion by Trustee Del Grande can move us back to where we should be. May (the month of Mary) is the perfect month to attest to what we believe in, namely the sanctity of all life. Mary's "yes" to life and our "yes" to life go hand in hand.

The Pro Life flag flown in May will speak to this truth....that every child does matter, including the most innocent and vulnerable child in the womb.

As trustees of Catholic Education for this board, you are to lead all stakeholders in this noble mission of educating our youth in truth and goodness.

How appropriate that on this day, Ann Marie D'Amico Day of Kindness and Love that you have an opportunity to show your kindness and love for the preborn through a vote unanimously in support of this motion.

It is an honour to be here tonight to speak to a Motion that is close to my heart. Trustee Michael Del Grande and many faithful Catholics and people of good will see the desperate plight of the precious unborn children in our land.

St John Paul II states in Evangelium Vitae:

4. CATHOLIC PARENT INVOLVEMENT COMMITTEE RECOMMENDATION TO THE BOARD OF TRUSTEES

The Catholic Parent Involvement Committee recommends to the Board of Trustees that the following be approved:

That Regulation 7 be reviewed to provide clarity regarding using Board approved vendors for major purchases (i.e. capital, technology) vs. nominal purchases; and

Members of the Board of Trustees,

RE: S.M.04 – Fundraising in Schools

Earlier this year, the Governance Committee approved a revised SM04 policy recommended by Staff and subsequently was approved by the full Board.

CPIC was informed about the policy, given its close ties to Catholic Parent School Councils and parental involvement with fundraising, but had not had an opportunity to review it before it was submitted to the Governance Committee. Upon our review, Members expressed concern over some of the provisions changed or struck. We also liaised with various CSPCs and found consensus amongst the parent community who responded.

- *“All purchases using fundraising proceeds shall follow the Boards Purchasing Policy and be mindful of any ongoing costs that could accrue to the Board. Purchases should only be made from Board approved vendors unless approved by Financial Services”*
- We believe to be overreach because as read would include all purchases (large or small). As you know fundraising dollars CSPCs raise is used for a long array of items, one-of purchases and large endeavors. CSPCs would generally agree to use Board approved vendors where it makes sense. For large capital purchases this would be expected to support Board purchasing power, warranties and supplier oversight.
- We further note that the Board does not publish its most common approved vendor list that CSPCs use, unlike the Toronto District School Board (TDSB).
- CPIC recommends to the Board of Trustees **“Regulation 7 be reviewed to provide clarity regarding using Board approved vendors for major purchases (ie: capital, technology) vs. nominal purchases.”**

- #8: *"When fundraising is a joint project with the local Catholic School Advisory Council and/or Student Council, it is understood that the decision making as to the disbursement of funds is also a joint responsibility."*
- This provision appears to be completely removed in the revised policy. Our parent community raised considerable concern about assumptions/current practice being made. While we have most school communities with great relationships, we have had some over the years where there has been not as ideal collaboration between administration and CSPCs as we would like. While we do not believe the intention would ever to be to cut parents out of the decision process, parents had expressed that they could rethink their volunteer activities and fundraising support because policy no longer explicitly includes them.
- CPIC recommends to the Board of Trustees **"Regulation 8 that was removed, be-reinstated to provide clarity that joint fundraising projects require a supporting motion from the Catholic School Parent Council on funds disbursement."**

We generally believe in strong policy language that makes it clear for all parties involved and removes ambiguity or assumptions. This was clearly evident in our advocacy and your support years at the time for the policy, S.10 CSPC review and keeping/enhancing key provisions.

We appreciate your consideration of this CPIC motion and ask that you reconsider the policy addressing the two items noted. As a Committee we look forward to positive response.

3. The school principal must approve the content, and/or posting on school property, of any advertising materials, or the distribution of notices dealing with school fundraising events.

Individuals and organizations, ~~approved under policy S.13, Approved Access to Schools by Individuals and Organizations,~~ who wish to raise funds on school property and/or with the assistance of school staff and students, must do so in accordance with the fundraising policy and its regulations **only with prior principal consent.**
5. Funds raised under this policy shall not be used to purchase textbooks, learning materials and resources for regular classroom programs which would normally be funded through Board and school-based budgets.
6. **Funds raised for capital or technology related projects must be pre-approved by the Principal in consultation with Financial Services and the applicable Superintendent.**
7. **All purchases using fundraising proceeds shall follow the Boards Purchasing Policy and be mindful of any ongoing costs that could accrue to the Board. Purchases should only be made from Board approved vendors unless approved by Financial Services.**
