FIX OUR SCHOOLS Campaign

We are a grassroots, non-partisan, parent-led campaign creating a large network of citizens across Ontario who all expect that:

- Ontario's publicly-funded schools are safe, well-maintained buildings for the 2-million students who attend them
- The \$15-billion of disrepair across all 72 Ontario school boards is addressed
- Publicly-funded schools are funded as critical public infrastructure on par with transit

Learning IMPACT of disrepair:

Research shows that school conditions impact student achievement, health and attendance1: Research shows that school conditions impact

on 2-million students who attend publicly-funded schools in Ontario

Classrooms 10°C in winter / over 30°C degrees in spring & fall learning and focus challenging

Washrooms that children refuse to use health issues such as bladder infections

Leaking ceilings > student distraction

opportunity for mould growth and associated health risks

Catastrophic IMPACT of disrepair: at the greatest risk:

It is the invisible types of disrepair that put student safety

Many repair items pertain to fire suppression/alarm systems, electrical systems, heating/cooling systems and structural issues.

- 6-year old student's head injury due to washroom door breaking
- → Auditorium ceiling collapsing during school hours
- → Fire exit blocked because outdoor steps collapse

Community IMPACT of disrepair:

Besides students, those also impacted by disrepair in publicly-funded schools include:

on the hundreds of thousands who also use school buildings

- Children in daycare programs in schools
- Teachers and school staff
- School administrators
- Citizens who rely on schools as community hubs



Funding FACTS:

- ► Every single one of our 72 school boards is impacted by the \$15-billion capital repair backlog in Ontario's publicly-funded schools
- Critical and urgent disrepair now totals \$1.7-billion, as per Ontario's Auditor-General 3
- Maintenance in publicly-funded schools over the last five years was underfunded \$5.8-billion 3
- ► Reactive repairs are estimated to cost 173% more than proactive repairs ⁴

CURRENT Funding solutions:

GROSSLY INSUFFICIENT TO DECREASE REPAIR BACKLOG

Commitment of \$11-Billion over 10 years cannot repair AND rebuild Ontario's schools

Selling schools conflicts with goal of realizing public assets as community hubs

- is a long process that requires provincial co-operation
- offers an incomplete funding solution

Funding solutions TO EXPLORE: SHORT TERM

- → Revise O. Reg. 20/98 to allow all School Boards to access Education Development Charges
 (EDCs) and use these monies for repairs, capital projects or land purchase
- → Allocate some of the promised new federal infrastructure funding to increase investment in repairing and rebuilding Ontario's publicly-funded schools
- → Allocate the capital costs of maintaining school buildings (and associated green spaces) used as Community Hubs, **in proportion to usage** by school boards, municipalities & various Ministries



Funding solutions TO EXPLORE: LONG TERM

- → Secure a long-term, sustainable funding source to maintain schools as critical public infrastructure.
- Develop health & safety standards for children in schools much like the workplace health and safety standards for adults - and fund those standards accordingly

Further recommendations

TO HELP ADDRESS DISREPAIR IN PUBLICLY-FUNDED SCHOOLS:

- → Publish the capital repair backlogs for every publicly-funded school within every Ontario school board once per year so that Ontario citizens have access to this information
- Establish guidelines for the desired condition at which facilities should be maintained
- Provide constructive & comparable feedback to every Ontario School Board on its capital plan. Trustees, staff and parents deserve transparency on where their School Board stands in the eyes of the Province in terms of "efficient use of space"

- Promote the Fix Our Schools campaign to parents (we can send materials to assist)
- Work with parents in your Ward to set up meetings with your MPP (Fix Our Schools can support these meetings)

Our ask of TCDSB Staff

→ Work together with Fix Our Schools to share information and insights, as appropriate
