TOPIC: **School-based Revenue Sharing**

WHEREAS: there is a growing disparity between what schools in high-income areas are able to fundraise for student success supports, and what schools in low-income areas are able to fundraise.

WHEREAS: closing the gap to learning opportunities for all TCDSB students is a clear goal of our Multi-Year Strategical Plan.

WHEREAS: the very significant contribution of some parents to help raise money in support of their children's school should not go unrewarded.

WHEREAS:

Therefore, be it resolved that, the TCDSB consult with school parent councils on a proposed revenue sharing model that would see a very small percentage of locally raised funds being redirected from schools with above average fundraising to schools with below average fundraising, in accordance with the following formula:

Where:

SE= Enrollment for the school

BE= Total enrollment for all schools in the TCDSB.

SFR= Funds raised by the school for the year.

BFR= Total funds raised by all schools in the TCDSB for the year.

Schools shall either give / receive or be revenue neutral: $\text{School Funds raised per student} / \text{Board Funds raised per student} * \text{number of students} [(SFR/SE) - (BFR/BE)] * SE * 10\%$


Where a positive value indicates an amount to be given, and a negative value, indicates an amount to be received.

For example, St Peter raises \$50,000 and has 500 students.

Therefore, the school raised \$100 per student.

Assuming the average amount fundraised in schools across the TCDSB is \$50 per student, St Peter has raised \$50 per student more than the average.

Therefore, under the proposed revenue sharing model, St Peter would share $(10\% * \$50 * 500 \text{ students}) = \1250 (or 2.5% of the \$50,000 fundraised). To be distributed using the same formula to school that raise less than the average funds raised by TCDSB schools.

Topic of Presentation	Impact of secondary school boundaries on Eastern Rite elementary schools
Topic or Issue	In many cases, it is impractical for graduates of Eastern Rite Schools to attend the secondary school closest to their elementary schools. There should be language in the secondary schools boundary policy that acknowledges this and proposes an alternate mechanism.
Details	Eastern Rite elementary schools have a significantly larger catchment area than most TCDSB elementary schools. As such historically students from all three of these schools have attended Father John Redmond, Bishop Allen and Michael Power. The result of this historical The historical relationship with these schools has led to an appreciation, understanding and accomm dation of Eastern Rite masses, religious feast days, traditions and holidays. By and large it is one of these three schools that is indeed the closest TCDSB school, and easiest to get to by public transit, to most of our students' homes.
Action Requested	We would ask for the secondary school boundary policy to state that students graduating from the three Eastern Rite schools – Josyf Cardinal Slipyj, St. Demetrius and St. Josaphat – be able to continue to select from among three TCDSB secondary schools – Bishop Allen, Father John Redmond and Michael Power. We believe this will result in continued growth in enrolment at the Eastern Rite elementary schools as well as pull through enrolment into TCDSB secondary schools.
