## A. EXECUTIVE SUMMARY

This report provides both a history and assessment of the level of support for the Toronto Catholic District School Board and Villa Charities Inc. intergenerational community hub project. The joint venture educational and cultural arts facility on Lawrence Avenue West was intended to house a 1,300 pupil place replacement secondary school for Dante Alighieri Academy and a new Columbus Centre.

Based on the recently completed Maximum City/Dillon consultation process, as well other opportunities for public input, including public meetings, Board deputations, Italian media coverage, and provincial government involvement, the level of support for the intergenerational community hub project does not achieve the *overwhelming support* threshold reference in the Board motion of November 16, 2017.

On February 14, 2018, the Board received a communication from the Minister of Education stating that due to the significant concerns regarding the potential demolition of the Columbus Centre and the ongoing divisions which still exist over the project, the Ministry of Education will not support a school project than allows for the demolition of the Columbus Centre.

Prior to receipt of the letter from the Minister of Education on February 14, 2018, staff were prepared to recommend a continued partnership with Villa Charities Inc. for the purpose of developing an intergenerational community hub through a new, participatory design process as recommended in the Maximum City/Dillon Report. This would mean starting the entire process over again.

Given the position of the Ministry of Education as of February 14, 2018, this report recommends that the Toronto Catholic District School Board proceed with a standalone secondary school on TCDSB property and discontinue the concept of a joint facility with Villa Charities Inc.

### The cumulative staff time required to prepare this report was 90 hours.

## **B. PURPOSE**

The purpose of the report is outlined below:

- 1. To respond to the two recent Trustee Motions with respect to the TCDSB/VCI Intergenerational Community Hub
  - i. Regular Board November 16, 2017, which resolved that:
    - ...upon completion of the public consultation by January 31, 2018, a report shall be delivered to a full meeting of the Board, within 30 days from that date, with a final recommendation that includes the framework for construction and anticipated timelines; and
    - ...should the outcome of the public consultation not document overwhelming support for the redevelopment of the Villa Charities site, the TCDSB will no longer pursue the partnership with Villa Charities Inc. and instead proceed with the building of Dante Alighieri Academy Catholic Secondary School on the property presently owned by the Board.
  - ii. Regular Board January 25, 2018 At this meeting, the Board adopted the following resolution:

In order to fulfil the motion of the Board passed on November 16, 2017 which committed the Board to consider the consultants' report on the public consultation and report back to the Board within 30 days;

The consultants' report was received on January 25, 2018 and the Board resolves that the Director deliver a report to the Board on February 22, 2018 on his assessment of the consultation report; and

The Board resolves that the Director of Education be authorized to enter into an amending agreement with Villa Charities Inc. extend the due diligence date in the Agreement of Purchase and Sale between the two parties to March 6, 2018.

- 2. In order to determine the level of support for the project, an assessment of the following will be provided:
  - i. Dillon/Maximum City Consultation process and report
  - ii. Research Etc. quantitative telephone survey
  - iii. Other public meetings, sessions, media coverage

- 3. Present benefits of the Intergenerational Community Hub.
- 4. Assess a future pathways for this project.

# C. BACKGROUND

## 1. <u>Historical Context of Dante Alighieri Academy</u>

The following context is necessary to fully understand the chronology of actions leading to the pursuit of a new school facility for Dante Alighieri Academy:

- a. Dante Alighieri Academy was built in 1973 on Playfair Avenue.
- b. The school building was originally designed to Senior Elementary school standards, and does not possess the required specialty classrooms and support spaces typically associated with secondary schools.
- c. The school has long been oversubscribed, resulting in 20 portables on site during the 1990s.
- d. As enrolment continued to climb, it was necessary for TCDSB to lease a TDSB vacant site, Bathurst Heights Secondary School, to accommodate the grade 9 students of Dante Alighieri from 2008 until June 2011.
- e. In September 2011, the grade 9 students were relocated to another TDSB school, Sir Sanford Fleming Academy, and remained there until June 2017.
- f. An accommodation solution for Dante Alighieri Academy was identified as the Board's top urgent Capital Priority Needs project for 2010-2011, and was submitted to the Ministry of Education for funding.
- g. Beginning in September 2017, the grade 9 students returned to the Playfair campus, reuniting with the grade 10-12 students.
- 2. **September 1, 2011** Toronto Catholic District School Board received capital priorities funding in the amount of approximately \$32.8 million from the Ministry of Education to proceed to construct a 1,300 pupil place replacement facility for Dante Alighieri Academy.
- 3. The TCDSB and Villa Charities Inc. (VCI) have a long-standing program partnership. Both parties expressed an interest in exploring opportunities for a joint development, multi-use educational/recreational/cultural facility on the southwest quadrant of Dufferin Street and Lawrence Avenue West.

- 4. **November 16, 2011** the Board and Villa Charities agreed to proceed with a Joint Feasibility Study (JFS) for the redevelopment of their combined land holdings. The firms of Global Architect Inc. and Pillon Architect Inc. were jointly retained by both parties to undertake the JFS. The purpose of the study was to assess redevelopment opportunities for replacement facilities for Dante Alighieri Academy and the Columbus Centre in the southwest quadrant of Dufferin Street and Lawrence Avenue West. The feasibility study evaluated the benefits of a joint-use complex consisting of a new secondary school and cultural recreational centre in comparison to stand-alone facilities for each party.
- 5. **November 20, 2012** the Board approved the construction of a replacement facility for Dante Alighieri Academy as part of a joint venture intergenerational community hub with VCI. The joint venture educational and cultural arts facility would house the new secondary school and a new Columbus Centre. The facility was originally contemplated to be located on Dufferin Street, however due to the inability to secure property for the project, VCI and the Board decided to pursue an alternative option for the joint building.
- 6. **January 6, 2014** the TCDSB received approval from the Ministry of Education to proceed with the joint venture with VCI as required under Section 196 of the *Education Act*.
- 7. **February 13, 2014** at the Corporate Affairs, Strategic Planning, and Property Committee, the Board approved, subject to the completion of the required land purchases to accommodate the construction of the new facility, the appointment of the architecture firm CS&P Architects Inc. with Pillon Architect and Global Architect for the intergenerational community hub project.
- 8. **March 12, 2015** at the Corporate Affairs, Strategic Planning, and Property Committee, the Board approved the construction of the joint venture facility with VCI on Lawrence Avenue West, which requires the demolition of the current Columbus Centre.
- 9. **May 14, 2015** at the Corporate Affairs, Strategic Planning, and Property Committee, the Board approved the acquisition of the 3.15 acre Sisters of the

Good Shepherd property, located at 25 Good Shepherd Court. The acquisition of this property was funded from Education Development Charges.

- 10. **June 8, 2015** at the Corporate Affairs, Strategic Planning, and Property Committee, the Board approved the acquisition of a 3.467 acre portion of 950 Lawrence Avenue West from VCI to accommodate the construction of a replacement facility for Dante Alighieri as part of a joint venture redevelopment with Villa Charities. The purchase price is entirely funded from Education Development Charges.
- 11. The two parties have jointly retained consultants to move forward with building the intergenerational community hub.
- 12. **December 2016 -** a Site Plan application for the joint facility was submitted to the City of Toronto, and in January 2017, applications for a zoning bylaw amendment and Plan of Subdivision were also submitted to seek development approvals for the project
- 13. **April 18, 2017** at the Open House held by the two parties, concerns regarding the project as submitted in the application were raised by members of the community.
- 14. **May 11, 2017** at the City Community Consultation meeting held at Yorkdale Secondary School, concerns regarding the project as submitted in the application were raised by members of the community.
- 15. **June 13, 2017** in response to concerns raised, North York Community Council directed the applicant to conduct extensive community consultation, including the formation of a working group composed of representatives from the Italian community, Columbus Centre and Health Club members, and parents from both Dante Alighieri Academy and Regina Mundi C.S. This direction was approved by City Council on July 4, 2017.
- 16. **August 1, 2017** Villa Charities and the TCDSB released a joint project update stating that, in response to the feedback received, the two parties would re-examine the current proposal in order to develop additional options for the new facility.

- 17. **September 7, 2017** at the Student Achievement and Well-Being, Catholic Education and Human Resources Committee, the Board approved the following recommendations:
  - That the Director of Education be authorized to enter into an Amending Agreement with Villa Charities Inc. to extend the due diligence date in the Agreement of Purchase and Sale between the two parties to January 31, 2018;
  - That the TCDSB and VCI engage in a meaningful and transparent community consultation process.
- 18. **October 24, 2017** –TCDSB and VCI jointly retained Maximum City/Dillon Consulting Limited as independent facilitators to develop and facilitate the community consultation process.
- 19. October 27, 2017 to January 25, 2018 the consultation process was initiated, facilitated and completed, engaging over 700 participants, and over 1000 total participants through a variety of methods.
- 20. **November 16, 2017** the Board approved a Motion regarding the Community Hub Partnership with Villa Charities, which resolved that:
  - ...upon completion of the public consultation by January 31, 2018, a report shall be delivered to a full meeting of the Board, within 30 days from that date, with a final recommendation that includes the framework for construction and anticipated timelines; and
  - ...should the outcome of the public consultation not document overwhelming support for the redevelopment of the Villa Charities site, the TCDSB will no longer pursue the partnership with Villa Charities Inc. and instead proceed with the building of Dante Alighieri Academy Catholic Secondary School on the property presently owned by the Board.
- 21. **January 15, 2018** at Sala Caboto, representatives from Maximum City/Dillon Limited and Research Etc. reviewed the methodologies used for the qualitative and quantitative analysis, and presented their respective draft reports at an open meeting attended by community members. Feedback provided during the session was intended to inform the final report.

22. **January 25, 2018** – at the Regular Board meeting, Maximum City/Dillon and Research Etc. presented the findings of the consultation process and telephone survey. All Trustees received copies of both reports. At this meeting, the Board adopted the following resolution:

In order to fulfil the motion of the Board passed on November 16, 2017 which committed the Board to consider the consultants' report on the public consultation and report back to the Board within 30 days;

The consultants' report was received on January 25, 2018 and the Board resolves that the Director deliver a report to the Board on February 22, 2018 on his assessment of the consultation report; and

The Board resolves that the Director of Education be authorized to enter into an amending agreement with Villa Charities Inc. extend the due diligence date

23. **February 14, 2018** – The TCDSB received a communication from the Minister of Education stating that due to the significant concerns regarding the potential demolition of the Columbus Centre and the ongoing divisions which still exist over the project, the Ministry of Education will not support a school project than allows for the demolition of the Columbus Centre. The letter is attached as *Appendix 'A'* to this report.

## D. EVIDENCE/RESEARCH/ANALYSIS

## Assessment of the support for the project:

In order to fully assess the level of support for the TCDSB-VCI Intergenerational Hub, a number of perspectives must be considered.

## Maximum City/Dillon Consultation process and report:

1. The qualitative community consultation program was launched in early November 2017, and was completed on January 25, 2018, when the results of the process and final report were presented and delivered to the Board.

Trustees received copies of the reports at the Board meeting of January 25, 2018. The report is available online, and can be downloaded using the following link:

https://columbusdantecommunity.com/wp-content/uploads/2018/01/1801-Columbus-Centre-Public.pdf

- 2. The consultation process consisted of engaging over 700 independent participants and over 1000 total participants through a variety of methods including:
  - Community workshops
  - Youth and senior outreach
  - Website and online survey
  - Telephone survey conducted by Research Etc.
  - Neighbourhood walks and site visits
  - Focus groups and facilitated discussions with various stakeholder groups
  - Observations and listening sessions, and a public report-back meeting.

## 3. The findings of this qualitative process highlight six key themes:

- i. The green, pedestrian, and open spaces of the Columbus Centre site play an important and varied role for a wide range of people, and are seen as a shared community asset which could be improved or expanded, but with no net natural loss.
- ii. There is place-based attachment to the current Columbus Centre, particularly to individuals of Italian heritage or association. There is a desire to honour, preserve, and celebrate the history and role of the Columbus Centre in the community and the role of the community in the Columbus Centre.
- iii. With respect to sharing spaces and partnerships, there is some confusion and concern as to how the new facility would be shared between Dante Alighieri students and Columbus Centre members, as well as desire to keep the two groups separate by not pursuing a joint facility. However, many comments expressed a desire for new and renewed partnerships between the two organizations, and a modern educational facility to serve future generations.
- iv. Many of the comments expressing frustration and opposition for the joint TCDSB/VCI project stem from concern over a lack of community involvement and voice in the proposed project from the beginning, as well as concerns over poor and incomplete communication. This has led to feelings of distrust, questions, and confusion over the project. There is also

opposition to the partnership between the TCDSB and VCI, as well as a fear of future redevelopment on the site.

- v. These comments also indicate a lack of understanding, trust, or clear information about the project, and concern that people are supporting, not supporting, or not participating in the project based on intimidation or inaccurate/complete information.
- vi. Many comments point to a built-up frustration and resentment regarding the project, and a desire to start over with better communication, transparency, community involvement/consultation, and clarity.
- 4. The recommendations in the Maximum City/Dillon report speak to the potential of the project moving forward productively in some way or form, while acknowledging that there is some opposition to this action within the community. The key recommendations are outlined below:
  - Rebuild trust with the community, which begins with an acknowledgement that there has been a breakage of trust, then seek out a process to regain accountability and trust with the community.
  - Establish a working group that is broadly representative of the community, and whose main role is to provide input on the project and liaise with the community.
  - Involve the community meaningfully and directly in the full cycle of the design process. This involves establishing feedback loops to share what is open to influence, inform the community how they will be consulted, and demonstrate how their input has been incorporated or considered.
  - Provide adequate time, space, and review periods for community consultation. Consultation and review should inform design and decisions, which should happen during and after the consultation, not before or separately.

### **Research Etc. Quantitative Telephone Survey:**

5. As part of the consultation process, Maximum City/Dillon retained Research Etc. to conduct a quantitative telephone survey to gauge awareness and opinions within the general public and local community for TCDSB/VCI

Intergenerational Community Hub, as well as to explore the opinions of users and non-users of the Columbus Centre.

The Research Etc. findings were included in the Maximum City/Dillon report distributed to Trustees at the January 25 Board meeting, and can be found in the same report referenced in comment #1 above.

6. The sample size of the survey was 400 participants from the general public living within five (5) kilometres of the Centre. Random digital dialling was used to select participants. 60% of the participants were 55 years of age or older; 23% of the participants were between the ages of 45 and 54; while 17% of the participants were under the age of 44.

The key findings of the telephone survey are summarized below:

- i. <u>General Public Opinion</u>: of the survey respondents, 55% support the proposed plan and 31% were neutral with respect to the project. Overall opposition is in the minority with 14%. Supporters appreciated the potential for classes, multi-generational experiences, new facilities for all, potential cost savings, and generally feel that it will be good for the community.
- ii. <u>More Immediate Community:</u> Response is more polarized among recent users of the Columbus Centre and among those living in closer to the facility. With respect to users of the Columbus Centre in the past 6 months, 49% support the plan, while 33% oppose it. Greater concern was expressed about how the redevelopment will take shape (what exactly is being built, how the shared facilities will work), as well as objections to the current Centre being torn down (sentiments of cultural significance and community attachment).
- iii. Questions and concerns were raised by survey respondents, regardless if they support the initiative or not, about the need for facility, issues with the current facilities, and how the facilities will be shared between students/seniors/broader community.

### **Other Indications of Support for the Joint Venture**

- 7. In addition to the formal consultation project and research conducted, there have been other opportunities to gauge support for the project outside of the recently completed consultation process, including:
  - i. **Open House April 18, 2017**: The Open House held at the Columbus Centre provided the opportunity for the public to learn more about the project, and review the proposed plans for the new facility. Generally, the reaction was positive, however concerns were raised regarding the absence of the swimming pool and running track in the design of the new Columbus Centre. In response to these comments, the building design was revised to include these amenities.
  - ii. **City of Toronto Public Consultation Meeting May 11, 2017**: This public meeting was held at Yorkdale Secondary School and was hosted by the City of Toronto's Planning Department. A large crowd attended the session in order to express their opposition to the project.
  - iii. **Delegations at TCDSB Board and Committee Meetings**: Delegations with respect to the project have been heard at several Board meetings. Essentially all the delegations expressed views in opposition to the proposed intergenerational hub.
  - iv. Meetings with Dante Alighieri/Regina Mundi Students, Staff, and Parents: Over the past several years, TCDSB staff have met with both school communities with respect to the project. Both Catholic School Parent Councils support the project. Further, those students who participated in consultation activities expressed excitement with respect to the initiative, while also demonstrating respect and empathy for other stakeholders, as well as open-mindedness towards compromise, change, and inclusivity.
  - v. **Coverage in the Italian Media:** The TCDSB/VCI project has received significant coverage in the Italian media. Virtually all of the coverage has highlighted the community and elected representatives' opposition to the proposed intergenerational community hub.
  - vi. **Provincial Government Involvement**: On June 15, 2017, in response to community concerns and opposition, MP Mike Colle sent a letter to

Minister of Education, Mitzie Hunter, requesting that the Minister intervene to have the current joint venture plans withdrawn immediately. On June 16, 2017, the Minister sent a communication to the Chair of the TCDSB requesting a pause in the project, and a meeting to discuss the concerns raised by the community and local politicians.

- vii. The Chair of the Board, the local Trustee and a VCI representative met with the Minister of Education in late June 2017 to discuss the community concerns with the current plan for the joint project. Arising from this discussion, the Minister requested that the two parties develop additional options in order to address these issues. It is important to note that while the TCDSB has received Section 196 approval for the joint project, it still requires Ministry approval to proceed with building the facility, which typically occurs after municipal approvals and tendering.
- viii. On February 14, 2018, the Board received a communication from the Ministry of Education stating that due to the significant concerns regarding the potential demolition of the Columbus Centre and the ongoing divisions which still exist over the project, the Ministry of Education will not support a school project that allows for the demolition of the Columbus Centre.

### **Assessment of Support**

8. The November 16, 2017 Board motion referenced *overwhelming support*. Based on the findings of the Maximum City/Dillon report, the Research Etc. report, and other opportunities outlined in comment #7 above, and staff's understanding of the term, **the level of support for the intergenerational community hub does not achieve that threshold**.

### **Benefits of the Intergenerational Community Hub**

- 9. Many Dante Alighieri students spend numerous hours volunteering in the senior residences on the VCI campus. The community hub will create an enhanced intergenerational learning environment benefitting both students and older adults.
- 10. The Schlegel-University of Waterloo Research Institute for the Aging identifies some of the key benefits of intergenerational programs. Benefits for students in intergenerational settings include:

- Gaining knowledge of the aging process and developing positive attitudes towards aging and older adults;
- Developing social skills and learning to cooperate with others;
- Gaining tolerance, patience and sensitivity as well as learning about empathy and how to respect others; and
- Experiencing emotional growth including becoming more self-confident and building self-esteem through learning new skills.

11.Intergenerational programming also has recognized benefits for senior citizens including, but not limited to:

- Reduced levels of loneliness, depression anxiety and agitation;
- Developing strong, meaningful relationships with youth, leading to an increased understanding and respect for youth;
- Developing a heightened sense of purpose and meaning; and
- Experiencing an increase in self-esteem and self-confidence, as well as a renewed sense of youthfulness.

12. Other benefits of the intergenerational community hub project include:

- Construction cost savings as a result of maximizing the amount of shared space, reducing the number of instructional spaces required;
- Avoidance of temporary relocation costs during the construction of the facility; and
- Student access to specialty instructional spaces and facilities not available in traditional secondary schools including a professional theatre, dance studios, fitness facility, and culinary arts space.

### **Impacts on Learning Environment for Regina Mundi Students**

- 13.A critical component of the intergenerational community hub project involved the relocation of Regina Mundi students to the current Dante Alighieri facility upon completion of the new secondary school facility. It is also important to note other significant issues with the facility:
  - The enrolment at Regina Mundi significantly exceeds the OTG capacity of 323 pupil places.
  - Based on the most recent assessment of the facility, the estimated Facility Condition Index (FCI) of the facility by 2021 is approximately 65%. The FCI rating is the ratio of a facility's renewal needs to its replacement cost, expressed as percentage.

- An FCI rating of 65% or greater indicates critical needs, and was previously defined by the Ministry of Education as prohibitive to repair. This means that renewal was not financially feasible, as the cost of repairs and renovations was too high in comparison to its replacement value.
- As such, the Board only completed minor renovations at Regina Mundi to accommodate the full day kindergarten program.
- Given the anticipated solution to move Regina Mundi CS into Dante Alighieri the TCDSB deliberately did not advocate for inclusion of Regina Mundi for Capital Priorities submission to the Ministry of Education for a new school facility.
- Had the intergenerational community hub not been conceptualized, then TCDSB would have made submissions to the Ministry of Education to secure funds for a new elementary school on Playfair Avenue.
- 14. The TCDSB has also received funding from the Ministry of Education to construct a new childcare in the proposed future Regina Mundi. The child care centre, which would be operated by VCI, is to be based on the Reggio Emilia model.

### **Preferred Option Prior to receipt of Letter from Minister of Education**

Maximum City/Dillon Report. This would mean starting the entire process over again.

Given the present reality of the Minister's message, staff cannot recommend this course of action.

### A. EXECUTIVE SUMMARY

The City of Toronto completed a review of its existing 44 ward boundaries in an effort to understand the number of people living in each boundary and how their populations are expected to change in the future.

Due to population growth, some of the existing City ward boundaries were 30% to 40% above the population of an average City ward. Therefore, not every Toronto citizen was being equally represented at City Council. This led to the creation of 47 new City wards.

The new 47 City wards were officially approved on December 31<sup>st</sup>, 2017 after appeals to the Ontario Municipal Board (OMB) were reviewed and dismissed. These new City wards will be the official electoral ridings for the upcoming Municipal elections and will be effective on December 1<sup>st</sup>, 2018.

TCDSB legal staff have advised that Trustee wards must be in complete alignment with the newly approved City ward boundaries.

This report provides a staff recommendation for the re-alignment of Trustee ward boundaries.

The cumulative staff time required to prepare this report was 349 hours.

### **B. PURPOSE**

To gain approval of the recommended changes to the TCDSB Trustee ward boundaries in order to align with the newly approved 47 City wards.

### C. BACKGROUND

1. **June 2013**—the current City ward boundaries were established in 2000 and are based on the Federal Electoral Districts that cover the City of Toronto. The City completed a preliminary review of its 44 ward boundaries to increase their understanding of the residents within each boundary and how their populations are expected to change in the future.

- 2. **March 2014 to July 2015**—the Consultant team ("TWBR") was selected by the City to undertake the research and development of City ward boundary options. The team consisted of members from the Canadian Urban Institute, Beate Bowron Etcetera, The Davidson Group, and Thomas Ostler. They gathered information on current ward characteristics and boundary options. Based on public input, expected population change and extensive background research, five (5) different ward boundary options were created:
  - 1) Option 1: "Minimal Change" 47 wards
  - 2) Option 2: "44 Wards" **44** realigned wards
  - 3) Option 3: "Small Wards" **58** wards
  - 4) Option 4: "Large Wards" **38** wards
  - 5) Option 5: "Natural/Physical Boundaries" **41** wards

Refer to the City's website: <u>http://www.drawthelines.ca</u> for more details.

- 3. **October 15<sup>th</sup>, 2015**—in a report to Corporate Services, Strategic Planning and Property Committee: "*City of Toronto Ward Boundary Review – Impact on TCDSB Trustee Boundaries*", staff advised the Board on the potential impacts to TCDSB Trustee ward boundaries based on the five (5) initial options put forward by the City's Consultant team as noted above.
- 4. **May 24<sup>th</sup>, 2016**—the Consultant team provided their final report to the City's Executive Committee. The report recommended a ward structure of 47 wards (Option 1: "Minimal Change") with an average population of approximately 61,000 people per City ward. This, in turn, will ensure effective representation given forecasted population growth in City of Toronto over the next fifteen (15) years.
- 5. August 25<sup>th</sup>, 2016—in a report to Board, staff provided a status update on the City of Toronto ward boundary review process. Staff also provided Trustees and members of the public with detailed information on how to get involved and provide feedback to the Consultant team.
- 6. **November 9<sup>th</sup>, 2016**—City Council considered a final report on the new ward boundary options and selected the 47-wards (Option 1: "Minimal Change").
- 7. **March 28-30<sup>th</sup>, 2017**—City Council enacted a By-law to revise the ward boundaries of the City. The By-law reflects the City Council decision thus ending any further debate on City ward boundary options.

- 8. **April 19<sup>th</sup>, 2017**—in an information report to Board: "*City of Toronto Ward Boundary Changes and its Impacts to Trustee Wards*", staff provided a preliminary proposal (staff Option 1) to align the Trustee ward boundaries to the new 47 City wards, with a primary focus on maintaining a balance of schools and enrolment per Trustee ward.
- 9. **May 14<sup>th</sup>, 2017**—six (6) appeals were submitted to the Ontario Municipal Board (OMB) concerning the City Council decision to adopt 47 City ward boundaries.
- 10. August 24<sup>th</sup>, 2017—in a report to Board: "*City of Toronto Ward Boundary Changes and Impacts to Trustee Ward Consultant Proposal*", staff recommended retaining the services of the Consultant team "TWBR" for its own Trustee ward boundary review. The Board, however, recommended that TCDSB staff conduct its own study and review.
- 11. **November 30<sup>th</sup>, 2017**—staff organized and led a Trustee ward boundary workshop, which provided three (3) staff options and one (1) sub-option to realign the Trustee wards to the newly approved 47 City wards. Staff were directed to continue to explore other possible options in a follow-up workshop.
- 12. **December 15<sup>th</sup>, 2017**—all six (6) OMB appeals were dismissed, with the exception of one (1) minor adjustment to a City ward boundary within the Thorncliffe Park neighbourhood.
- 13. **January 11<sup>th</sup>, 2018**—staff facilitated a second Trustee ward boundary workshop, where an additional option (staff Option 4) was created in response to the feedback received.
- 14. **April 1<sup>st</sup>, 2018**—the last day for Toronto school boards to provide the City Clerks office with Board approved re-aligned Trustee ward boundaries.

### D. EVIDENCE/RESEARCH/ANALYSIS

1. The process of re-aligning Trustee ward boundaries is governed by the Education Act (*Sec. 58.1*) and Ontario Regulation 412/00 *Elections to and Representation on District School Boards*.

- 2. The existing 44 City wards and the newly approved 47 City wards can be found in a map in *Appendix 'A'*. This map also demonstrates the misalignment between the newly approved 47 City wards and the current Trustee ward boundaries.
- 3. After consultation with TCDSB legal counsel, it was recommended that Trustee wards be created with a focus on equitable distribution of eligible Catholic Supporters. This is in accordance with the Education Act, using a calculation method known as the Electoral Quotient.

Electoral Quotient is simply the proportion of eligible Catholic supporters per Trustee ward. Below, is the calculation for Electoral Quotient:

Electoral Quotient = 
$$\frac{a \times b}{c}$$

**a**—is the number of eligible Catholic supporters within each Trustee ward

**b**—is the total number of Trustee wards

c—is the total number of eligible Catholic supporters in the City of Toronto

- 4. Staff re-aligned Trustee wards to the new 47 City wards with a goal of maintaining a fair and equitable balance of eligible Catholic supporters. *Appendix 'C'* provides maps and details of all staff options shared with Trustees to date.
- 5. **Option 1**—focuses primarily on balancing the distribution of schools and enrolment per Trustee ward. This option was dismissed during the first Trustee ward boundary workshop.
- 6. **Option 2**—provides for the <u>most optimal balance</u> of eligible Catholic supporters per Trustee ward and still demonstrates minimal changes to the current Trustee ward boundaries.
- 7. **Option 3a**—still provides for an acceptable balance of eligible Catholic supporters per Trustee ward and demonstrates <u>the least amount of changes</u> to current Trustee ward boundaries. However, there was a noticeable imbalance of eligible Catholic supporters between Trustee wards 9 and 10, which led to the creation of Option 3b.

- 8. **Option 3b**—maintains the original configuration of Option 3a but with an adjustment to the proposed boundaries for Trustee wards 9 and 10 to allow for a better balance of eligible Catholic supporters.
- 9. **Option 4**—was created following feedback received from Trustees during the first ward boundary workshop. The most noticeable change to this configuration is the transfer of City ward 31 to Trustee ward 7 and the transfer of City ward 19 back to Trustee ward 9.
- 10. After reviewing all options for re-alignment and incorporating feedback from Trustees, staff recommend Option 2, as provided in *Appendix 'B'*. Option 2 provides the most optimal balance of eligible Catholic supporters per Trustee ward, with minimal changes to the current Trustee ward boundaries. There will also be minimal changes for the parent and school communities in regards to current Trustee representation based on Option 2.





# Introduction

The information within this package was created to show the Board of Trustees preliminary options to re-align current Trustee ward boundaries to the new 47 City ward boundaries with a focus on maintaining the distribution of the Catholic population within the City using *Electoral Quotients*.

TCDSB Legal staff have confirmed that there must be 100% Trustee ward boundary alignment with City of Toronto ward boundaries. The process of realigned Trustee ward boundaries is governed by the *Education Act* (*Sec 58.1*) and *Ontario Regulation 412/00 Elections to and Representation on District School Boards*.

*Electoral Quotient* is the proportion of Eligible Catholic Supporters per Trustee ward in order to have a fair and equitable distribution of the Catholic population. This calculation derived from the Education Act.

# **Summary of Options**

#### **OPTION 1**

- Initially created to assess and balance the distribution of schools and enrolment between the Trustee wards.
- Option was brought to Board on April 19<sup>th</sup> 2017, and was not approved.

# The following options were created to maintain or improve the balance of eligible Catholic supporters within each proposed Trustee ward configuration:

### **OPTION 2**

- The most equitable balance of eligible Catholic supporters while trying to keep boundaries fairly close to the current Trustee ward arrangement.
- The most notable change is the transfer of City ward 31 to Trustee ward 11 and City ward 19 to Trustee ward 10.

### **OPTION 3A**

- Least amount of boundary changes based on the newly approved 47 City wards.
- There is a noted imbalance of eligible Catholic supporters in Trustee Wards 9 and 10.

#### **OPTION 3B**

- Maintains the original boundaries of Option 3a, with the exception of Trustee ward 9 and 10.
- Provides an improved balance of eligible Catholic Supporters.

#### **OPTION 4**

- Created in response to the concerns brought forward by Trustee Davis and Trustee Del Grande after the November 30<sup>th</sup>, 2017 Workshop.
- This option changes the boundaries of Ward 7, 9, 10 and 11 while maintaining the original configuration of Option 3a.

### **APPENDIX** A

#### **Revised Terms of Reference for the**

#### Executive Compensation Adhoc Committee of the Toronto Catholic District School Board

The Executive Compensation Adhoc Committee of the Board of Trustees of the Toronto Catholic District School Board ("the Committee") shall have the responsibilities, authority and duties described below:

- 1. The Committee reports to the Board of Trustees;
- 2. Following the approval of the Board of Trustees, the Committee shall have the authority to engage counsel and other advisors to assist and support the Committee, acting reasonably, as it determines necessary, to carry out its duties. This may include contracting with a compensation consulting firm, such as Mercer;
- 3. The Committee shall assist the Board of Trustees in fulfilling its oversight responsibilities in compliance with the *Broader Public Sector Executive Compensation Act 2014*, (the "BPSECA"), the BPSECA Program Directive, the BPSECA Guide, and all other relevant legislation and directives;
- 4. The membership of the Committee is determined at the annual Caucus meeting of the Board of Trustees, as follows:
- a. Voting members: no more than four Trustees, plus ex officios, the Chair and Vice Chair of the Board; and
- b. Staff support and non-voting members: Director and the Superintendent of Human Resources.
- 5. The Committee shall be responsible for making recommendations to the Board of Trustees with respect to the following:
- a. Develop a comprehensive statement of compensation philosophy, strategy and principles. The compensation philosophy shall reward the achievement of performance objectives that align with the TCDSB's Multi-Year Strategic Plan;

- b. Research and study best practices in executive compensation and performance-related incentive compensation in the broader public sector;
- **c**. Consult with other school boards that may be interested in exploring performance-related incentive compensation;
- d. Support the Chair of the Board of Trustees in requests to the Minister of Education and/or the President of the Treasury Board, as applicable, in regard to executive compensation and performance-related incentive compensation. This may include requests for funds to obtain external expert compensation advice;
- e. In consultation with the Director of Education, make recommendations regarding the targets for the performance-related incentive compensation plan, to be administered by the Board;
- f. Assess annually the performance-related incentive compensation plan approved by the Board, and make recommendations regarding the performance-related incentive compensation to be paid to designated executives;
- g. Review reports from the Director of Education regarding the performance and evaluation for other designated executives;
- h. Review contracts of designated executives;
- i. Where appropriate, make recommendations to the Board of Trustees regarding executive compensation policies;
- j. Review and monitor the compensation of designated executives and recommend changes, where appropriate, to the Board of Trustees; and
- 6. The Committee shall consider such other matters as may be requested by the Board of Trustees.

### A. EXECUTIVE SUMMARY

The school year calendar is prepared and submitted annually to the Ministry of Education, in accordance with the Education Act and Ont. Regulation 304, School Year Calendar, Professional Activity Days. The 2018-2019 school year calendar must be submitted to the MOE by May 1, 2018. This report recommends that trustees adopt the attached school year calendar (Appendix A) for the 2018-2019 school year and that this information be communicated as outlined in Section D of this report. The calendar aligns with that of the Toronto District School Board, in order to minimize additional transportation costs.

Secondary schools, in consultation with their Local School Staffing Advisory Committee (LSSAC), may schedule a Professional Activity Day to align with the day following one of the Parent-Teacher Interview nights.

#### The cumulative staff time required to prepare this report was 20 hours.

### **B. PURPOSE**

- 1. To provide information on what governs the development of the school year calendar.
- 2. To outline a communication plan that encompasses the TCDSB community.
- 3. To present the 2018-2019 school year calendar as agreed to, through a consensus process, by the Academic/Business Advisory Committee (AcBac) members.

### C. BACKGROUND

- 1. Annually the Board establishes the school year calendar in accordance with the Education Act and Ont. Regulation 304.
- 2. The TCDSB must approve a school year calendar that includes a minimum of 194 school days, of which no more than seven (7) will be professional activity (PA) days and at least 187 will be instructional days. Three of the seven PA Days must be devoted to provincial education priorities as set out by the Ministry of Education.
- 3. In the 2018-2019 school year, there are a possible 194 instructional days from September 4, 2018 to June 28, 2019. The requirement of 194 instructional

days would be achieved if the first school day is Tuesday, September 4, 2018 and the last school day is Friday, June 28, 2019.

### **D.** EVIDENCE/RESEARCH/ANALYSIS

#### **Elementary Schools:**

- 1. For the purposes of the 2018-2019 school year calendar, please note the following for **elementary schools**:
  - Two PA days are to be used for parent-teacher conferences.
  - Two PA days are to be used for assessment and completion of report cards.
  - Three PA days are to be used for Provincial Education Priorities of which one half day will be devoted to Faith Development.

#### Secondary Schools:

- 2. For the purposes of the 2018-2019 school year calendar, please note the following for **secondary schools**:
  - Three PA days devoted to Provincial Education Priorities and supporting Article 19 of the Collective Agreement.
  - One PA day devoted to Faith Development.
  - One PA day devoted to numeracy across the curriculum.
  - The remaining two PA days will be devoted to system priorities, annual learning plans and local goals articulated in the School Learning Improvement Plan.
- 3. The remaining school days shall be instructional days.

Each school year calendar must be accompanied by a general outline of the activities to be conducted on PA days, as per Ministry Policy/Program Memorandum 151, "*Professional Activity Days Devoted to Provincial Education Priorities*" (PPM151).

4. The selection of the PA days for 2018-2019 school year has been in consultation with our Academic/Business Advisory Committee (AcBac) Committee members.

- 5. The AcBac Committee consists of members of Senior Staff and representatives from each federation, association and various board departments (including Transportation, Communications and Human Resources)
- 6. We have aligned our PA days with the TDSB to minimize any additional transportation costs.
