- Locking in 100% of the Board's Gas Transportation requirement for the period September 1, 2015 to August 31, 2016 at an average price not to exceed \$2.25/GJ.
- 2. The report further recommends setting the Gas Budget for fiscal year 2015-2016 at \$4,941,254
