Dear Sirs.

I am writing as a former student, current parent and long time supporter of the Toronto Catholic District School Board (TCDSB). I just learned that TCDSB Trustees and Superintendents are considering eliminating the existing International Languages Program and are planning to hold a meeting next week to decide the future of the program. As I am unable to attend this meeting, I have a number of concerns that I would like to raise with respect to this issue.

Firstly, as a matter of administrative fairness you have failed to provide the parent community with a reasonable opportunity to participate in this process. There has been a lack of transparency and appropriate notice provided to us with respect to this entire issue. The fact that you are considering dealing with the future of this program in the middle of the Summer when many impacted families may not be available is outrageous and speaks volume to how little you regard the input of the parent community and the very taxpayers that continue to fund and support the TCDSB. Query how this process is consistent with the TCDSB's own strategic plan which provides that the board will "ensure accountability, fairness, and transparency to the public in all processes and policies" and "ensure timely and sensitive responses to stakeholder questions and concerns". I am confident that I am not the only stakeholder that has raised this concern with you.

Secondly, the suggestion that Administrators cannot fit 30 minutes of learning another language in the current school day lacks credibility given the long-standing history of this program in the current curriculum. More importantly this suggestion fails to appropriately account for the benefits students gain of learning a foreign language in a city like Toronto that prides itself on its multiculturalism and diversity.

Finally, the International Languages Program has been, in my view, one of the most distinguishing features of the TCDSB's educational offering (in addition to Catholic Teachings) compared to the public school board. As Professor Jim Cummins (one of the world's leading authorities on second language acquisition)

astutely noted "schools that succeed in bringing issues related to cultural and linguistic diversity from the periphery to the center of their mission are much more likely to prepare pupils to thrive in the interdependent global society within which they will live. These schools will communicate to pupils and communities that their access to more than one culture and language is a resource that can enrich the entire school". I would strongly encourage the TCDSB not to stray from this fundamental principle which has also helped to distinguish the value of your board more generally.

Dear Trustees, Director of Education, Associate Director of Academic Affairs, Superintendent of Human Resources,

I have been an Italian instructor in the International Language Program with the TCDSB for 14 years. I write to you today concerned about the possibility of the program's removal from **regular** school hours and urge you to vote against this choice.

The ILP has existed since 1977 and achieved great scholastic success in the Toronto Catholic District School Board. It has been a great benefit to students and communities in Toronto, and a point of pride for them to express their heritage and enjoy a greater breadth of learning in our schools.

Despite this, the program has always been attacked and threatened with reduction and closure, and its passionate, hard-working instructors have made many concessions over the years to continue their work. It troubles me that even today, in 2018, we are having the same discussions whose objective is simply, and seems always to have been, to close the program.

Recently, to satisfy the interests of other groups and without regard to the students themselves, the Board decided to shorten the school day at the expense of the ILP, who once again accepted their conditions. Now, with the most recent decisions, some have suggested to parents that there won't be enough time to deliver the curriculum, and that the only solution is to move the ILP after school or cancel it. According to them, the subjects we teach – which foster creativity, flexibility of thought, deep linguistic understanding, and cultural perspective – are not as important as subjects like math or science. Who can make such a claim? Who decides the worth of our culture in Canada, and of the breadth of knowledge we have worked so hard to cultivate in our schools?

Countless studies demonstrate that learning a third language has vast benefits for childhood development. Students exposed to a third language demonstrate greater critical thinking abilities, creative skills and open-mindedness. That is to say nothing of the fact that we live in the most multicultural country, with arguably the richest variety of traditions, foods, clothes, languages and ethnic values, in the world. How can we be proud of this fact if we decide to make cultural education an afterthought for our children?

Students of diverse cultures live, accept, respect and work with their neighbours on the basis of what they are exposed to and taught at an early age. The first act of multiculturalism is precisely the recognition of and exposure to a language. Without upholding this in our schools, we not only deprive students of the unique advantages and perspectives we have ourselves enjoyed and cultivated, we lose a cornerstone of our identity as Canadian educators. And in this globalized world, where language and cultural understanding plays a fundamental role in the harmony and well-being of neighbours, the timing of such a decision seems particularly worrisome.

I trust in the foresight of the trustees to put student's needs first and retain the ILP within regular school hours.

The staff and school community at my school has been so great, so this new conversation that has come about is shocking to me.

I cannot believe that the CATHOLIC board would allow instructors to be dismissed, especially with such short notice. We were negotiating for the program to be delivered in various ways, yet this was conveniently completed on the last week of school and into the summer. I have kids of my own and a husband that I also think about when I go to work everyday so that I can put food on the table and have a roof over our heads. I am in dismay and question what the Catholic board and Catholic church have to say about this conversation and how they plan on telling the students about the reasoning behind eliminating the program. I question if the students feel like they are being abandoned or if all of their hard and meaningful work did not matter.

I hope that you have read my letter and recognize the love, time and hard work that I bring to each of my students at the Toronto Catholic District School Board. I hope to see them again in September to continue to educate them on the Italian heritage and language.

Dear Trustees,

I am writing to express my concern over the suggestion to remove the Integrated Day International Language Program (ILP) within the Toronto Catholic District School board and I am appealing for your support to continue with an Integrated Day model.

Given the high percentage of families that rely on bussing services, moving the program to either before or after school will have the effect of ultimately cancelling the program altogether. In addition, on the TCDSB's very own brochure explaining the Integrated Day International Languages Program, it says:

"The International Languages Program is provided during the school day when at least 67% of the parents of a school request a language program to be established during the school day".

What gives anyone the right to revoke the program from the established curriculum, without the same consult of the parents where such programs have already been established? How can you allow a union to effectively dictate the curriculum at our schools, which in principle is what will happen if the integrated day model is abolished? And how can you also allow such an unfair process which lacks transparency, and with critical decisions being made on short notice in the middle of the summer?

You as our elected officials hold the balance of power not to exacerbate an already damaging impact on our children's education as a result of the reduced number of instructional time negotiated with the union. To abandon the Integrated Day ILP is to take that one step further, and also has the effect of turning your backs on one of the core principles our country champions - that is to celebrate the ethnicity, diversity and inclusion of its people.

On a more personal note, the Integrated Day ILP at Josyf Cardinal Slipyj school was the key deciding factor why I chose to send my child here. I am also proud to say that my mother was on the founding committee that established Josyf Cardinal Slipyj school, on the back of an identified need to form a third Catholic School enriched by Eastern Rite traditions. I would like to express my concern about the "recent change to the Delivery model of the International Language program (IL)" which is going to remove from the TCDSB from the curriculum next school year; with the purpose of shortening the student's school day by half hour.

This is not a step forward for our students, on the contrary this action will be detrimental for all our students and will not reflect their best interests.

Additionally; the students are the ones who will suffer when issues of contracts and unions are disputed.

It is unclear as to what was the process for such drastic change to be considered for the future. All we want at this meeting is respect, the respect we want is that our voice is going to be heard regarding this issue.

It is very concerning that this letter from Rory was sent to the parents on June 28th, 2018; as it had been redacted on March 29th, 2018. Dear Sirs,

I am writing as a former student, current parent and long time supporter of the Toronto Catholic District School Board (TCDSB). I just learned that TCDSB Trustees and Superintendents are considering eliminating the existing International Languages Program and are planning to hold a meeting next week to decide the future of the program. As I am unable to attend this meeting, I have a number of concerns that I would like to raise with respect to this issue.

Firstly, as a matter of administrative fairness you have failed to provide the parent community with a reasonable opportunity to participate in this process. There has been a lack of transparency and appropriate notice provided to us with respect to this entire issue. The fact that you are considering dealing with the future of this program in the middle of the Summer when many impacted families may not be available is outrageous and speaks volume to how little you regard the input of the parent community and the very taxpayers that continue to fund and support the TCDSB. Query how this process is consistent with the TCDSB's own strategic plan which provides that the board will "ensure accountability, fairness, and transparency to the public in all processes and policies" and "ensure timely and sensitive responses to stakeholder questions and concerns". I am confident that I am not the only stakeholder that has raised this concern with you.

Secondly, the suggestion that Administrators cannot fit 30 minutes of learning another language in the current school day lacks credibility given the long-standing history of this program in the current curriculum. More importantly this suggestion fails to appropriately account for the benefits students gain of learning a foreign language in a city like Toronto that prides itself on its multiculturalism and diversity.

Finally, the International Languages Program has been, in my view, one of the most distinguishing features of the TCDSB's educational offering (in addition to Catholic Teachings) compared to the public school board. As Professor Jim Cummins (one of the world's leading authorities on second language acquisition)

astutely noted "schools that succeed in bringing issues related to cultural and linguistic diversity from the periphery to the center of their mission are much more likely to prepare pupils to thrive in the interdependent global society within which they will live. These schools will communicate to pupils and communities that their access to more than one culture and language is a resource that can enrich the entire school". I would strongly encourage the TCDSB not to stray from this fundamental principle which has also helped to distinguish the value of your board more generally.

One of the selling points of our house was its proximity to JCS; it was (and is) important for our family that their children attend not just a school, but a community. Schools are more than academics, they are a social place, a second home. And, as a graduate of Josyf Cardinal Slipyj, I must be frank that I didn't appreciate the Ukrainian program as a kid. However, growing up has made me realize the importance and benefits of my Ukrainian classes. It fostered my language skills, gave me a sense of community, and recognized my identity as part Ukrainian-Canadian.

No one would question learning French in schools. One would be baffled by protesting English classes. I think the same mentality should be applied to this program, as Canada is truly a melting pot of nations. English and French are necessary, but that is not all that defines us. We are a wide range of communities that must be represented.

Further still, research¹ has shown that learning a new language further develops the brain. This is especially significant for early stages in life, as children's brains develop rapidly. I am a Parent Volunteer and former Vice-Chair at St. Wilfrid School. I am writing this in regards to the TCDSB's recent decision to shorten the school day by 30 minutes beginning in September 2018, while maintaining 120 minutes per week of International Language instruction.

My first question is: Why were parents not consulted regarding the possible changes? We should be asked for our input when the board is planning to make any major decisions regarding our children's education! A survey conducted 3 years ago does not reflect the current situation in our schools, especially now with the announcement of the shortened school day.

My second question is: Why are we reducing English instruction time by 120 minutes per week while maintaining an International Language that represents the culture of such a small percentage of our schools' population. I understand the need to shorten the school day, however, our city has a large population of immigrant families, from many different countries, who need to focus on learning English and French! Why are we so concerned in keeping instruction of a third language when they are struggling in reading and writing the two most important ones? If the Board is so concerned with having students learn a third language to "thrive in today's interdependent global society", why are they not being taught Mandarin or Spanish – 2 of the most spoken languages in the world? The students at St. Wilfrid are learning Italian, however, they will most likely only find it useful if they ever travel to Italy! Is that the best use of that 120 minutes per week? To learn a language they will most likely never use? In addition, our EQAO scores show that our students need more help in English and Math. How will reducing English instructional time assist with that? The schools that offer IL will suffer with even lower scores going forward.

I attended St. Wilfrid School in the 1980's. In grade 7, several of my grade 7 classmates and I asked our parents to write a letter to the school to allow us to opt out of our International Language because we felt we could better use our time focussing on our other school work. For that period, we would gather in another classroom and use that time to work on our homework. If we continue with a shortened schedule, I will choose to exclude my son from IL class in the coming school year so he can work on his homework instead. I understand that the Board offers a variety of International Languages classes on Saturday. Those parents that wish for their children to learn a third language have the option of doing so by taking Saturday classes, without it affecting the rest of the children that need more

time for other core subjects. We cannot shorten the students' day and expect better results from them. We should be making decisions that provide students with the best chance for success. I feel that the decision to shorten the school day while maintaining 120 minutes of IL instruction does not provide them with that. It is only going to create more of a struggle for them in all other areas of study.

I am very disappointed in the decision the Board has made and also the manner in which it did so. We, as parents, act as the union representing our children. Our voice should have been represented at these negotiations. However, it was not, and as a result the adults will win and our children will lose.

I would like to recommend that the Board remove International Language Instruction, or, at the very least, conduct a new survey with parents regarding IL instruction at our schools and the impact of the shortened school day on English Instruction time, with concerned parents also having input in the creation of the survey. We should be allowed input in any major decisions that will affect our childrens' education. I trust that the TCDSB will put the education of our children first.

Dear Board of trustees:

I am a concerned Catholic Peruvian-Canadian, who came to this country at a very young age; former TCDSB student, now father of two young children 1 and 3; I want them to attend a Catholic School in Toronto, with the hopes that they can learn Spanish at school.

A letter that was sent to parents at the end of school year, from Rory McGuckin, regarding the future of the International language program, has raised many troublesome questions regarding the heritage, cultural values and safeguarding what is dear to me, personally.

My parents brought my brothers and me to Toronto in the year 2000. I am the eldest of four brothers. I was 16, and my brothers were 12, 6 and 1. We spoke Spanish in Peru, and we spoke Spanish at home. It was very important for my parents to keep a safe cultural background. To know where you come from and to know who you are, are ideals that my parents inculcated on us from a very young age.

One of the most important tool my parents had to offer was their language. My brothers and I were fortunate be enrolled in the international languages program offered by the Catholic district school board at the time.

The formal instruction at an institution complemented the spoken Spanish we used at home, and gave us the tools to properly speak, write and read our native language. It gave us a sense of security and belonging. I know that I am from Peru, and this is my native language. Now I am here in Canada, and I have to learn a new language, English.

Many times, immigrant children lose their identities, they stop speaking their native languages, and confused children raise questions and need guidance. Many times, immigrant children do not succeed under these circumstances. Parents trying to make ends meet, working long hours, new place to live, etc.

The instruction of International Languages helps children grasp a sense of identity in these difficult years transitional of their lives; and prevent them from using other distractions such as gangs and drugs.

My working hours do not allow me to attend. I am asking a Community Representative from the Board to please show this letter to the Board of trustees and to Rory McGuckin, Director of Education; tomorrow July 12th at the Special Board Meeting at the Catholic Education Centre, at 80 Sheppard Ave East; and ask him and the Board, to please reconsider their decision on trying to eliminate the International Languages day program.



We are writing today regarding Arbitrator Goodfellow's decision dated July 6, 2018 involving Ontario English Catholic Teachers' Association and Toronto Catholic District School Board.

This decision has serious implications for the members of the Canadian Union of Public Employees (CUPE) Local 3155 members. The implications of this award will inevitably be a breach of Letter of Understanding #3 (job security) in the Central Agreement between CUPE, the Council of Trustees Association and the Crown.

The parties' decision to proceed to arbitration without giving notice to CUPE results in a denial of procedural fairness and natural justice. CUPE should have been given notice so that it could have intervened in the proceedings and given evidence of the deleterious effects that this case will have on its members.

We ask the Toronto Catholic District School Board and Ontario English Catholic Teachers' Association to advise the Arbitrator that CUPE is adversely impacted by his decision, that we were not given notice of the hearing and that the case must be reopened so that CUPE may be heard and our members represented.

If you are unable to agree to the foregoing CUPE will explore alternative options including a judicial review of arbitrator Goodfellow's July 6, 2018 decision.

Dear Board of trustees:

I am a concerned Catholic Peruvian-Canadian, who came to this country at a very young age; former TCDSB student, now father of two young children 1 and 3; I want them to attend a Catholic School in Toronto, with the hopes that they can learn Spanish at school.

A letter that was sent to parents at the end of school year, from Rory McGuckin, regarding the future of the International language program, has raised many troublesome questions regarding the heritage, cultural values and safeguarding what is dear to me, personally.

My parents brought my brothers and me to Toronto in the year 2000. I am the eldest of four brothers. I was 16, and my brothers were 12, 6 and 1. We spoke Spanish in Peru, and we spoke Spanish at home. It was very important for my parents to keep a safe cultural background. To know where you come from and to know who you are, are ideals that my parents inculcated on us from a very young age.

One of the most important tool my parents had to offer was their language. My brothers and I were fortunate be enrolled in the international languages program offered by the Catholic district school board at the time.

The formal instruction at an institution complemented the spoken Spanish we used at home, and gave us the tools to properly speak, write and read our native language. It gave us a sense of security and belonging. I know that I am from Peru, and this is my native language. Now I am here in Canada, and I have to learn a new language, English.

Many times, immigrant children lose their identities, they stop speaking their native languages, and confused children raise questions and need guidance. Many times, immigrant children do not succeed under these circumstances. Parents trying to make ends meet, working long hours, new place to live, etc.

The instruction of International Languages helps children grasp a sense of identity in these difficult years transitional of their lives; and prevent them from using other distractions such as gangs and drugs.

My working hours do not allow me to attend. I am asking a Community Representative from the Board to please show this letter to the Board of trustees and to Rory McGuckin, Director of Education; tomorrow July 12th at the Special Board Meeting at the Catholic Education Centre, at 80 Sheppard Ave East; and ask him and the Board, to please reconsider their decision on trying to eliminate the International Languages day program.

We are thinking of sending another but will likely be saying something similar, as we are not 100% sure exactly what part(s) of the policy will be discussed tomorrow. We were hoping we might be able to get some insight into this, or if anything came back from the legal department.

We also wanted to ask if you had any thoughts on how we might be able to poll our parents/take a vote on whether to request a formal review of the IL program at our school, given that the summer is about to start. We had a few ideas but aren't sure if they would be acceptable as proper procedure by the Board.

My name is Helen Dunn and I am the Co-chair of the St. Brigid CSPC. We are here today regarding the recent decision by the School Board to incorporate the Italian Heritage language instruction at St. Brigid into the standard school day instruction time. At our CSPC meeting this past Monday, as well as through email, we have heard concerns from many parents about these upcoming changes. Specifically, concerns largely surround the loss of 2 hours PER WEEK of instructional time to cover the Ministry mandated curriculum. This means that our kids will have to learn the same Ministry mandated curriculum in almost 80 fewer hours per year (8% less) than at other schools in the TCDSB. This was NOT clearly stated in the letter issued by the Board on May 31, and many parents missed this on their first read of the letter.

While an informal school-wide survey conducted by our CSPC last year suggested that the overall feeling about the Italian program is positive in a longer day scenario, over 90% of those who have commented recently have indicated that it is not worth sacrificing 2 hours of our childrens' core instructional time in order to incorporate Italian into a shortened day. Many of these parents feel that the loss of core hours could have long term detrimental effects on all of our students, from the children entering our newly formed French Immersion program to grade 8s preparing for high school.

The feeling at our recent CSPC meeting was that in all of the contract and money talks, the Board had set aside the educational needs of our children. The Board decision appears to be hasty and without consultation of families and other key stakeholders. We are submitting excerpts from several of the 27 emails we have received in just over a 24 hour period, including the two we received in support of maintaining Italian during the school day, in a document for your reference.

Due to the very late notice of these changes (May 31, 2018), we have not had adequate time to conduct a full school poll to get a clearer idea of the true balance of opinions on this subject. However, we HAVE voted to go forward to the next step towards a potential Board review of our Italian program, which is to hold a meeting specifically about the program. Should the outcome of that meeting be that our school would like a review, we would like assurance from the Board that this will be expedited. IN the meantime, we would also like to know how the Board will ensure that students at our school and others like ours will be provided with the same level of curriculum coverage in 2 hours LESS regular instructional time per week (up to 80 hours per year). Further, we would like the Board to consider and consult parents on possible interim solutions for the loss of 2 hours of regular instructional time per week in the 2018-2019 school year, should the review not be possible before the start of September.
