A. EXECUTIVE SUMMARY

This report recommends that the following revised Capital projects submitted to the Ministry of Education on July 15, 2015 for funding consideration be approved:

It is expected that there will be a Capital funding announcement from the Ministry of Education in the Fall of 2015 (perhaps by mid to late October).

Additional opportunities to submit Capital Priorities funding requests are expected to occur in the Spring and Fall of each year. Capital Projects linked to Facility Consolidations may be submitted in the Fall, and projects linked to Facility Consolidations, Accommodation Pressure, or Facility Condition may be submitted in the Spring of each year for funding consideration. Any Capital Projects linked to a School Accommodation Review must have a final Trustee decision on the outcome of the Review before submission.

B. BACKGROUND

- 1. On May 26, 2015 the Ministry of Education issued *Memorandum 2015:B12:* Request for 2015 Capital Priorities Business Cases.
- 2. On June 8, 2015, Corporate Affairs, Strategic Planning and Property Committee approved the report *Capital Priorities 2015-2016* (See *Appendix "A"*). This report approved that the following Capital projects be submitted to the Ministry of Education by July 15, 2015:

- 3. On May 26, 2015 Ministry Memorandum 2015:B11: Capital Funding for New Construction of Child Care announced a new investment of \$120M over three years to support the construction of new child care spaces for children 0 to 3.8 years of age in new and expanded schools beginning this school year. School boards and their local CMSMs (Consolidated Municipal Service Managers) are expected to work together to identify the need for dedicated child care space in eligible schools. In the City of Toronto, Toronto Children's Services will consider projects against area demand and long-term viability.
- **4.** Toronto Children's Services subsequently identified need for child care as follows:

- 5. Due to site constraints and building issues, the Board approved Capital project requests were revised from "Addition" to "Replacement School":

 - b) Bishop Allen

6. In summary, the following revised Capital projects were submitted to the Ministry of Education on July 15, 2015 for funding consideration, and incorporate the changes resulting from Comment 4 and 5:

- 7. These changes will be reflected in the updated TCDSB Capital Plan.
- 8. Board staff met with Ministry of Education staff on September 9, 2015 to review the TCDSB Capital Priorities. Ministry staff expect that there will be a Capital funding announcement from the Ministry of Education in mid to late October 2015.
- 9. Additional opportunities to submit Capital Priorities funding requests are expected to occur in the Spring and Fall of each year. Capital Projects linked to Facility Consolidations may be submitted in the Fall, and projects linked to Facility Consolidations, Accommodation Pressure, or Facility Condition may be submitted in the Spring of each year for funding consideration. Any Capital Projects linked to a School Accommodation

Review must have a final Trustee decision on the outcome of the Review before submission.
