WHEREAS: The principles advocated by Meagan Bebenek Foundation align closely with the values and objectives of the TCDSB.

THEREFORE, BE IT RESOLVED THAT: The TCDSB hereby establishes an Annual School HUG Day every Friday before Mother's Day beginning May 2025 and every year thereafter, in recognition of the Meagan Bebenek Foundation and the principles it instills as part of the Kids Helping Kids Program;

THEREFORE, BE IT RESOLVED THAT: The TCDSB invite all pastors and associated pastors of schools associated with any of our elementary and secondary schools to an Open House and Curriculum Night at least once a year to familiarize them with their Trustees and the operations of the Catholic Education Centre (CEC) to provide a welcoming environment and sense of engagement to facilitate a greater commitment on the part of both Parish and School to fostering the school/parish/parent triad which is at the heart of our mission as Catholic Educators easily accessible to all parents and community members in a format similar to the Board's.
