### **Brandi Ward's Delegation Speech**

**SLIDE 1** My name is Brandi Ward. I am a parent at St. Leo and a member of the St. Leo SARC committee.

Firstly, I would like to begin by thanking the entire SARC committee and the Facilities and Planning Department staff for putting forth the recommendation that St. Leo needs a new school. We have a very **SLIDE 2** compelling business case, as St. Leo meets **all** the funding criteria laid out by the Ministry. High FCI, Increased enrollment, consolidation, land share opportunity adjacent to the school and the opportunity for a community hub.

**SLIDE 3** With respect to our high FCI consider the following:

St. Leo was built in 1926. We are currently operating in the original building which is 90 years old. We have an FCI of 47.9 and there is a whopping \$6,816,000 in deferred maintenance. These renewal statistics are from 2011 and our maintenance issues have only grown since then. As Maia Puccetti can attest to, St. Leo is a sinking ship.

**SLIDE 4** I would like to give you a very quick snap shot of the scope of work that needs to be done. Our foundation is failing and the replacement of the exterior walls have been quoted to cost just shy of 1 million dollars. This is just one example of the 30 highlighted items you will see on the slide posted that exceed \$100,000 dollars and an additional 10 that exceed \$200,000, many of which are considered urgent and critical.

**SLIDE 5** As you can see from these photos, we have water in the basement after it rains or when snow melts. **SLIDE** 6 The foundation is literally crumbling. There is a stairwell that our principal, Lillian Ugrin, does not allow students and staff to access for safety reasons. **SLIDE 7** The schoolyard pavement is buckling and poses an ongoing safety hazard. The list of health and safely concerns at St. Leo are extensive. **SLIDE 8** I think it is important to note that should St. Leo be awarded Ministry funds through this process, it would free up nearly 7 million dollars in repairs that could be spent elsewhere in the board. I repeat, that is 7 Million dollars that could be much better spent else where on things such as programming.

You have heard us delegate to the board numerous times over the last two years on the state of our facility. Perhaps the most disheartening reality of this is that we continue to lose Catholic families to the TDSB because of the state of our facility. These are Catholic families that opt to send their children to John English Public School despite the fact that it is busting at the seams with over 800 students. A new facility will win back these Catholic families. This is just one of the multiple strategies already in place for boosting enrollment at St. Leo which leads us into the next criteria, increased enrollment. **SLIDE 9** 

Thanks to our successful Early French Immersion Program, the ever-increasing population base of Mimico, including three new developments within a five block radius of the school, and the staff recommended consolidation plan, St. Leo's new building will also be at capacity. We know that the capacity of a school is directly proportionate to the attention that the board pays to a school. We've seen this pattern over and over throughout the city. Additionally, in the case of St. Leo, we will not simply be shuffling the population from one school to another but will actually be winning back per capita funding from the TDSB. **SLIDE 10** 

### On the topic of consolidation:

Let me be very clear when I say that St. Leo's fully supports the staff recommendation for consolidation. This move itself will generate increased enrollment at St. Leo.

SLIDE 11 With respect to the land share opportunity, as I'm sure you are aware, the TCDSB has been in discussions with St. Leo's Parish priest and the Archdiocese about a very exciting prospect. A section of parish land has been offered to the TCDSB in exchange for the use of our future gymnasium, which would double as a parish hall and a community gathering space. The use of this land would allow for a much larger footprint for our new school. As well, this shared center concept exemplifies one of the foundations of Catholic education to uphold the HOME-SCHOOL-PARISH-COMMUNITY connection. SLIDE 12

### Community Hub

I've yet to expand on the fifth criteria that the ministry looks favorably on, that of a community hub. Michelle Nolden will elaborate on this key criteria in the following delegation.

**SLIDE 13** The focus of this petition for ministry funding should not be on capacity issues alone. We've discovered that these are valid concerns for all of the schools in south Etobicoke. What separates the need at St. Leo is **the immediate concern over health and safely issues that simply cannot be overlooked any longer. The dire state of St. Leo and the necessity for a new school must be made a top priority by the board.** 

**SLIDE 14** To reiterate, Ministry funding for a new school at St. Leo will save the board 7 million dollars in repairs and will increase per capita funding. For this reason, combined with the fact that St. Leo meets all the criteria for ministry funding, makes St. Leo's is a slam dunk business case.

Thank you once again for recognizing that St. Leo needs a new school.

### Michelle Nolden's Delegation Speech

I would like to reiterate what Brandi has said and thank the SARC and Facilities and Planning Department Staff for recognizing that St. Leo needs a new school. In true St. Leo style we are not here tell you that it is your responsibility to provide our students with a safe and healthy environment. You already know that and the recommendation supports that a new school for St. Leo is CRITICAL . **SLIDE 15** 

We ARE here to tell you what we are doing to work with you and how we are making it as easy as possible for St. Leo to jump to the top of the Ministry funding list. So Brandi has shown that by the Ministry requirements we have checked off high FCI, the land share with the Archdiocese and over subscription. But... The Ministry has also made it very clear, under the direction of Karen Petrie (insert Karen's title) that priority will be given to Community Hubs and to partnerships that maximize resource dollars.

### SLIDE 16

Currently there is an entire city block that houses the crumbling St. Leo. The Mimico Adult Centre, with John English Public School directly across the street. It has been a long time vision of our Councillor Mark Grimes and his Mimico 20/20 plan to revitalize these buildings in a way that services all of our residents. Like you, I am a steward of the school while my children are there. This is about a long term inclusive vision that services everyone in the Mimico community. These are public lands and we are not only responsible to provide safe and healthy environments for our children to learn, we have a responsibility to those who pay for it to make these buildings accessible – regardless of which government agency owns them. Think of Holy Child Catholic School, Humberwood Public School and Toronto Public Library in North Etobicoke and the current Block 31development of the Railway Lands in Downtown Toronto.

### **SLIDE 17** In a time of cuts and deficits, this is the future!

Over the last two years, St. Leo and John English schools have had separate breakout sessions about how to best maximize resources and have been lobbying our respective Trustees. There is an enormous grass roots movement within the community that has had enough of the failing buildings at the centre of Mimico and want to see change. **SLIDE 18** Our Councillor responded to this outcry. On December 15<sup>th,</sup> under the guidance of Councillor Grimes, St. Leo Catholic School, John English Public School, planning from the TDSB and the TCDSB, Parks and Rec, Moss Architects, Humber College, our respective Trustees Ann Andrachuk and Pam Gough and the City of Toronto came to one table to make this a reality.

**SLIDE 19** Over the last three years St. Leo has worked vigorously to cement our relationships with those in our community. Through our sponsorship fundraising program, our hugely successful Spring Fling is on June 9<sup>th</sup>; (if any of you would like to come).

**SLIDE 20** On our social media and parent council website we have a community of businesses, residents and public agencies who are supportive of building of a new school. One of the connections that we are most proud of is our partnership with Humber College.

**SLIDE 21** Two years ago, Humber came onboard to help design something that would give our children something to play with at recess as part of their Design, Situate and Build course. Through this same connection, they set up a "design trailer" at our last Spring Fling to get ideas from the community and residents about what this city block should look like; a vision for the future of St. Leo Catholic school!

I'll share with you now one of the three concepts that the renown MOS architects put forth at that December 15<sup>th</sup> meeting – so you have a visual and so that you can see that the possibilities are exactly that – POSSIBLE!

*SLIDE 22*– This is the new St. Leo School now up on Royal York where the Parish House used to be with a gymnasium that doubles as a Parish Hall, underground parking to maximize green space and a new community hub that services both John English Public and St. Leo Catholic schools and the entire Mimico community.

Pretty amazing right! The Community Hub is another box to tick off in a slam dunk business case for Ministry funding and I highlight it to show you that we as a community and as a group of unified taxpayers are resourceful and willing to work with you so that we can all achieve something that is forward thinking.

(But)... Let's be clear that the first and most crucial step is a new school for St. Leo.

**SLIDE 23** Think again to what Brandi showed you - about the state of our current school and whether you yourselves would want your children or grandchildren to spend their day in a building like this.

We will do whatever we can to help, to raise additional funds and to galvanize an already passionate community.

**SLIDE 24** We thank you and the SARC again for this recommendation. Ecclesiastes 3:1-5

### Cover Letter

Dear St. Leo Committee,

Thank you for the opportunity to present an overview of ideas for the revitalization of the St. Leo block as part of the Community Hub master plan project. We're delighted that Marcin Kedzior has invited us to meet. After preliminary research and review of the documents sent to us, we have developed three options to consider as design strategies for the site. There is a strong potential to develop the site by building upon the programs already housed in the St. Leo Catholic Church, the Mimico Adult Centre, St. Leo Catholic School, and John English Junior Middle School. We imagine opportunities to strengthen those programs by increasing site density and introducing additional space for gardening, socializing, and living.

Our previous built projects have focused on creating spaces which support social interaction through a concept of radical inclusion. Our buildings are accessible and interconnected, extensions of the communities they serve. We carefully consider the transitions between interior and exterior space. Interiors are flexible and open while exterior spaces can be covered to create porches, gardens and terraces accessible year round. Here, we are including examples of such work: an arts school in Denmark, an orphanage and library in Nepal, a housing and arts building in Seattle, and a community center in Hawaii.

We look forward to learning more about the St. Leo community in the future. Each of our projects is developed through extensive research, large scale models, and architectural drawings. We are happy to set up a conference call or a visit in person to discuss our ideas further and share our working process with you.

### **Architectural Fact Sheet**

### Setting

The St. Leo block is located in the neighbourhood of Mimico, a community approximately 30 minutes travel distance on the GO train from downtown Toronto. The site is just south of the Gardiner Expressway, north of Lake Ontario and in close proximity to Humber College's Lakeshore Campus.

### **Project Description**

The revitalization of the block containing the St. Leo Roman Catholic Church, St. Leo Catholic Elementary School and the Mimico Adult Centre will involve the addition of multiple programs serving to strengthen the community. As an institution and home, the St. Leo block currently breathes life into the Mimico community, both emotionally and spiritually. The site houses autonomous buildings and open spaces, with a perimeter of fencing offering few points of entry.

This project presents an opportunity to rethink the neighbourhood block. The proposed schemes respond uniquely to their four sides, opening up the block by creating connections across the site and linking diverse programs and open spaces. Responding to the low-rise scale of the neighbourhood, the block is transformed to create a more inclusive dialogue with the surrounding community. This creates opportunity to both share resources with the adjacent John English Junior Middle School and position the block as a meeting hub within a larger network of community organizations. Existing green spaces for exercise and sport are supplemented by courtyards with botanic, ecological and working gardens supporting a local farmers market. The entire site is

integrated with nature, offering a cleaner and healthier place to live, learn, work and play. The ground floors provide areas for sitting, leisure and conversation.

As the master plan strategy is developed further, it will include new thinking about environmental efficiencies in terms of water, energy and natural elements. Passive systems will be explored in combination with supplemental energy to develop efficient heating and cooling strategies. For example, spaces designated for circulation may be more temperate, reserving heating and cooling for only the most essential spaces. This project also presents opportunities to research durable materials that could resonate with landscape elements to enrich the design.

The next steps of this project will be to undertake zoning analysis, develop a preliminary program and generate rendered viewpoints.





### Master Plan Preliminary Study

At this time, we are presenting three preliminary schemes, all of which are open and accessible, and emphasize a relationship to outdoor activities and the surrounding landscape. In all cases, the proposed block opens up to the surrounding community. Multiple points of entry allow for access from surrounding streets as well as through existing buildings. Underground parking is included to liberate the landscape.

Here, the St. Leo block is reimagined as a cloister with two main courtyards. The courtyards house athletic activities, playgrounds as well as botanic, ecological and community gardens. The buildings appear in parts, connected by covered walkways. The courtyards are accessed easily across a porous site edge. This scheme retains the existing St. eo schoolhouse and elementary school as well as the Mimico Adult Centre. New additions include a gymnasium and outdoor athletic facilities with accessible green roofs. Located in close proximity to Royal York Road, the gymnasium is equally accessible to the elementary school and the church, an ideal location for a flexible event space. The Mimico Adult Centre is supplemented by a new wing, hosting additional community workshop spaces, makers space, and galleries. At the south edge of the site, there are two buildings: one containing a business hub, co-working space and library and the other a communal kitchen, dining hall, event space, and farmers market. A covered walkway connects these buildings to the west edge of the site, designated for housing.

### Scheme 2 No Frills St. Leo Community Hub MOS Master Plan Project

### Master Plan Preliminary Study

In this second scheme, the east side of the block is reimagined as a shared park space. A connection between the St. Leo and John English schools is established through the inclusion of a full-size track. This track can support local track and field meets as well as dry-land training, rugby, soccer and football. Botanic, ecological and community gardens are located around the perimeter directly adjacent to the buildings. The St. Leo Elementary School is relocated into a new building facing Royal York Road. An independent building designated as a Parish Hall, housing a gymnasium and event space, is added in close proximity to both the school and the church. The Mimico Adult Centre program is moved to a new building along Royal York Road, creating a continuous street presence and revealing the diverse activities supported by the Centre.

### Master Plan Preliminary Study

Our third scheme proposes to elevate the full-size running track onto the roof of four interconnected buildings. A vertical organizational strategy is used, with the parking underground, freeing up the landscape as a shared space for sports, recreation, and gardening. The new St. Leo Elementary School, Mimico Adult Center, and housing share a large central courtyard. Additional green space is added around the perimeter of the block. Covered walkways throughout maintain continuity in the landscape. The courtyard is easily accessed from the surrounding streets and through the buildings. The building masses maximize exposure to natural light. Their roofs introduce potential for landscape elements and seating areas offering up views of Lake Ontario. The continuity of the interconnected roof plane combines the block's diverse communal programs into a cohesive whole.

### A. Introduction

Holy Angels Catholic School is at the heart of the Etobicoke community. Generations of families have attended this great school. Families specifically choose Holy Angels because of its unique character and family like environment. Its appeal is in its exceptional academic reputation, its size and the very personalized touch that this offers to our children's education. The Principal knows every child by name and students have a greater opportunity to participate in teams and clubs.

It is a vibrant school community that embraces Inquiry Based Learning, Bucket Filling, Me to We and other wonderful initiatives. Teachers love working at Holy Angels, as demonstrated by the very positive staff retention rates. Our EQAO scores are in the 90s. We are very proud of our school.

In light of this exceptional learning environment, we would be happy with status quo. We would love for this close knit community to stay as is and feel that the proposed changes will change Holy Angels at its core. However, our community understands that change is inevitable and we wish to work together with the school board in order to make transition as smooth and comfortable as possible for the school community.

### B. Current Challenges

The current school, which was already expanded with an addition many years ago, has an on the ground capacity of 372 students. The current enrollment is at 114% capacity and without any changes is projected to grow upwards to 126% by 2017. The building is unfortunately not structurally able to support a second story.

The overcrowding has limited programming opportunities at the school. In 2014, to accommodate full day kindergarten, we lost the library to create two new classrooms and a portable was added. In order to accommodate the PLASP before and after school program, we have had to multi-purpose rooms and PLASP is required to share a classroom. Due to the limited green space and current overcrowding, use of the field and playground is managed by a weekly rotation, limiting the time each child has to play on the grass. The use of the gym is also limited and most students have minimal access to gym time. The loss of the large library and tight gym schedule makes meeting in larger groups impossible. Any guest speakers or authors have to use the gym.

The 2015 ParticipACTION Report Card on Physical Activity for Children and Youth indicates that Canadian children are getting a D- in both physical activity and sedentary behaviour. The

proposed increase in enrollment without an appropriate facility and outdoor environment is concerning because:

- (1) "Children and youth spend a large proportion of their waking hours in non-parental environments such as schools". "These environments represent multiple opportunities to promote and facilitate physical activity (e.g., PE, recess, intramural sport, varsity sport). Indeed, there is evidence that more physical activity offerings at school are associated with more active children and youth." (ParticipACTION, 2015)
- (2) Decreased participation in school sports has a negative effect on mental health. A ParticipACTION study showed that "Grades 7-12 students who reported participation in school sports throughout their secondary school years were more likely to report lower levels of depression symptoms and perceived stress, and were more likely to report higher levels of self-rated mental health when followed up at approximately 20 years of age." (ParticipACTION, 2015)
- (3) "Ontario preschoolers spend twice as much time being active when play is outdoors (53% of time active outdoors versus 23% of time active indoors)."

  "Children who engage in active outdoor play in natural environments demonstrate resilience, self-regulation and develop skills for dealing with stress later in life." "Outdoor play that occurs in minimally structured, free and accessible environments facilitates socialization with peers, the community and the environment, reduces feelings of isolation, builds inter-personal skills and facilitates healthy development."

  (ParticipACTION, 2015)

Holy Angels is surrounded by new developments. A large-scale development is under construction to the north at Norseman Street and Islington Avenue. There are several condos being built south of the school on The Queensway. Overcrowding is already a serious concern for our school community. The current facility cannot accommodate any additional students.

Holy Angels C.S. sits next to a large industrial section of the city, which not only has very limited green space but also has created a serious safety concern with regards to traffic in and around the school. In addition to bus traffic, church traffic and parents dropping off and picking up children, Jutland Road is a major throughway for heavy trucks. The police and city are aware of these issues. Any further increase in enrollment on the current site would add further stress to this precarious situation.

C. Impact of Director's Report Recommendations

The Director's report is recommending a boundary change resulting in a drastic increase in the enrollment at Holy Angels C.S. In three years (2019), the capacity would be at 160% and in eight years (2024), it would be at 182%.

The proposed boundary change would redirect 20 existing high-rise buildings northwest of Islington and Bloor to our school. It would also include the planned high rises on the Islington Subway station lands and the Westwood Theatre developments. This would be in addition to the development already happening in the area.

If St. Louis closes, Holy Angels would also absorb students from that school. This will likely result in the student's home being situated further from the school inhibiting the student's ability to use active modes of transportation (ie: walking, cycling) to travel to school. Active modes of transportation not only have significant benefits to physical health, but also on mental health. The Public Health Agency of Canada (PHAC) strongly promotes the use of active transportation and "walking" school busses. The proposed boundaries should not pose an obstacle in allowing children to follow PHAC guidelines encouraging children to walk to school. Using active transportation for all distances less than 1 km are generally recommended.

The boundary changes proposed in the Director's report predicts that enrollment at Holy Angels to be 182% by 2024. This level of overcapacity would cause a crisis at our school under the current conditions. It would move the overcrowding crisis from Our Lady of Sorrows to our school. If the boundary changes, we need a new school. The TCDSB purchased the Kerr Candy Factory next to the school. If a boundary change is made, it is imperative that the overcrowding problem is not just moved from one school to another. Moving students who are currently in portables at Our Lady of Sorrows to portables at Holy Angels is not a solution.

### D. Moving Forward

Our school community is not supportive of moving a crisis from one school to another. Our Lady of Sorrows has a new state of the art facility, which has been able to house its overpopulation and can continue to do so until Holy Angels can accommodate more students.

The Holy Angels community will only support your plan under the following conditions:

- The TCDSB presents a business case to the Ministry of Education which prioritizes a new school for Holy Angels.
- The proposed effective date of September 2017 for the boundary changes as indicated in Appendix D is reconsidered. The current facility at Holy Angels cannot accommodate students from St. Louis and Our Lady of Sorrows. There is inadequate space to accommodate additional portables as the limited green space has already been compromised.

- The TCDSB does not implement a boundary change until there is funding approval for a new school at Holy Angels and the Kerr Candy Factory lease has been terminated allowing for immediate construction minimizing delays and impacts on our community.
- The allowed capacity at a new Holy Angels school does not exceed 600 students.
- The TCDSB creates a transition committee that includes parent and community representation.
- Assessments are completed that deems the land on the Kerr Candy Factory to be suitable to build and play on prior to any boundary changes.

To summarize our position:

- Holy Angels is currently overcrowded.
- Traffic and limited green space are already safety issues.
- Additional students would compound the problem.
- No boundary change should be implemented until a new school is in place to house the increased number of students.

The Holy Angels community acknowledges that changes are coming and want to work together with the school board to make Holy Angels a 21st Century school and community hub. The purchase of the Kerr Candy Factory land has doubled our potential footprint. The potential for an enhanced green space that can promote both physical and mental well being to stimulate academic excellence in an industrial area is exciting. Surely the city and other community partners will be excited to partner with the TCDSB to make it a shared green space.

### To Whom It May Concern:

I feel very fortunate to be part of the Holy Angels School community.

Over the course of the seven years my children have been attending it has grown from a small community to a medium sized one and I still believe that primary and junior education at the school has been exceptional.

There is a lot of speculation as to what might happen to our tight knit group once the new boundary changes take place. As an involved parent who contributes voluntarily to the daily workings of the school I fear for over crowding, portables, and run down and under-maintained facilities that indirectly affect the learning and mental health of our growing children.

Two years ago we specifically purchased a home to be within walking distance of Holy Angels School. My heart goes out to all the families affected by the boundary change including families from OLS and St Louis – nobody likes change, especially when there's no clear benefit to them. But times are changing, the demographics of our area are changing and it's safe to say that our little community is going to bust at the seams if we don't keep up with modernity.

I have conflicting instincts regarding the "idea" of a new "mega-school". It angers me that my children will have to live through the construction, the unknowing, the "can't do this/that/the other", delays and hiccups due to inevitable budget restraints. Especially since I purchased a home specifically for my children to learn in the peace and calm of a smaller school. However, the prospect of my family being able to benefit from a mega school after they have long left the premises reduces the sting if even just a little.

I support the mega-school and keeping up with the times. I think it would be fantastic to include a technology lab, triple gym so all students can have physical education each day without teachers having to beg, borrow and steal gym time for each other, a beautiful public library, and public indoor pool on the grounds for everyone – including the seniors in the area who sent their children to Holy Angels decades ago – to benefit from.

But in the meantime I strongly and vehemently hope that St Louis remains open and that it'll be used to bus all overflow of students there instead of raising portables on the current school property. Our schoolyard is small enough as it is and with the growing knowledge of children needing physical activity we are doing them no favours by cutting out their room to run. Reduced outdoor activity reduces the ability to learn. It's proven fact and it would be very sad to see The Board support this problem by taking away our – very limited – play space.

It's unclear how long this project might take. My youngest daughter is currently in JK and it's likely she will not be a student at the new mega school by the time it's up and running. But wouldn't it be cool to at least have a place where she might be able to return to, like a library, a conference room or public pool and say "the hassle was worth it in the end".







### A. Introduction

Holy Angels Catholic School is at the heart of the Etobicoke community. Generations of families have attended this great school. Families specifically choose Holy Angels because of its unique character and family like environment. Its appeal is in its exceptional academic reputation, its size and the very personalized touch that this offers to our children's education. The Principal knows every child by name and students have a greater opportunity to participate in teams and clubs.

It is a vibrant school community that embraces Inquiry Based Learning, Bucket Filling, Me to We and other wonderful initiatives. Teachers love working at Holy Angels, as demonstrated by the very positive staff retention rates. Our EQAO scores are in the 90s. We are very proud of our school.

In light of this exceptional learning environment, we would be happy with status quo. We would love for this close knit community to stay as is and feel that the proposed changes will change Holy Angels at its core. However, our community understands that change is inevitable and we wish to work together with the school board in order to make transition as smooth and comfortable as possible for the school community.

### **B. Current Challenges**

The current school, which was already expanded with an addition many years ago, has an on the ground capacity of 372 students. The current enrollment is at 114% capacity and without any changes is projected to grow upwards to 126% by 2017. The building is unfortunately not structurally able to support a second story.

The overcrowding has limited programming opportunities at the school. In 2014, to accommodate full day kindergarten, we lost the library to create two new classrooms and a portable was added. In order to accommodate the PLASP before and after school program, we have had to multi-purpose rooms and PLASP is required to share a classroom. Due to the limited green space and current overcrowding, use of the field and playground is managed by a weekly rotation, limiting the time each child has to play on the grass. The use of the gym is also limited and most students have minimal access to gym time. The loss of the large library and tight gym schedule makes meeting in larger groups impossible. Any guest speakers or authors have to use the gym.

The 2015 ParticipACTION Report Card on Physical Activity for Children and Youth indicates that Canadian children are getting a D- in both physical activity and sedentary behaviour. The

proposed increase in enrollment without an appropriate facility and outdoor environment is concerning because:

- (1) "Children and youth spend a large proportion of their waking hours in non-parental environments such as schools". "These environments represent multiple opportunities to promote and facilitate physical activity (e.g., PE, recess, intramural sport, varsity sport). Indeed, there is evidence that more physical activity offerings at school are associated with more active children and youth." (ParticipACTION, 2015)
- (2) Decreased participation in school sports has a negative effect on mental health. A ParticipACTION study showed that "Grades 7-12 students who reported participation in school sports throughout their secondary school years were more likely to report lower levels of depression symptoms and perceived stress, and were more likely to report higher levels of self-rated mental health when followed up at approximately 20 years of age." (ParticipACTION, 2015)
- (3) "Ontario preschoolers spend twice as much time being active when play is outdoors (53% of time active outdoors versus 23% of time active indoors)." "Children who engage in active outdoor play in natural environments demonstrate resilience, self-regulation and develop skills for dealing with stress later in life." "Outdoor play that occurs in minimally structured, free and accessible environments facilitates socialization with peers, the community and the environment, reduces feelings of isolation, builds inter-personal skills and facilitates healthy development." (ParticipACTION, 2015)

Holy Angels is surrounded by new developments. A large-scale development is under construction to the north at Norseman Street and Islington Avenue. There are several condos being built south of the school on The Queensway. Overcrowding is already a serious concern for our school community. The current facility cannot accommodate any additional students.

Holy Angels C.S. sits next to a large industrial section of the city, which not only has very limited green space but also has created a serious safety concern with regards to traffic in and around the school. In addition to bus traffic, church traffic and parents dropping off and picking up children, Jutland Road is a major throughway for heavy trucks. The police and city are aware of these issues. Any further increase in enrollment on the current site would add further stress to this precarious situation.

C. Impact of Director's Report Recommendations

The Director's report is recommending a boundary change resulting in a drastic increase in the enrollment at Holy Angels C.S. In three years (2019), the capacity would be at 160% and in eight years (2024), it would be at 182%.

The proposed boundary change would redirect 20 existing high-rise buildings northwest of Islington and Bloor to our school. It would also include the planned high rises on the Islington Subway station lands and the Westwood Theatre developments. This would be in addition to the development already happening in the area.

If St. Louis closes, Holy Angels would also absorb students from that school. This will likely result in the student's home being situated further from the school inhibiting the student's ability to use active modes of transportation (ie: walking, cycling) to travel to school. Active modes of transportation not only have significant benefits to physical health, but also on mental health. The Public Health Agency of Canada (PHAC) strongly promotes the use of active transportation and "walking" school busses. The proposed boundaries should not pose an obstacle in allowing children to follow PHAC guidelines encouraging children to walk to school. Using active transportation for all distances less than 1 km are generally recommended.

The boundary changes proposed in the Director's report predicts that enrollment at Holy Angels to be 182% by 2024. This level of overcapacity would cause a crisis at our school under the current conditions. It would move the overcrowding crisis from Our Lady of Sorrows to our school. If the boundary changes, we need a new school. The TCDSB purchased the Kerr Candy Factory next to the school. If a boundary change is made, it is imperative that the overcrowding problem is not just moved from one school to another. Moving students who are currently in portables at Our Lady of Sorrows to portables at Holy Angels is not a solution.

### D. Moving Forward

Our school community is not supportive of moving a crisis from one school to another. Our Lady of Sorrows has a new state of the art facility, which has been able to house its overpopulation and can continue to do so until Holy Angels can accommodate more students.

The Holy Angels community will only support your plan under the following conditions:

- The TCDSB presents a business case to the Ministry of Education which prioritizes a new school for Holy Angels.
- The proposed effective date of September 2017 for the boundary changes as indicated in Appendix D is reconsidered. The current facility at Holy Angels cannot accommodate students from St. Louis and Our Lady of Sorrows. There is inadequate space to accommodate additional portables as the limited green space has already been compromised.

- The TCDSB does not implement a boundary change until there is funding approval for a new school at Holy Angels and the Kerr Candy Factory lease has been terminated allowing for immediate construction minimizing delays and impacts on our community.
- The allowed capacity at a new Holy Angels school does not exceed 600 students.
- The TCDSB creates a transition committee that includes parent and community representation.
- Assessments are completed that deems the land on the Kerr Candy Factory to be suitable to build and play on prior to any boundary changes.

To summarize our position:

- Holy Angels is currently overcrowded.
- Traffic and limited green space are already safety issues
- Additional students would compound the problem.
- No boundary change should be implemented until a new school is in place to house the increased number of students.

The Holy Angels community acknowledges that changes are coming and want to work together with the school board to make Holy Angels a 21st Century school and community hub. The purchase of the Kerr Candy Factory land has doubled our potential footprint. The potential for an enhanced green space that can promote both physical and mental well being to stimulate academic excellence in an industrial area is exciting. Surely the city and other community partners will be excited to partner with the TCDSB to make it a shared green space.

Dear Mrs. Fernandes,

Due to emerging issues at work I will be unable to attend the public meeting tomorrow. Therefore I am providing a written delegation which I would request to be presented and recorded into the file.

I am a parent of a child at Our Lady of Sorrows and have been following the SARC process for from the beginning of OLS's involvement. A lot of hard work was put in by all the members of the SARC. They put in a lot of late nights, made a lot of difficult decisions while under a lot of scrutiny, but in the end, I feel they made a solid set of recommendations.

I was therefore disappointed to read the staff report and discover how few of them made it through. While the recommendation to close St. Louis is the biggest one, I will leave it to the parents in that community to speak to that decision, and instead focus on the issues of concern to my family and my community.

First, I was disappointed to see that the change in the OLS admission boundary proposed in the SARC was weakened with no explanation. Scenario 3 was considered by the SARC and rejected, so why was it brought back? It leaves OLS tremendously oversubscribed for the foreseeable future, and the report makes no mention as to how this is to be resolved.

Second, the request for a change to the admissions policy - especially for extremely oversubscribed schools - was rejected, pointing to decision made by the board recently at their October 22 meeting. That vote (to leave the admissions policy untouched for two years) was made prematurely with the full knowledge that this SARC intended to request a change. I would request that the board reconsider this decision, as this is the only way that OLS can address its over-subscription in the short term. I feel that amendments specifically covering oversubscribed schools can be written, approved, and implemented quickly if focus is maintained.

Finally, OLS was only included in this SARC group to address the request for a boundary review. However, since OLS is the northernmost school in the grouping, any boundary change could only affect our southern border. Since the school is already near the southern end of its catchment, options for further cutting from the south are limited and undesirable as it will cut off a large portion of the OLS church parish from the associated OLS school, and divide the community. Therefore, I would request that the report be amended to either (1) recommend that OLS be included in any future SARC involving schools to the north and or west of OLS, specifically St. Gregory, or (2) a boundary review be scheduled, specifically for OLS, independent of the SARC process.

### Dear Madame Chair and fellow Trustees

Good Evening. My name is Noreen Reid, and I appreciate the opportunity to speak with you today. I am here to represent a group of concerned parents at Our Lady of Sorrows. We do not represent CSPC, however, we wish to express our collective concern with the Staff's recommended boundary change (Scenario 3).

The Staff's proposed boundary will do very little to address the enrolment pressures for Our Lady of Sorrows. Based on Staff's projections, our school will still be at 130% by 2020, while the SAR Committee's recommended scenario had us at 119% by 2020. Our Lady of Sorrows has been before this Board and Staff several times engaging in discussions about our capacity issues. In a parental survey conducted last year, capacity and safety was a concern for 69% of the respondents. It has been an extremely contentious issue for our community, understanding that there would be strong opposition from the parent groups that are directly affected by the SAR Committee's recommended boundary change (Scenario 9). However, our school was very methodical about garnering community support for the recommendations, ultimately culminating in a vote of 9-1 by our CSPC Elective Council to support the SARC recommendations.

If our capacity is not reduced, we will continue to be faced with the existing problems of being overcrowded, mainly:

- Ability for new children within our catchment to attend our school due to lack of available spots in FDK. Registration was January 13 and within minutes, all FDK spots were full (4 classrooms/30 students in each class). And, as of Monday at noon, we are redirecting 32 families.
- Last year, 66 families (priority 2) were redirected and 22% of those families opted to register with another Board
- We are on the cusp of violating building code (fixture to student ratio) which is 792 for our school. We are at 786 students today.
- There are safety issues surrounding the school due to high volumes of traffic
- Safety issues in the playground due to overcrowding
- Bathrooms are over used and in poor conditions throughout the day
- Over capacity has negatively affected our fundraising efforts despite our population growing our fundraising dollars are lower
- O The increased number of portables due to classroom shortage impedes the line of site between the playground and the field
- Redirecting children within the TCDSB with limited bussing is a problem for working parents
- The admissions policy is ineffective at helping us to service the growing number of families within the catchment and to control the influx of students from grades 1 to 8

In order to right-size OLS, the admissions policy would need to allow the school administration to manage the admittance of new students in grades 1 through 8. We understand the Board's constraints relative to funding and balancing the needs of our neighbouring schools. And, on this note, we are disappointed that the Staff recommends closing St. Louis as they could be the solution to mitigating overcrowding at OLS and Holy Angels. In a recent memo from Sharon McMillan, dated January 13, she references that "closing several hundreds of schools across Ontario would be the only way to save money through amalgamation and if schools were amalgamated and hundreds of schools closed, all Ontario students (across all systems) would be displaced. There is no indication that public school supporters would be prepared to move their children from the local public school in order to accommodate children living closer to a Catholic school or vice versa." Yet, none of these principles are being applied in our community.

Through you the Chair, we have the opportunity to achieve balanced enrollment at OLS given that the other schools in the SARC are projected to be well within capacity by 2020

- Holy Angels 95%
- o St. Mark 114%
- o St. Leo 103%

Based on the same projections, Holy Angels will be under-subscribed and will have the capacity to move more families from OLS.



### Dear Madame Chair and fellow Trustees,

My name is Idalia Furtado-DeFaria and I am here today to represent a group of parents who are concerned with the capacity issues at Our Lady of Sorrows. To be clear, I am not speaking on behalf of CSPC or any other school committees. However, we feel that you deserve to have a balanced view from our respective communities.

As you know, for over two years, the OLS community has been involved in the protracted process to have the school's boundaries adjusted to ease its current enrolment pressures and mitigate against further impairment of our over-crowding problem.

This has been a highly contentious and emotional process for our school. Through the SARC process, OLS has performed a rigorous, challenging examination of its over-enrolment all with a view to obtaining a reasonable, meaningful solution at the end – and the end is now.

### During this time, OLS has:

- (1) held open and transparent meetings to discuss potential solutions to our overenrollment problem;
- (2) published/disseminated minutes and all relevant documentation regarding this process;
- (3) encouraged participation and welcomed all community members to attend and engage in the meetings and be part of the solution process;
- (4) listened to, considered and debated all solutions in our aim to achieve a reasonable solution to OLS's over-enrolment problem.

After investing 100s of hours of intense meeting time, using the Board's resources to provide over 12 scenarios, which were analyzed in great depth and weighing the rights of many different groups affected, OLS came up with a sensible set of Recommendations. Part of those Recommendations include a Boundary Change as set out in Scenario 9 which gets OLS closer to an ideal utilization rate of 119% in 2020 and ultimately 105% in 2023. Scenario 3 or Appendix D, which was recommended by the Board staff doesn't even get us close to that or do enough to meaningfully address our problem.

The rationale behind Scenario 9, which received an overwhelming majority of support from our elected Parent Counsel in a 9 to 1 vote in favour, was to: (1) solve our overcapacity issue; and (2) cut once, cut deep and then rebuild. This has been a divisive time and process for our community which must end now.

We acknowledge the opposition voiced by those directly impacted and have not ignored those who feel left out by a Boundary change but rather, OLS has aimed to provide those affected with some safeguards by including in OLS's set of Recommendations

My son attends Our Lady of Sorrows School and we live in the area south of Bloor Street and bounded by Mimico Creek and Islington Avenue.

I am writing to you as unfortunately I am unable to attend tonight's meeting. This letter speaks for a large part of my area of the OLS community.

The Board's decision to put forward scenario 3 is welcome news to us. We trust that you and the Board's team noted our concerns and the parents in our area, given that we are less than 1 km from the school and walkability and maintaining a significant part of Our Lady of Sorrows community were critical determining factors in your decision. There are a significant number of parents and community members in our area that were upset with the SARC and school's direction.

Over this past year we have watched the SARC process and provided our input on a number of occasions. The SARC process has caused a rift in our community and has been an emotional roller-coaster ride for all in my part of the community.

We recognize that a great deal of thought and work has gone into the SARC process. Whilst there were a number of scenarios put forward, OLS committee finally put forward 3b or scenario 9. We were against this scenario for a number of reasons:

- 1. Walkability: We were given to understand that walkability was the main guiding principle. However, this was not taken into account when they proposed 3b. I live less than 1 km to the school. Most parents in the OLS school boundary live significantly further north or east, and their kids have to be bussed or driven to the school. My son walks to school daily except on very cold days. Sunnylea area (south of Bloor between Royal York and Prince Edward is further away from the school...yet this area was included as there were parents that were on the SARC and Capacity committee, and unfortunately we believe they did not act in the best interests of all in the OLS community. They didn't want their community to be directed to St Marks school which in fact is under-capacity!
- 2. <u>Inclusivity and diversity</u>: By choosing 3b or scenario 9, the SARC and Capacity committee would create an EXCLUSIVE and "PRIVATE" school by reducing the utilization numbers for OLS. The school has been over capacity for many years and has functioned perfectly well producing fine students from all of its community, not just the more affluent families.

We also understand that there are parents from OLS school that are angry with the staff recommendation of scenario 3. Even though the school's SARC committee recommended to accept Scenario 3 they are doing everything in their power (including meeting privately with Angela Gauthier) to change your decision back to 3b. Whilst their voice was being heard (prior to the scheduled board meeting today) in no way do they represent the school's entire community.

Whilst we are happy with the staff recommendation of Scenario 3, we also feel that the <u>Admission Policy</u> should be revised so that oversubscribed schools could redirect any families that subsequently move outside of the catchment to their new home school. This is not new and has been suggested on many occasions. The Board agreed that change was needed during the All Saints boundary review. Rather than leave this in the hands of the school administration, as suggested by the SARC, we strongly urge that board clearly define and limit accessibility for out of catchment students.

I thank you for listening to my concerns and the parents in my community, and feel that Scenario 3 is the best possible solution and that the majority of us are in agreement.

### The question of comparability and environment between Our Lady of Sorrows and Holy Angels. Air Pollution Considerations

The OLS Capacity Committee suggest that Holy Angels provides a comparable Alternative to OLS for those families who will be excluded from a school less than a kilometre from where they live. By accepting the OLS capacity Committee proposal for Scenario 3b (now 9) the Board must also believe this to be true.

The term comparable has not been defined in any meeting minutes or documents on the Board's website. Clearly in its current state, Holy Angels is nowhere near comparable to Our Lady of Sorrows School. Holy Angels is smaller and overcapacity with not enough class rooms and zero portables.

The Capacity Committee, School and Board fail to recognize the stark differences between the OLS and Holy Angels locations.

Whilst the Board is committed to building a new school at Holy Angels, the actual start date and the date when students will have access to this school has not been provided. One can predict a minimum five years from now and that means housing students in portables before it is built. The likely location of those portables is on the site of the recently demolished home; again this is very close to Islington Avenue

Simply based on the information above, it appears incredulous that the Board and Capacity Committee would deem it acceptable to move any children from OLS via a boundary change or any other school to Holy Angels before they have built the new school.

### **AIR POLLUTION ISSUES**

A worrying fact is that there is no publicly available School Board documentation showing that it has considered the environmental issue of locating a new large school on this site.

In doing so, the board and the representative SARC committees have failed to recognize the health impact on children who attend schools close to major roads and industrial areas.

Holy Angels and its playground are less than 5 m from Islington Avenue. As pointed out in the table above this is a major north south thoroughfare for commuters to and from the QEW that is under a kilometre away. Traffic on Islington Avenue is not light by any means and all of us who live in this neighbourhood can attest to the dramatic increase of vehicles throughout the day, but especially during rush hour. The development of Etobicoke Center is expected to bring in up to 70,000 new residents into the area and it is logical to expect a significant increase in air pollution and especially around Holy Angels.

The traffic lights at the intersection of Jutland Road and Islington Avenue as well as the close proximity of the 7/11 gas station creates an increased wait time of cars adjacent to the school and many vehicles use Jutland as an alternative route to Kipling Avenue. There is a hidden toll of traffic jams and there is increased risk to air pollutants in the vicinity of traffic lights. There are a significant number of recent studies showing the detrimental affects of long term exposure to toxic vehicle emissions and that the air within a few hundred meters of large streets are polluted with harmful particulates from and stirred up by

### **Fine Particulate Matter**

The World Health Organization have stated that small particulate pollution has health impacts even at very low concentrations – **indeed no threshold has been identified below which no damage to health is observed.** Therefore, the WHO 2005 guideline limits aimed to achieve the lowest concentrations of PM possible. http://www.who.int/mediacentre/factsheets/fs313/en/

### What are the effects of fine particulate matter?


The greatest effect on health is from particles 2.5 microns or less in diameter. Exposure to fine particulate matter has been associated with hospital admissions and several

serious health effects, including premature death. People with asthma, cardiovascular or lung disease, as well as children and elderly people, are considered to be the most sensitive to the effects of fine particulate matter. Adverse health effects have been associated with exposure to  $PM_{2.5}$  over both short periods (such as a day) and longer periods (a year or more).



The figure below shows the results of a study carried out by the University of Toronto in 2008. Note that Holy Angels lies on the eastern edge of a major zone of fine particulate pollution.

An important thing to note is that air pollution does not reduce in the winter, in fact during the winter months, vehicle emissions can be trapped near the ground by temperature inversions. This can lead to high levels of primary pollutants including nitrogen dioxide (NO<sub>2</sub>), carbon monoxide (CO) and particulate matter (PM<sub>2.5</sub>).



"The Toronto data isn't yet available to the public, but <u>it could have some</u> <u>interesting applications for public officials looking to locate new schools</u>, sports fields or retirement homes, or for individuals who want to plan their jogging route or decide where to move." It appears the catholic School Board does not agree with this.

There are a number of recent studies showing the impact of traffic pollution on cognitive ability

With regards to proximity of the 7/11 gas station to Holy Angels, a recent Spanish study proposes that they be a minimum of 100 m from schools.



There are many more studies and examples that can be found.

The Capacity Committee and the School Board would have our area's children walk significantly further than the less than 1 km they now walk to OLS. That walk will take them along a major traffic route and expose them to significantly higher levels of air pollution. They will suggest that those children can be bussed or driven by parents but that will only increase the traffic and detrimentally impact air quality around Holy Angels.

### **Additional Pollution Concerns**


A significant portion of Holy Angels catchment area includes the industrial area to its west. Whilst the Holy Angels Capacity Committee said that they were aware of this issue, it has not been made public to the other schools and affected parents. The TRAC Reports for emissions around Holy Angels School (Provide by the Toronto Environmental Alliance). Clearly this is another important fact to be considered.

### ADDITIONAL INFORMATION

"In Canada, approximately 36% of urban public elementary schools are located within 200 m of a major road (Amram et al., 2011). This is of concern, given that traffic-related air pollutants are elevated within approximately 100 – 500 m of major roadways (Zhou and Levy, 2007) and elevated concentrations of traffic-related pollutants have been found in schools located near highways or major roads (Janssen et al., 2001; Patel et al., 2009). Chronic exposure to traffic-related pollution has been linked with several adverse health outcomes in children. These include increased respiratory symptoms, asthma exacerbations, and adverse effects on lung and cognitive development (Brauer et al., 2002; Dales et al., 2008; Gauderman et al., 2002, 2004; Janssen et al., 2003; Kim et al., 2004; McConnell et al., 2010; Sunyer et al., 2015; Venn et al., 2001). Given that children spend approximately 6 h a day at school, for a minimum of 194 days a year (Ontario Ministry of Education, 1990), pollutants in this environment are an important consideration for children's health. In their recent review, Choo et al. (2014) identified that most of the indoor air pollutants in schools can be attributed to vehicle emissions and industrial sources."

### **British Columbia**

A study carried out in BC in 2011 recommended:

- 1. To minimize the exposure of building occupants to traffic-related air pollution associated with proximity to major roads, recommendations include:
  - 1. **Setbacks:** 150 metre (500 feet) setbacks from "busy roads<sup>1</sup>" especially for buildings such as day care facilities and schools.

Motor vehicles emit at least 40 different air pollutants, usually concentrated within 100-500 metres of freeways and busy roadways, and research points to a need for increased awareness of the public health concerns associated with roadway proximity in creating land-use policy, building design and environmental/air quality management programs.

### **New Zealand**

Outside of North America, the Regional Public Health Service in Auckland, New Zealand, provides analogous guidelines for the siting of early childcare centres. The recommendation is that such centres, which cater to children age 4 and under, are not to be located either within 60 m of district or regional arterial roads, within 150 m of roadways, within enclosed parking facilities, within 300 m of industrial zones, or

within 100 m of petrol stations (ARPHS, 2009a). They advise that these recommendations should be incorporated into local authority plans to ensure that developers of early childhood centres avoid hazardous locations. The "Health & Safety Guideline for Early Childhood Centres" (ARPHS, 2009b) is a published tool for early childhood centre operators whose centre is to undergo a health and safety assessment by the Auckland Regional Public Health Service. This guide summarizes the relevant health standards, including those regarding traffic exposure as outlined in the "Position Statement on Air Quality and Early Childhood" (currently pending clarification of Ministry of Health policy intentions), that early childcare centres must comply with in order to obtain an operating licence from the Ministry of Education. The surrounding environment in relation to air quality is scrutinized, including current location of major roads adjacent to the facility and future transport and development plans. Under these guidelines, a number of new early childcare centres in Auckland have either been refused licences or are operating on provisional basis pending the results of air monitoring by the Health Ministry, due to air quality concerns (Fisher and Shepheard, 2009).

These factors should have been considered paramount when looking to locate a new school on the site of Holy Angels.

### **Conclusions and Recommendations**

This study is no ways exhaustive, yet in a relatively short time I have managed to uncover a significant number of environmental issues that are currently affecting children at Holy Angels and will most certainly affect children who will attend the newly proposed school.

Holy Angels school, and for that matter St Louis, are in an area of Etobicoke known for high levels of air pollution.

Whilst there is a considerable amount of data and studies that show the harmful effects on the health of children in Canada and from elsewhere in the world. It appears that the Catholic School Board has not considered the implications of these and in particular Fine Particulate Pollution at Holy Angles.

I strongly suggest that the school board look very closely at the implications of this brief study and provide a public forum to notify parents of how they will ensure the health of students attending Holy Angels.

I contact the Board of Director who permitted me to attend the meeting. My goal was to ensure the Board was clear that the voice of 2 parents does not represent the voice of the OLS school community at large and that there are several reasonable opinions and suggestions being tabled at OLS.

Again speaks to what happens when an outside influence comes into a community a pits one section of a community against another.

#### **SLIDE 32-34**

Ms. Di Ruscio-Young discussed Walkability

While OLS has allows tried to make WALKABILITY a guiding principle it was within the context of Safe and Reasonable Walkable routes

Currently almost all families within the west and south quadrants are within 1.5-1.7 walkability.

Ms. Di Ruscio argued some families that can see the school has been redirected. This is misleading as for many although they may be able to see the school, their path between home and school is dissect by the Humber creek. If they were to cross the creek then yes they could reach the school in under 1.5km.

OLS community took the stance that walkability must include safe, accessible routes to and from school. And the creek, during winter, bad weather, at night (after team practice for example or early morning) does not represent a safe route to school. This coupled with support from Police Services and recent and ongoing public warnings of youth assaults, bullying, and aggressive behavior down by the creek solidified stance that the path to the school via the creek does not constitute safe, reasonable walkable route.

It would seem only fair THAT BEFORE:

You reconsider unfairly targeting the south again and sending them to St. Mark

Dear Mr. Yack,

I'm sending this letter as our official opposition to the Proposed 3b OLS Boundary Change. Both my husband (Christopher Liew) and I (Debbie Tong) are not in agreement with this proposal.

First, on behalf of the children, who have no voice in this and who will ultimately be affected by the final decision, I think they might have this to say:

Please keep me safe on my route to school.

Please let me walk to school since I'd rather watch the birds and squirrels, and play in the snow.

Please keep me healthy.

Please keep ME in mind when you're making your final decisions.

As a parent of kids of OLS for the past 10 years, I have watched OLS grow. And grow beautifully it did, that is until recently. Sadly and heart-wrenchingly, I have watched a parent community being torn apart, first by a North / South division and most recently by a East / West division. Understandably, things can never be static, and things must change to serve our communities better. However, I have many questions, all of which remain unanswered at this moment.

MOST IMPORTANTLY, are the decisions being made keeping the CHILDREN at heart? They are our future, our gift, our responsibility.

Other questions, I've listed below in no particular order, as short as I possibly can, since I know your time is valuable. In the end, I trust and pray that fairness will prevail and that the final decision will serve the children of ALL the school communities of Central Etobicoke well.

- 1) Why are children that live within walking distance to OLS being asked to go to Holy Angels, either via a bus or via a walk on an extremely busy artery, an artery that will only become busier as Etobicoke continues to grow?
- 2) Why are the school boundaries to the North of OLS closed, and why can't they be re-opened?
- 3) Why was the north boundaries of OLS changed without OLS consultation?
- 4) Why can't the school boundaries bordering St. Gregory's be moved?
- 5) Why can't St. Gregory's accommodate portables?
- 6) Why is scenario 3b information not on the TCDSB website as yet?
- 7) How do the numbers in the 3b scenario make any sense? I.e. With the planned growth in Etobicoke, how is it that the projections in 3b show the OLS school pupil count trending down.
- 8) Where will the children moving 'into catchment' go to school, if OLS is already full?
- 9) In the 3b scenario (an all other scenarios), do the projections take 'out of catchment' children currently attending the school into consideration?

- 10) Wouldn't OLS naturally right size itself without changing school boundaries, if stricter school admissions policies were enforced and adhered to?
- 11) Why are there children 'out of catchment' currently attending OLS?
- 12) How did scenario 3b suddenly become the recommendation, as it was clearly discounted in a SARC Committee Meeting on June 16<sup>th</sup>, 2015?
- 13) How can we say that the process has be transparent when 3b only became a viable option on June, 2015 when a parent by-passed the process and emailed the scenario directly.
- 14) How can we say that that process has been transparent when the first time the entire OLS parent community received the map associated with the 3b scenario was on September 30th, after it became the CPSC / SAR final recommendation for OLS? This communication also did not disclose the utilization chart for the other affected neighboring schools.
- 15) How does a smaller school actually benefit the children in terms of learning and achievement? I'd argue that a smaller class size would be more beneficial to both teachers and students.
- 16) If Holy Angels does not get funding to build a new school, how is the school going to handle being at 180% over capacity.
- 17) If Holy Angles can even get funding, is the school even prepared to handle the growth with its limited space until the new school is built MANY years in the future.
- 18) Is the site for the new school for Holy Angels safe for the health of the children?
- 19) If the go ahead is given for the new school, are there any health concerns to be taken into consideration for the children attending Holy Angels during the construction of the new school.
